Activities

Objects: (I) TO RELIEVE AND PREVENT SUFFERING CAUSED BY MENTAL OR PHYSICAL ILL HEALTH OR BY SOCIAL OR ECONOMIC CIRCUMSTANCES, ANY YOUNG PEOPLE BY ESTABLISHING A YOUTH CLUB TO PROVIDE COUNSELLING, INFORMATION, ADVICE AND ACTIVITIES ON NORTHLEACH, (II) TO PROMOTE FOR THE BENEFIT OF THE INHABITANTS OF NORTHLEACH AND THE SURROUNDING AREA THE PROVISION OF FACILITIES FOR RECREATION OR OTHER LEISURE TIME OCCUPATION OF INDIVIDUALS WHO HAVE NEED OF SUCH FACILITIES BY REASON OF THEIR YOUTH AGE, INFIRMITY OF DISABLEMENT, FINANCIAL HARDSHIP OR SOCIAL AND ECONOMIC CIRCUMSTANCES OR FOR THE PUBLIC AT LARGE IN THE INTERESTS OF SOCIAL WELFARE AND WITH THE OBJECT OF IMPROVING THE CONDITION OF LIFE OF THE SAID INHABITANTS, (III) FOR THE PUBLIC BENEFIT TO PROMOTE AND PROVIDE FOR THE EDUCATION (INCLUDING THE STUDY OF MUSIC OR OTHER ARTS AND SOCIAL AND PHYSICAL TRAINING) OF PEOPLE UNDER OF 25 YEARS IN NORTHLEACH AND THE SURROUNDING AREA IN SUCH WAYS AS THE CHARITY TRUSTEES THINK FIT.

Activities: The Youth Club is no longer operating - the building has been sold and the proceeds of the sale will be allocated to youth organisations in the vicinity as determined by our constitution. When all the proceeds have been awarded the charity will then be wound up.
