**Objects:** 1) FOR THE RESTORATION,PRESERVATION,REPAIR,MAINTENANCE,IMPROVEMENT, BEAUTIFICATION AND RECONSTRUCTION OF THE CHURCH GROUNDS AND BOUNDARIES OF ST GREGORY THE GREAT AND OF THE MONUMENTS,FITTINGS,FIXTURES,STAINED GLASS, FURNITURE,ORNAMENTS AND CHATTELS IN THE CHURCH AND OF THE CHURCHYARD. 2) FOR THE BENEFIT OF THE PEOPLE OF THE SAID COUNTY OF SHROPSHIRE AND THE SAID DIOCESE TO PRESERVE,REPAIR,MAINTAIN,IMPROVE,BEAUTIFY AND RECONSTRUCT THE CHURCH AS A BUILDING OF HISTORICAL IMPORTANCE OR ARCHITECTURAL VALUE IN THE EVENT OF THE CHURCH BEING DECLARED REDUNDANT BY A PASTORAL SCHEME MADE UNDER THE PASTORAL MEASURE 1983 (OR ANY STATUTORY MODIFICATION OR RE-ENACTMENT THEREOF) OR OTHERWISE CEASING TO BE USED REGULARY FOR THE PUBLIC WORSHIP AND THE MONUMENTS,FITTINGS,FIXTURES,STAINED GLASS,FURNITURE,ORNAMENTS AND CHATTELS IN THE CHURCH AND THE CHURCHYARD BELONGING THERETO.
