**Objects:** (A) FOR THE RESORATION PRESERVATION REPAIR MAINTENANCE IMPROVEMENT BEAUTIFICATION AND RECONSTRUCTION OF THE CHURCH OF DICKLEBURGH NORFOLK ("THE CHURCH")IN THE DIOCESE OF NORWICH AND THE COUNTY OF NORFOLK AND OF THE MONUMENTS FITTINGS FIXTURES STAINED GLASS FURNITURE ORNAMENTS AND CHATTELS IN THE CHURCH AND OF THE CHURCHYARD BELONGING TO THE CHURCH. (B) FOR THE BENEFIT OF THE PEOPLE OF THE SAID COUNTY OF NORFOLK AND THE SAID DIOCESE TO PRESERVE REPAIR MAINTAIN IMPROVE BEAUTIFY AND RECONSTRUCT THE CHURCH AS A BUILDING OF HISTORICAL BEING DECLARED REDUNDANT BY A PASTORAL SCHEME MADE UNDER THE PASTORAL MEASURE 1983 (OR ANY STATUTORY MODIFICATION OR REENACTMENT THEROF) OR OTHERWISE CEASING TO BE USED REGULARLY FOR PUBLIC WORSHIP AND THE MONUMENTS OF FITTINGS FIXTURES STAINED GLASS FURNITURE ORNAMENTS AND CHATTLES IN THE CHURCH AND THE CHURCHYARD BELONGING THERETO.
