Trustee Report 2024-25

Doncaster & Bassetlaw Hospitals NHS Foundation Trust Charitable Funds presents their annual report together with the financial statements for the year ending 31 March 2025.

OBJECTIVES AND ACTIVITIES

Our Charitable Objectives

The Aim of the charity is that:

Charitable funds received by the Charity are accepted, held, and administered as funds and property held on trust for purposes relating to the health service in accordance with the National Health Service Act 2006 by the Corporate Trustee, to benefit patient care and advance the good health and welfare of patients, carers and staff.

The main activity of the charity is to provide grants to wards and departments of Doncaster & Bassetlaw Teaching Hospitals NHS Foundation Trust (DBTH), and for these grants to enhance the environment for patients and staff, going above and beyond what is normally expected of the NHS. The output of this is dependant on the strategic direction of DBTH, although the aims of the Charity are still the same - to provide an enhanced level of support for patients and staff.

The Strategic Report within this document outlines how this has been achieved in 2024/25.

In achieving our purpose, the Trustees have due regard to the Charity Commission's general guidance on public benefit, appreciating that the Charity exists to benefit the patients and staff of DBTH. Grants are structured in a way that ensures the money raised is used to best effect. The Charity does not provide grants directly to the public. Instead, we provide them to the hospital, which in turn ensures the patients and their families, and staff, are supported and receive the best quality care.

Public Benefit – The Trustees confirm that they have complied with the duty in the Charities Act 2011 to have due regard for the Charity Commission's general guidance on public benefit.

Grant Making – Funded projects are decided upon by the Trustees of the Charity in line with the objectives of the Charity. Projects that are funded by the Charity must support and enhance the work of the Trust and not undermine the provision of the NHS.

Strategic Report

Achievements and Performance

Patients' Welfare and Amenities

As a result of the support of donors both in 2024/25 and previously, the charity has been able to support the following projects in the year:

Shuttle Bus service between Mexborough and Doncaster

The free shuttle bus service between the two hospital sites was made possible by the legacy left by Fred & Ann Green a number of years ago. This service connects the two hospital sites, making access to healthcare and in-patient relatives much easier and costs in the region of £200k a year to operate.

By providing free travel between the two sites to allow relatives and loved ones to visit in-patients, this creates opportunities for patients to receive morale-boosting visits, which in turn, aids recovery and reduces length of stay.

The free shuttle bus also allows better access to out-patient appointments at both sites, which improves the health and wellbeing of patients.

Completion of the Surgical Robot Project

In 2023/24, the Charity committed to the purchase of a multi-million pound Intuitive da Vinci XI Surgical Robot to transform the way that cancer surgery is performed, to lead to better outcomes for patients.

In 2024/25, the project was completed, with the installation of the 'Robi Sheldon Alan Surgeonator' or 'Robi' for short. The robot provides a less invasive alternative to traditional surgery.

Operated by a surgeon, a camera and robotic arms are inserted inside the patient and controlled from a console using an advanced set of instruments for minimally invasive surgery. This procedure allows for greater precision than traditional laparoscopic (also known as "keyhole") or open surgery.



Michael Smethurst, a 54-year-old lorry driver, was the first patient to undergo a colorectal operation performed by Robi. The procedure successfully removed a cancerous tumour from his right colon, along with 17 lymph nodes. Just two weeks after surgery, Michael was walking two miles a day, and by five weeks, he was back to cycling.

Michael said, "The operation hasn't left me with any noticeable scarring, and I was walking a day later. I've also been told that I'm less likely to develop a hernia due to the nature of the operation. I would absolutely recommend this method of surgery to others in my position – Robi is the way forward."

Support for Sepsis care and Prevention

In the UK alone, 245,000 people are affected by sepsis with at least 48,000 people losing their lives in sepsis-related illnesses every year. Sepsis claims more lives than breast, bowel and prostate cancer put together.

The Charity has funded two nurse specialists; one for adult and one for paediatric, to make positive changes to sepsis care. For example, within paediatrics, such schemes like "Sepsis Response Boxes", "Paediatric Sepsis Roadshows" and "Sepsis Padlets" are being introduced

The Sepsis Response Boxes are a tool to support effective management of the septic child quickly. Everything required for the sepsis six pathway is available within it,



Dr Hugh Wilson, Acute Consultant in Adult Care and Trust Clinical sepsis lead, explained how the mortality rate from sepsis within the Trust has been falling. He said: "Paediatrics has made great progress with the appointment of Bethany as the specialist nurse in sepsis. Bethany's work has been extremely valuable in improving sepsis care in the Emergency Department (ED) and Paediatrics."

Funding was also provided for online sepsis training for staff. Prior to this, sepsis was taught as part of other courses, making the dedicated sepsis training the first of its kind in the Trust. The three modules, purchased from the UK Sepsis Trust, consist of an introduction to sepsis, adult sepsis and paediatric sepsis. They are accessible to healthcare assistants (HCA), trainee assistant practitioners (TAP) and clinical support workers, as well as all medical and nursing teams, completing the module most relevant to their role.

Dr Ken Agwuh, Director of Infection and Control, and a member of the Sepsis Action Group, said: "As a Trust we are committed to getting it right the first time with Sepsis. We know the importance of early identification, diagnosis and management of this syndrome. "With "Think sepsis", we encourage our healthcare workers to consider the diagnosis of sepsis for every patient that presents in our emergency units acutely unwell or with an acute deterioration while on our wards."

Staff Welfare and Amenities

It is widely acknowledged that a proportion of donors gifting to the Charity wish for the staff to benefit as much as patients.

Whilst controls are in place to ensure such expenditure is appropriate and in line with NHS values, it is important to Some of the items purchased include:

- Training courses allowing staff to develop professionally and personally, beyond their current role.
- Retirement vouchers, as a "thank-you" for spending a substantial length of time providing a service to the people of Doncaster, Worksop and the surrounding areas.
- Office equipment and furnishings, enhancing the staff environment over and above what would normally be expected.

Volunteers and Fundraisers

Our Charity is testament to the generosity of our donors and we are extremely grateful to all who have been involved this year.

The level of support that is received from volunteers and fundraisers is paramount to the Charity and for it to achieve its objectives. Without this, the Charity would not be able to help provide better facilities, provide specialist medical equipment and improve the environment for patients, families and visitors.

It would be impossible to recognise all the volunteers and fundraisers that have supported the Charity in the past, but our sincere thanks goes out to all of them.

A regular feature of this is the support that is received over the Christmas period. Festive fundraising activities, such as the Children's Ward's 'Winter Wonderland', the 'Our Shining Stars' campaign, Festive Sock Day and various independent fundraisers have raised over £25,000 for DBTH Charity.

Amongst those donating gifts were regular supporters Yorkshire Wildlife Park, Doncaster Rovers, Stratstone Mini Doncaster, GXO, Legacy Church and more.



Duncan Batty, former Head of DBTH Charity, said: "On behalf of the Charity, I want to express my gratitude to our incredible local community, businesses, colleagues, and patients who have shown such generosity this festive season. Your donations of money, toys, and, most importantly, your time spent visiting our patients have brought so much joy and comfort to those in need. We are deeply thankful for your unwavering support in helping us make this season brighter for so many."

Review of Charity Activities Year ending 31st March 2025

What are our costs?

Charitable Activities: These are costs related to allowing the charity to meet its objectives. These include direct costs and grants of charitable expenditure.

Raising Funds: Costs related to the running of activities designed to raise funds for the Charity. These costs relate to salaries for staff not performing charitable expenditure, IT costs, transactional finance costs and professional fees for the charity such as audit fees.

What are our funding sources?

We are extremely grateful for the support that our fundraisers, donors and volunteers give to us. Our funding comes from a range of sources, including donations from individuals, fundraising events, corporate donations, legacies and income from investments. Without the support and effort from these sources, we would not be able to enhance the level of care and support for our patients and staff.

Reserves

The Charity aims to hold undesignated reserves sufficient to cover three months operational costs. At the year end the charity held restricted funds of £1,664k and unrestricted funds of £1,072k. The funds held outside of restricted funds are sufficient to cover operational costs for at least three months.

Risk Management

The Trustees have assessed the major risks to which the charity is exposed, in particular those related to the operations and finances of the Trust and are satisfied that systems are in place to mitigate our exposure to the major risks.

The main risk for the charity is the economic uncertainty and to this extent, the Trustees are using investment managers to reduce the level of risk within the investments held. With this in mind, trustees have a risk averse approach to investments, whilst trying to ensure a reasonable level of income into the charity.

Future financial performance and position is likely to be determined by the state of the economy, both in terms of the success and stability of the investments held, as well as the level to which donors feel as though they are able to support the charity. While steps can be taken to manage the risk, the risk still remains and could make it difficult for the charity to achieve its objectives in the short to medium term.

During the year, there was a detailed review of our Investment Policy working alongside our investment managers, Aberdeen Standard. This exercise challenged previous risk appetites and ensured that the updated Investment Policy provided a balance between financial flexibility, financial risk and ethical risk.

Investment Performance

The charity is reporting a small loss on investments of £57k which is a loss of 0.7% in the year, compared to the value of investments held at the start of the financial year. This is against a gain of 6.7% (£454k gain) in the previous year.

The investments were put into a low default risk portfolio. The aim was for the investments to exceed the income available through fixed-term, fixed-yield investments provided by UK High Street banks. It is felt that the performance of the portfolio has met this aim when including investment income.

Charity Lottery

In 2024/25, the Charity launched a fundraising lottery for the first time. The impact on the 2024/25 financial statements is minimal, as it was launched late in the financial year.

The lottery is open to all adults and every penny raised will be reinvested into improving care and services, ensuring participation directly affects the community.

The Charity is extremely mindful of the negative effect that gambling has on some people and is working with industry leaders to ensure appropriate checks are in place. For example, the maximum entry amount per person is £10 and cancelling entries is a simple process.

It is hoped that the lottery will be a significant income stream in future years, helping to fund improvements which will benefit patients and staff for the long term.



Structure, Governance and Management

Doncaster & Bassetlaw Hospitals NHS Foundation Trust Charitable Funds is a registered charity (number: 1057917). It is governed by its Memorandum & Articles of Association.

The Directors of Doncaster & Bassetlaw Teaching Hospitals NHS Foundation Trust act as de-facto Trustees of the Charity, as the NHS Foundation Trust is the corporate Trustee for the Charity.

When an individual ceases to be a Director of the NHS Foundation Trust, they also cease to be a Trustee of the Charity.

The Charity utilises the opinions of a number of governors and key stakeholders to help in its decision making process. This helps provide additional opinions and perspectives into the decision making process and helps ensure the aims of the Charity are being met. However, these are only advisory roles.

No Trustee received any remuneration from the Charity in the financial year 2024/25 for their role with the Charity, although they do receive remuneration for their role with the Foundation Trust.

Our Plans for the Future:

The Charity aims to further utilise the reserves that it has at present to further improve the patient experience across all of its sites.

The main way that the Charity hopes to do this is to supplement the capital works that are due to take place in the next few years and provide an enhanced environment and facilities for patients, which will aid treatment and recovery.

As discussed previously, the charity lottery is a significant area for development and its success will hopefully drive significant levels of income into the charity, which will subsequently help fund charitable activities.

Statement of Trustee responsibilities

- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue its activities.

The Trustees are required to act in accordance with the trust deed and the rules of the charity, within the framework of trust law. The Trustees are responsible for keeping proper accounting records, sufficient to disclose at any time, with reasonable accuracy, the financial position of the charity at that time, and to enable the Trustees to ensure that, where any statements of accounts are prepared by the Trustees under section 132(1) of the Charities Act 2011, those statements of accounts comply with the requirements of regulations under that provision. The Trustees have general responsibility for taking such steps as are reasonably open to the Trustees to safeguard the assets of the charity and to prevent and detect fraud and other irregularities.

The Trustee confirms that it has met the responsibilities set out above and complied with the requirements for preparing the accounts.

Opinion

We have audited the financial statements of Doncaster and Bassetlaw Hospitals NHS Foundation Trust Charitable Fund for the year ended 31 March 2025 which comprise the Statement of Financial Activities, the Balance Sheet, the Cash Flow Statement and the related notes 1 to 18, including a summary of significant accounting policies. 1. Accounting Policies

1.1 Basis of preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102), the Charities Act 2011 and UK Generally Accepted Practice.

The charity constitutes a public benefit entity as defined by FRS 102.

The significant accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all years presented unless otherwise stated.

The charity is a company limited by guarantee not having a share capital, incorporated in the UK, and operates in England. Its Registered Office and Principal Place of Business is shown on page 1.

1.2 Funds

Unrestricted funds are available for use at the discretion of the Trustees in furtherance of the general objectives of the charity and which have not been designated for other purposes. Designated funds comprise unrestricted funds that have been set aside by the trustees for particular purposes.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the charity for particular purposes.

The cost of raising and administering such funds are charged against the specific fund.

1.3 Income

All income is included in the statement of financial activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

The charity recognises legacy income when the amount due can be quantified with reasonable probability and the timing of the receipt is known.

1.4 Donated goods, facilities and services

Donated facilities and donated time are recognised in income at their fair value when their economic benefit is probable, it can be measured reliably and the charity has control over the item. Fair value is determined on the basis of the value of the gift to the Charity. For example, the amount the charity would be willing to pay in the open market for such facilities and services. It is not felt that this can be reliably measured for the reporting period presented.

Doncaster and Bassetlaw Teaching Hospitals NHS Foundation Trust provides some office accommodation, facilities and administration support to the charity on a cost basis.

1.5 Use of Volunteers

A notional amount of time is donated by volunteers to assist with fundraising but no amount is included in the financial statements for volunteer time in line with the SORP (FRS 102). Further detail is given in the Trustees' Annual Report.

Periodically, goods are donated to the Charity and are impractical to value.

1.6 Fundraising and Trading Activities

Income from trading activities includes income earned from fundraising events and trading activities to raise funds for the charity. Income is received in exchange for supplying goods and services in order to raise funds and is recognised when entitlement has occurred.

1. Accounting Policies (continued)

1.7 Investment income

Investment income is earned through holding assets for investment purposes such as shares and gilts. It includes dividends and interest. Where it is not practicable to identify investment management costs incurred within a scheme with reasonable accuracy the investment income is reported net of these costs. It is included when the amount can be measured reliably. Interest income is recognised using the effective interest method and dividend income is recognised as the charity's right to receive payment is established.

The Trustees have considered the most appropriate policy for the investment of funds and decided to invest in a low risk portfolio of stocks, shares and gilts. Investments are stated at market value. The Statement of Financial Activities includes the net gains and losses arising on revaluations and disposals throughout the year.

The main form of financial risk faced by the charity is that of volatility in equity markets and investment markets due to wider economic conditions, the attitude of investors to investment risk, and changes in sentiment concerning equities and within particular sectors or sub sectors.

1.8 Resources expended

All expenditure is accounted for on an accruals basis, except for grants, which are accounted for in the period in which the charity makes a formal commitment to give grant aid.

Resources expended are allocated to the particular activity where the cost relates directly to that activity. The cost of overall direction and overhead costs of the central function are borne by the unrestricted fund.

1.9 Taxation

The Charity is a registered charity, and as such is entitled to certain tax exemptions on income and profits from investments, and surpluses on any trading activities carried on in furtherance of the charity's objectives. Irrecoverable VAT is charged against the category of resources expended for which it was incurred.

1.10 Financial Instruments

Financial assets and financial liabilities which arise from contracts for the purchase or sale of non-financial items are recognised when performance occurs.

1.11 Allocation of overhead and support costs

Due to the small amounts involved, all costs of generating funds have been allocated as governance costs and apportioned across all funds.

1.12 Cost of generating funds

The cost of generating funds is the cost of investment management fees, audit fees and support costs.

1.13 Fundraising Arrangements

The charity has a Corporate Fundraiser, and they are subject to a bonus scheme, depending on the level of income that has been generated, over and above a financial baseline. They are paid by Doncaster & Bassetlaw Healthcare Services Limited, and their costs are recharged back in full to the charity. For 2023/24 and 2024/25, there were no employees who received employee benefits (excluding employer pension costs) of more than £60k. On occasions, the charity will utilise additional staff on an ad-hoc basis.

1.14 Charitable activities

Costs of charitable activities comprise all costs incurred in the pursuit of the charitable objects of the charity. These costs, where not wholly attributable, are apportioned between the categories of charitable expenditure in addition to the direct costs.

Notes to the financial statements for the year ended 31 March 2025

1. Accounting Policies (continued)

1.15 Realised gains and losses

All gains and losses are taken to the Statement of Financial Activities as they arise. Realised gains and losses on investments are calculated as the difference between sales proceeds and opening carrying value (or purchase date if later). Unrealised gains and losses are calculated as the difference between the market value at the end and opening carrying value (or purchase date if later).

1.16 Tangible Fixed Assets

The charity has a small level of fixed assets to aid fundraising. These are help at cost, less depreciation (over 5 years on a straight line basis), and the depreciation charge is included within the costs of raising funds. Annual impairment reviews are made.

1.17 Debtors

Debtors are measured on the basis of amount due less provision for doubtful debt. Debtors include prepayments and accrued income.

1.18 Cash and cash equivalents

Cash and cash equivalents includes cash at bank, cash in hand and deposits held at call with banks and as part of investment portfolios.

1.19 Creditors

Creditors include amounts invoiced to the organisation but not yet paid, along with accrued and committed expenditure.

1.20 Committed Expenditure

In line with the SORP, expenditure on charitable activities is incurred when it is committed, rather than when the goods/services are received.

1.21 Going Concern

After making enquiries, the Trustee is satisfied that the Charity has adequate resources to continue in operational existence for the foreseeable future therefore there are no material uncertainties over going concern.

The charity meets its day-to-day working capital requirements through cash held in the bank and investments. The charity's forecasts and projections, taking account of possible changes in performance including a range of scenarios, show that the charity should be able to operate within the level of its current facilities. This includes stress testing the performance of investments, coupled with operational performance of the charity.

The Trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for a period up to 31st January 2027.

As such, the financial statements are prepared on a going concern basis under the historical cost convention, modified to include listed investments at market value.

11 Details of transfers between funds

The Charity has performed fund transfers in year to ensure the number of separate funds is minimised, whilst ensuring the wishes of donors are met. Any transfers are done to maximise the ability of the charity to fulfil the wishes of the donor.

12 Related Party Transactions

The Doncaster and Bassetlaw Hospitals NHS Foundation Trust is the Corporate Trustee and sole beneficiary of the Charity. The Charity has provided funding to the Trust for approved expenditure made on behalf of the Charity. Included in the financial statements as at 31st March 2025 are Creditors of £5,688k (31st March 2024: £1,676k). As outlined in note 1.13 the charity has a Corporate Fundraisers who are paid by Doncaster & Bassetlaw Healthcare Services Limited, which is a subsidiary of the Foundation Trust and thus it is also a related party of the Charity.

Doncaster and Bassetlaw Hospitals NHS Foundation Trust's principal activity is providing public healthcare in its role as an NHS Foundation Trust.

13 Fund descriptions

Unrestricted funds

These funds are amounts which are not yet designated for a particular project but also where no restriction as to how the funds can be expensed has been placed on the funds by the donor.

Designated funds

The numerous designated funds are projects or fundraising activities being run by the charity where donors can specify the money being donated is for the particular project. These funds are set as to what projects will be run and generally the funds are eligible to be transferred from one to another under the terms of the donations.

Restricted funds

These tend to be a result of one off large donations, regularly from legacies, where the funds are specified to only be spent on a particular type of work. The restrictions do not, usually, restrict the expenditure any further but a close watch is kept as to how these funds are spent and also what opportunities arise to spend the funds on prospective projects.

14 Material Fund Balances

The balance on the Fred & Ann Green Restricted Fund is £261k (2023/24: £482k). The fund received no income in year, and incurred expenditure of £221k.

A further breakdown of fund balances is shown on Note 17.

15 Post balance sheet events

In September 2025, the Doncaster Cancer Detection Trust charity ceased to operate and its funds totalling £341k were transferred to the charity. These funds will be used to support cancer services in future years.

16 Contingent assets

The charity recognises legacy income when it has received notification of the legacy and has sufficient certainty regarding the amount of the receipt. Where there is uncertainty over the amount of the legacy that will be received, income is not recognised until the estate has been finalised by its executors. As at 31 March 2025, there are no such amounts.

The Fred and Ann Green Legacy Fund relates to a significant legacy that was left to the charity many years ago. This is for activities mainly at Montagu and Doncaster hospitals, within the Doncaster & Bassetlaw Teaching Hospitals NHS Foundation Trust umbrella. There are no restrictions with regards to the type of expenditure this fund can be used for - it has been used for activities as diverse as upgraded medical equipment, clinical building enhancements and a staff/patient shuttle bus between Montagu and Doncaster hospital sites.

Material transfers of funds, are as a result of the charity utilising the funds so that they can be most efficiently utilised to meet the wishes of the donor. This is done in a systematic way to ensure there aren't any duplication of funds with similar aims and objectives, which will increase the purchasing power of the fund, as well as reduce management costs. The material transfers in 2024/25 relate to the consolidation of General Funds across all clinical sites, as well as allocation of funds following the Bereavement Suite appeal.

OBJECTIVES AND ACTIVITIES

Our Charitable Objectives

The Aim of the charity is that:

Charitable funds received by the Charity are accepted, held, and administered as funds and property held on trust for purposes relating to the health service in accordance with the National Health Service Act 2006 by the Corporate Trustee, to benefit patient care and advance the good health and welfare of patients, carers and staff.

The main activity of the charity is to provide grants to wards and departments of Doncaster & Bassetlaw Teaching Hospitals NHS Foundation Trust (DBTH), and for these grants to enhance the environment for patients and staff, going above and beyond what is normally expected of the NHS. The output of this is dependant on the stratetic direction of DBTH, although the aims of the Charity are still the same - to provide an enhanced level of support for patients and staff.

The Strategic Report within this document outlines how this has been achieved in 2023/24.

In achieving our purpose, the Trustees have due regard to the Charity Commission's general guidance on public benefit, appreciating that the Charity exists to benefit the patients and staff of DBTH. Grants are structured in a way that ensures the money raised is used to best effect. The Charity does not provide grants directly to the public. Instead, we provide them to the hospital, which in turn ensures the patients and their families, and staff, are supported and receive the best quality care.

Public Benefit – The Trustees confirm that they have complied with the duty in the Charities Act 2011 to have due regard for the Charity Commission's general guidance on public benefit.

Grant Making – Funded projects are decided upon by the Trustees of the Charity in line with the objectives of the Charity. Projects that are funded by the Charity must support and enhance the work of the Trust and not undermine the provision of the NHS.

Strategic Report

Achievements and Performance

Patients' Welfare and Amenities

As a result of the support of donors both in 2023/24 and previously, the charity has been able to support the following projects in the year:

Shuttle Bus service between Mexborough and Doncaster

The free shuttle bus service between the two hospital sites was made possible by the legacy left by Fred & Ann Green a number of years ago. This service connects the two hospital sites, making access to healthcare and in-patient relatives much easier and costs in the region of £200k a year to operate.

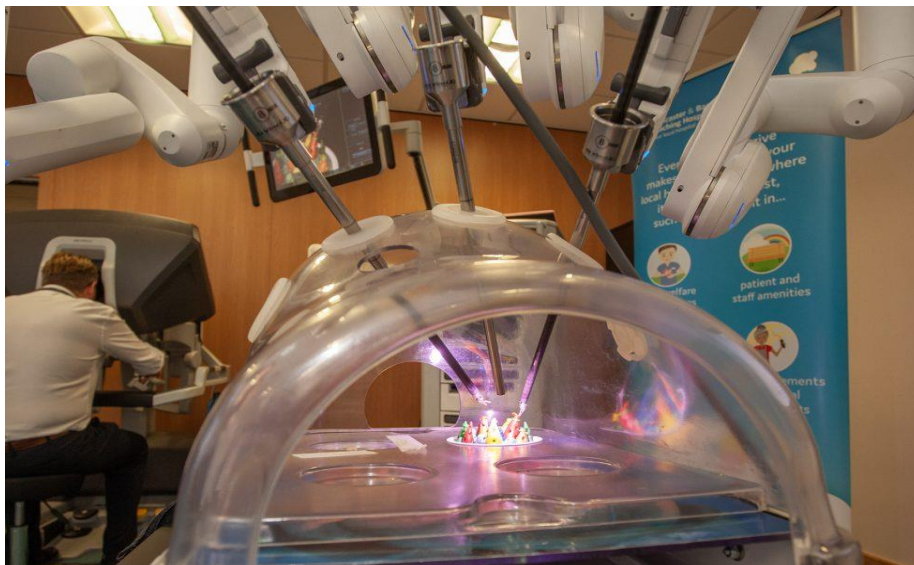
By providing free travel between the two sites to allow relatives and loved ones to visit in-patients, this creates opportunities for patients to receive morale-boosting visits, which in turn, aids recovery and reduces length of stay.

The free shuttle bus also allows better access to out-patient appointments at both sites, which improves the health and wellbeing of patients.

Support for Medical devices for Cancer Surgery

In 2023/24, the Charity committed to the purchase of a multi-million pound Intuitive da Vinci XI Surgical Robot to transform the way that cancer surgery is performed, to lead to better outcomes for patients.

The device works in two parts – the first a specialised console equipped with a 3D display, similar to a virtual reality headset, whilst the second piece contains the surgical arms and 3D camera. Operated by a specially trained surgeon, the robot will be used as part of laparoscopic (also known as ‘keyhole’) or open surgeries. As part of the minimal invasive procedure, the camera and robotic arms are inserted within the patient. These instruments are then operated by the trained surgeon using a set of advanced instruments which are manipulated using your index finger and thumb.



Miss Antonia Durham-Hall, Colorectal Consultant Surgeon and Lead Clinician for Gastrointestinal Surgery at DBTH, remarked: “This investment heralds a new era in colorectal cancer surgery for our patients. As we advance in early cancer detection, it’s imperative that our treatment methods evolve in tandem, ensuring improved post-surgical outcomes and enhanced quality of life.

“I’m extremely pleased that we will be able to offer this to our patients in the near future and thankful to the Doncaster and Bassetlaw Teaching Hospitals Charity, and its kind supporters, for such a significant investment which will transform the lives of so many people.”

Special Appeal Launched for Bassetlaw's new "Emergency Village"

The appeal, once funded, will support holistic improvements in patient comfort and stress relief, including an outdoor play area for children, a bereavement room and specialist sensory toys, amongst much else.

Dr Kirsty Edmondson Jones, Director of Innovation and Infrastructure at DBTH, said: "This appeal, with the kind support of our communities, will help to provide those nice-to-have and holistic improvements not covered by usual NHS funding, something that we hope will move an experience within our service from good to outstanding."



Alongside funding various projects for children and young people, the charity will also be funding a number of projects to support adults such as televisions across all waiting rooms and side rooms, helping to bring the normal comforts from home. It is hoped that the Charity will be able to support over £100k of enhancements to the project.

Suzy Brain England OBE, Chair of the Board at Doncaster and Bassetlaw Teaching Hospitals (DBTH) said: "We are calling upon our communities and businesses to rally behind this appeal. The enhancements we aim to add will benefit patients and improve facilities for our hardworking colleagues. This appeal will enable us to go beyond the standard approach to add a touch of excellence to the Emergency Department, the Children's Assessment Unit, and the Assessment Treatment Centre."

Staff Welfare and Amenities

It is widely acknowledged that a proportion of donors gifting to the Charity wish for the staff to benefit as much as patients.

Whilst controls are in place to ensure such expenditure is appropriate and in line with NHS values, it is important to acknowledge the hard work that staff perform and go above and beyond for patients on a daily basis.

Some of the items purchased include:

- Training courses allowing staff to develop professionally and personally, beyond their current role.
- Retirement vouchers, as a "thank-you" for spending a substantial length of time providing a service to the people of Doncaster, Worksop and the surrounding areas.
- Office equipment and furnishings, enhancing the staff environment over and above what would normally be expected.

Review of Charity Activities Year ending 31st March 2024

What are our costs?

Charitable Activities: These are costs related to allowing the charity to meet its objectives. These include direct costs and grants of charitable expenditure.

Raising Funds: Costs related to the running of activities designed to raise funds for the Charity. These costs relate to salaries for staff not performing charitable expenditure, IT costs, transactional finance costs and professional fees for the charity such as audit fees.

What are our funding sources?

We are extremely grateful for the support that our fundraisers, donors and volunteers give to us. Our funding comes from a range of sources, including donations from individuals, fundraising events, corporate donations, legacies and income from investments. Without the support and effort from these sources, we would not be able to enhance the level of care and support for our patients and staff.

Reserves

The Charity aims to hold undesignated reserves sufficient to cover three months operational costs. At the year end the charity held restricted funds of £1,645k and unrestricted funds of £1,551k. The funds held outside of restricted funds are sufficient to cover operational costs for at least three months.

There are significant amounts which are committed as at 31st March 2024. This is as a result of the timing of such commitments, due to the timing of large, strategic projects within DBTH. It is expected that these will be fully realised within 2024/25.

Risk Management

The Trustees have assessed the major risks to which the charity is exposed, in particular those related to the operations and finances of the Trust and are satisfied that systems are in place to mitigate our exposure to the major risks.

The main risk for the charity is the economic uncertainty and to this extent, the Trustees are using investment managers to reduce the level of risk within the investments held. With this in mind, trustees have a risk averse approach to investments, whilst trying to ensure a reasonable level of income into the charity.

Future financial performance and position is likely to be determined by the state of the economy, both in terms of the success and stability of the investments held, as well as the level to which donors feel as though they are able to support the charity. While steps can be taken to manage the risk, the risk still remains and could make it difficult for the charity to achieve its objectives in the short to medium term.

During the year, there was a detailed review of our Investment Policy working alongside our investment managers, Aberdeen Standard. This exercise challenged previous risk appetites and ensured that the updated Investment Policy provided a balance between financial flexibility, financial risk and ethical risk.

Investment Performance

The charity is reporting a gain on investments of £454k which is a gain of 5.7% in the year, compared to the value of investments held at the start of the financial year. This is against a loss of 7% (£675k loss) in the previous year.

The investments were put into a low default risk portfolio. The aim was for the investments to exceed the income available through fixed-term, fixed-yield investments provided by UK High Street banks. It is felt that the performance of the portfolio has met this aim.

Structure, Governance and Management

Doncaster & Bassetlaw Hospitals NHS Foundation Trust Charitable Funds is a registered charity (number: 1057917). It is governed by its Memorandum & Articles of Association.

The Directors of Doncaster & Bassetlaw Teaching Hospitals NHS Foundation Trust act as de-facto Trustees of the Charity, as the NHS Foundation Trust is the corporate Trustee for the Charity.

When an individual ceases to be a Director of the NHS Foundation Trust, they also cease to be a Trustee of the Charity.

The Charity utilises the opinions of a number of governors and key stakeholders to help in its decision making process. This helps provide additional opinions and perspectives into the decision making process and helps ensure the aims of the Charity are being met. However, these are only advisory roles.

No Trustee received any remuneration from the Charity in the financial year 2023/24 for their role with the Charity, although they do receive remuneration for their role with the Foundation Trust.

Our Plans for the Future:

The Charity aims to further utilise the reserves that it has at present to further improve the patient experience across all of its sites.

The main way that the Charity hopes to do this is to supplement the capital works that are due to take place in the next few years and provide an enhanced environment and facilities for patients, which will aid treatment and recovery.

Statement of Trustee responsibilities

The Trustees are responsible for keeping proper accounting records, sufficient to disclose at any time, with reasonable accuracy, the financial position of the charity at that time, and to enable the Trustees to ensure that, where any statements of accounts are prepared by the Trustees under section 132(1) of the Charities Act 2011, those statements of accounts comply with the requirements of regulations under that provision. The Trustees have general responsibility for taking such steps as are reasonably open to the Trustees to safeguard the assets of the charity and to prevent and detect fraud and other irregularities.

The Trustee confirms that it has met the responsibilities set out above and complied with the requirements for preparing the accounts.

So far as each of the Trustees at the time the report is approved are aware:

- a) there is no relevant audit information of which the auditors are unaware and,
- b) the Trustees have taken all the steps they ought to have taken to make themselves aware of any relevant audit information and to establish that the auditors are aware of that information.

Opinion



- We understood how Doncaster and Bassetlaw Hospitals NHS Foundation Trust Charitable Fund is complying with those frameworks by understanding the incentive, opportunities and motives for non-compliance, including inquiring of management and obtaining and reviewing documentation relating to the procedures in place to identify, evaluate and comply with laws and regulations, and whether they are aware of instances of non-compliance. We corroborated this through our review of minutes and through the inspection of other information. Based on this understanding we designed our audit procedures to identify non-compliance with such laws and regulations. Our procedures had a focus on compliance with the accounting framework through obtaining sufficient audit evidence in line with the level of risk identified and with relevant legislation.
- We assessed the susceptibility of the charity's financial statements to material misstatement, including how fraud might occur by understanding the potential incentives and pressures for management to manipulate the financial statements, and performed procedures to understand the areas in which this would most likely arise. Based on our risk assessment procedures, we identified manipulation of reported financial performance through improper recognition of income, and management override of controls to be our fraud risks.

Our procedures also involved testing of journal entries, with a focus on journals meeting our defined risk criteria based on our understanding of the business, enquiries of management reading and reviewing relevant meeting minutes, understanding the internal controls in place to mitigate risks related to fraud and non-compliance with laws and regulations, and remaining alert to potential instances of non-compliance with laws and regulations during our substantive procedures performed on the financial statements. Notes to the financial statements for the year ended 31 March 2024

1. Accounting Policies

1.1 Basis of preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014, the Charities Act 2011 and UK Generally Accepted Practice as it applies from 1 January 2016.

The charity constitutes a public benefit entity as defined by FRS 102.

The significant accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all years presented unless otherwise stated.

1.2 Funds

Unrestricted funds are available for use at the discretion of the Trustees in furtherance of the general objectives of the charity and which have not been designated for other purposes. Designated funds comprise unrestricted funds that have been set aside by the trustees for particular purposes.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the charity for particular purposes.

The cost of raising and administering such funds are charged against the specific fund.

1.3 Income

All income is included in the statement of financial activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

The charity recognises legacy income when the amount due can be quantified with reasonable probability and the timing of the receipt is known.

1.4 Donated goods, facilities and services

Donated facilities and donated time are recognised in income at their fair value when their economic benefit is probable, it can be measured reliably and the charity has control over the item. Fair value is determined on the basis of the value of the gift to the Charity. For example, the amount the charity would be willing to pay in the open market for such facilities and services. It is not felt that this can be reliably measured for the reporting period presented.

Doncaster and Bassetlaw Teaching Hospitals NHS Foundation Trust provides some office accommodation, facilities and administration support to the charity on a cost basis.

1.5 Use of Volunteers

A notional amount of time is donated by volunteers to assist with fundraising but no amount is included in the financial statements for volunteer time in line with the SORP (FRS 102). Further detail is given in the Trustees' Annual Report.

Periodically, goods are donated to the Charity and are impractical to value.

1.6 Fundraising and Trading Activities

Income from trading activities includes income earned from fundraising events and trading activities to raise funds for the charity. Income is received in exchange for supplying goods and services in order to raise funds and is recognised when entitlement has occurred.

1.7 Investment income

Investment income is earned through holding assets for investment purposes such as shares and gilts. It includes dividends and interest. Where it is not practicable to identify investment management costs incurred within a scheme with reasonable accuracy the investment income is reported net of these costs. It is included when the amount can be measured reliably. Interest income is recognised using the effective interest method and dividend income is recognised as the charity's right to receive payment is established.

The Trustees have considered the most appropriate policy for the investment of funds and decided to invest in a low risk portfolio of stocks, shares and gilts. Investments are stated at market value. The Statement of Financial Activities includes the net gains and losses arising on revaluations and disposals throughout the year.

The main form of financial risk faced by the charity is that of volatility in equity markets and investment markets due to wider economic conditions, the attitude of investors to investment risk, and changes in sentiment concerning equities and within particular sectors or sub sectors.

1.8 Resources expended

All expenditure is accounted for on an accruals basis, except for grants, which are accounted for in the period in which the charity makes a formal commitment to give grant aid.

Resources expended are allocated to the particular activity where the cost relates directly to that activity. The cost of overall direction and overhead costs of the central function are borne by the unrestricted fund.

1.9 Taxation

The Charity is a registered charity, and as such is entitled to certain tax exemptions on income and profits from investments, and surpluses on any trading activities carried on in furtherance of the charity's objectives. Irrecoverable VAT is charged against the category of resources expended for which it was incurred.

1.10 Financial Instruments

Financial assets and financial liabilities which arise from contracts for the purchase or sale of non-financial items are recognised when performance occurs.

1.11 Allocation of overhead and support costs

Due to the small amounts involved, all costs of generating funds have been allocated as governance costs and apportioned across all funds.

1.12 Cost of generating funds

The cost of generating funds is the cost of investment management fees, audit fees and support costs.

1.13 Fundraising Arrangements

The charity has a Corporate Fundraiser, and they are subject to a bonus scheme, depending on the level of income that has been generated, over and above a financial baseline. They are paid by Doncaster & Bassetlaw Healthcare Services Limited, and their costs are recharged back in full to the charity. For 2022/23 and 2023/24, there were no employees who received employee benefits (excluding employer pension costs) of more than £60k. On occasions, the charity will utilise additional staff on an ad-hoc basis.

1.14 Charitable activities

Costs of charitable activities comprise all costs incurred in the pursuit of the charitable objects of the charity. These costs, where not wholly attributable, are apportioned between the categories of charitable expenditure in addition to the direct costs.

Notes to the financial statements for the year ended 31 March 2024

1. Accounting Policies (continued)

1.15 Realised gains and losses

All gains and losses are taken to the Statement of Financial Activities as they arise. Realised gains and losses on investments are calculated as the difference between sales proceeds and opening carrying value (or purchase date if later). Unrealised gains and losses are calculated as the difference between the market value at the end and opening carrying value (or purchase date if later).

1.16 Tangible Fixed Assets

The charity has a small level of fixed assets to aid fundraising. These are help at cost, less depreciation (over 5 years on a straight line basis), and the depreciation charge is included within the costs of raising funds. Annual impairment reviews are made.

1.17 Debtors

Debtors are measured on the basis of amount due less provision for doubtful debt. Debtors include prepayments and accrued income.

1.18 Cash and cash equivalents

Cash and cash equivalents includes cash at bank, cash in hand and deposits held at call with banks and as part of investment portfolios.

1.19 Creditors

Creditors include amounts invoiced to the organisation but not yet paid, along with accrued and committed expenditure.

1.20 Committed Expenditure

In line with the SORP, expenditure on charitable activities is incurred when it is committed, rather than when the goods/services are received.

1.21 Going Concern

After making enquiries, the Trustee is satisfied that the Charity has adequate resources to continue in operational existence for the foreseeable future therefore there are no material uncertainties over going concern.

The charity meets its day-to-day working capital requirements through cash held in the bank and investments. The charity's forecasts and projections, taking account of possible changes in performance including a range of scenarios, show that the charity should be able to operate within the level of its current facilities. This includes stress testing the performance of investments, coupled with operational performance of the charity.

The Trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for a period up to 31st May 2026.

As such, the financial statements are prepared on a going concern basis under the historical cost convention, modified to include listed investments at market value.

1.22 Prior Year Adjustment

11 Details of transfers between funds

The only significant movement between funds is related to a reallocation of investment gains and losses. This is across all the funds within the charity.

12 Related Party Transactions

The Doncaster and Bassetlaw Hospitals NHS Foundation Trust is the Corporate Trustee and sole beneficiary of the Charity. The Charity has provided funding to the Trust for approved expenditure made on behalf of the Charity. Included in the financial statements as at 31st March 2024 are Creditors of £1,619k (31st March 2023: £145k). As outlined in note 1.13 the charity has a Corporate Fundraiser who is paid by Doncaster & Bassetlaw Healthcare Services Limited, which is a subsidiary of the Foundation Trust and thus it is also a related party of the Charity. Included in the financial statements as at 31st March 2024 are Creditors of £57k (31st March 2023: £nil) with this organisation.

Doncaster and Bassetlaw Hospitals NHS Foundation Trust's principal activity is providing public healthcare in its role as an NHS Foundation Trust.

13 Fund descriptions

Unrestricted funds

These funds are amounts which are not yet designated for a particular project but also where no restriction as to how the funds can be expensed has been placed on the funds by the donor.

Designated funds

The numerous designated funds are projects or fundraising activities being run by the charity where donors can specify the money being donated is for the particular project. These funds are set as to what projects will be run and generally the funds are eligible to be transferred from one to another under the terms of the donations.

Restricted funds

These tend to be a result of one off large donations, regularly from legacies, where the funds are specified to only be spent on a particular type of work. The restrictions do not, usually, restrict the expenditure any further but a close watch is kept as to how these funds are spent and also what opportunities arise to spend the funds on prospective projects.

14 Material Fund Balances

The balance on the Fred & Ann Green Restricted Fund is £482k (2022/23: £4,468k). The fund received no income in year, and incurred expenditure of £3,986k.

A further breakdown of fund balances is shown on Note 17.

15 Post balance sheet events

There are no post balance sheet events having a material effect on the financial statements.

16 Contingent assets

The charity recognises legacy income when it has received notification of the legacy and has sufficient certainty regarding the amount of the receipt. Where there is uncertainty over the amount of the legacy that will be received, income is not recognised until the estate has been finalised by its executors. As at 31 March 2024, there are no such amounts.

OBJECTIVES AND ACTIVITIES

Our Charitable Objectives

The Aim of the charity is that:

Charitable funds received by the Charity are accepted, held, and administered as funds and property held on trust for purposes relating to the health service in accordance with the National Health Service Act 2006 by the Corporate Trustee, to benefit patient care and advance the good health and welfare of patients, carers and staff.

In reality, this means that the donations received by the Charity are used to enhance the environment for patients and staff, going above and beyond what is normally expected of the NHS.

In setting our objectives and planning our activities, our Trustees have given careful consideration to the Charity Commission's general guidance on public benefit.

Public Benefit – The Trustees confirm that they have complied with the duty in the Charities Act 2011 to have due regard for the Charity Commission's general guidance on public benefit.

Grant Making – Funded projects are decided upon by the Trustees of the Charity in line with the objectives of the Charity. Projects that are funded by the Charity must support and enhance the work of the Trust and not undermine the provision of the NHS.

Strategic Report

Achievements and Performance

Patients' Welfare and Amenities

As a result of the support of donors both in 2022/23 and previously, the charity has been able to support the following projects in the year:

Shuttle Bus service between Mexborough and Doncaster

The free shuttle bus service between the two hospital sites was made possible by the legacy left by Fred & Ann Green a number of years ago. This service connects the two hospital sites, making access to healthcare and in-patient relatives much easier.

By providing free travel between the two sites to allow relatives and loved ones to visit in-patients, this creates opportunities for patients to receive morale-boosting visits, which in turn, aids recovery and reduces length of stay.

The free shuttle bus also allows better access to out-patient appointments at both sites, which improves the health and wellbeing of patients.

Covid-19 Memorial Sculpture now in place in Doncaster

A sculpture has been erected in Doncaster in memory of those who sadly lost their life to coronavirus and to honour the efforts of key workers throughout the pandemic.

Located just outside of Doncaster's former Museum and Art Gallery on Chequer Road and standing at nine feet tall at its height, the monument is currently a sky blue arch. Once completed, it will resemble a rainbow with individually etched hearts making up its constituent colours. In total, there is room for over 5,000 hearts, and residents are encouraged to support the project which is being called 'Hearts for Doncaster'. So far local people have sponsored 600 acrylic hearts, all of which bear a special message.



Richard Parker OBE, Chief Executive, said: "We began this project in 2021, and it is wonderful to see it come to fruition. I can't wait to see it flourish over the coming days, weeks and months as it transforms into a rainbow."

"Local people can still get involved in this project by dedicating a heart. Each of these can have a simple message of your choosing and will be a core part of the design of the memorial. Most importantly, any funds raised will be reinvested in local NHS services – on which so many of us have depended throughout the past few years."

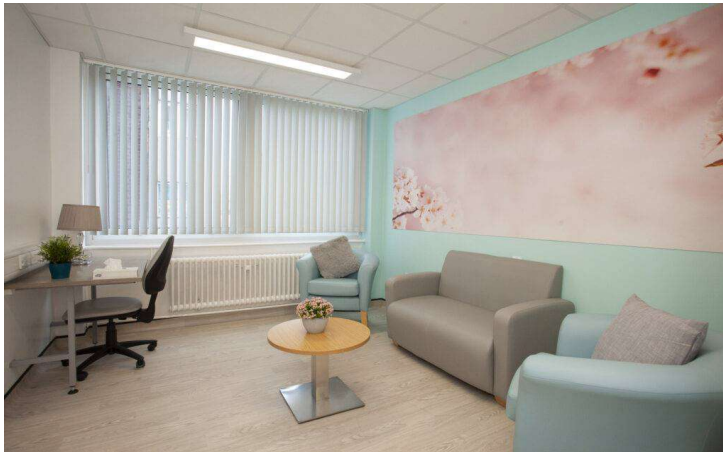
Specialist bereavement suite opens at Doncaster Royal Infirmary

It would be impossible to recognise all the volunteers and fundraisers that have supported the Charity in the past, but our sincere thanks goes out to all of them.

One example is during December 2022, players from Doncaster football and rugby teams visited Doncaster Royal Infirmary (DRI) to hand-deliver gift bags for the youngsters on the children's wards.

Alongside Play & Activity Leaders, Icky Lall and Maxine Deakin, the players visited the bedsides of children throughout the wards, chatting with them and watching as they unpacked their gift bags.



Icky Lall said: "We are so grateful to this group of players for coming to visit us. It was wonderful to see them chat with each individual child and take the time to make the visit memorable. I'm sure this is an experience that many of the children will not forget, thank you."

Review of Charity Activities Year ending 31st March 2023

What are our costs?

Charitable Activities: These are costs related to allowing the charity to meet its objectives. These include direct costs and grants of charitable expenditure.

Raising Funds: Costs related to the running of activities designed to raise funds for the Charity. These costs relate to salaries for staff not performing charitable expenditure, IT costs, transactional finance costs and professional fees for the charity such as audit fees.

Reserves

The Charity aims to hold undesignated reserves sufficient to cover three months operational costs. At the year end the charity held restricted funds of £5,661k and unrestricted funds of £1,595k. The funds held outside of restricted funds are sufficient to cover operational costs for at least three months.

Risk Management

The Trustees have assessed the major risks to which the charity is exposed, in particular those related to the operations and finances of the Trust and are satisfied that systems are in place to mitigate our exposure to the major risks.

The main risk for the charity is the economic uncertainty and to this extent, the Trustees are using investment managers to reduce the level of risk within the investments held. With this in mind, trustees have a risk averse approach to investments, whilst trying to ensure a reasonable level of income into the charity.

Future financial performance and position is likely to be determined by the state of the economy, both in terms of the success and stability of the investments held, as well as the level to which donors feel as though they are able to support the charity. While steps can be taken to manage the risk, the risk still remains and could make it difficult for the charity to achieve its objectives in the short to medium term.

During the year, there was a detailed review of our Investment Policy working alongside our investment managers, Aberdeen Standard. This exercise challenged previous risk appetites and ensured that the updated Investment Policy provided a balance between financial flexibility, financial risk and ethical risk.

Investment Performance

The charity is reporting a loss on investments of £675k which is a loss of 7% in the year. This is against a gain of 7% (£581k gain) in the previous year, which was caused by the recovery from the initial impact of Covid-19 on the financial markets. As a comparison, the FTSE 100 had a gain of 1% during 2022/23.

The investments were put into a low default risk portfolio. The aim was for the investments to exceed the income available through fixed-term, fixed-yield investments provided by UK High Street banks. However, the underperformance was a result of increasing interest rates and inflation which negatively affected the portfolio.

Structure, Governance and Management

Doncaster & Bassetlaw Hospitals NHS Foundation Trust Charitable Funds is a registered charity (number: 1057917). It is governed by its Memorandum & Articles of Association.

The Directors of Doncaster & Bassetlaw Teaching Hospitals NHS Foundation Trust act as de-facto Trustees of the Charity, as the NHS Foundation Trust is the corporate Trustee for the Charity.

When an individual ceases to be a Director of the NHS Foundation Trust, they also cease to be a Trustee of the Charity.

The Charity utilises the opinions of a number of governors and key stakeholders to help in its decision making process. This helps provide additional opinions and perspectives into the decision making process and helps ensure the aims of the Charity are being met. However, these are only advisory roles.

No Trustee received any remuneration from the Charity in the financial year 2022/23 for their role with the Charity, although they do receive remuneration for their role with the Foundation Trust.

Our Plans for the Future:

The Charity aims to further utilise the reserves that it has at present to further improve the patient experience across all of its sites.

The main way that the Charity hopes to do this is to supplement the capital works that are due to take place in the next few years and provide an enhanced environment and facilities for patients, which will aid treatment and recovery.

Statement of Trustee responsibilities

Under charity law, the Trustees are responsible for preparing the Trustees' annual report and accounts for each financial year which show a true and fair view of the state of affairs of the charity and of the excess of expenditure over income for that period.

- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue its activities.

The Trustees are responsible for keeping proper accounting records, sufficient to disclose at any time, with reasonable accuracy, the financial position of the charity at that time, and to enable the Trustees to ensure that, where any statements of accounts are prepared by the Trustees under section 132(1) of the Charities Act 2011, those statements of accounts comply with the requirements of regulations under that provision. The Trustees have general responsibility for taking such steps as are reasonably open to the Trustees to safeguard the assets of the charity and to prevent and detect fraud and other irregularities.

The Trustee confirms that it has met the responsibilities set out above and complied with the requirements for preparing the accounts.

In the calculation of net cash from operating activities, the prior year figure for the increase in creditors has been restated by £74,000 from £384,000 to £458,000, this has in turn resulted in the restatement of the net cash flow from operating activities by £74,000 from £(570,000) to £(496,000). As a result, within the cashflow statement the net decrease in cash and cash equivalents has been restated from £252,000 to £178,000 and the value of cash and cash equivalents at 31 March restated from £576,000 to £650,000. This has arisen due to an error in the calculation of the increase in creditors in the prior year.

Notes to the financial statements for the year ended 31 March 2023

1. Accounting Policies

1.1 Basis of preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014, the Charities Act 2011 and UK Generally Accepted Practice as it applies from 1 January 2016.

The charity constitutes a public benefit entity as defined by FRS 102.

After making enquiries, the Trustee is satisfied that the Charity has adequate resources to continue in operational existence for the foreseeable future therefore there are no material uncertainties over going concern.

The financial statements are prepared on a going concern basis under the historical cost convention, modified to include listed investments at market value.

The financial statements are prepared in sterling which is the functional currency of the charity.

The significant accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all years presented unless otherwise stated.

1.2 Funds

Unrestricted funds are available for use at the discretion of the Trustees in furtherance of the general objectives of the charity and which have not been designated for other purposes. Designated funds comprise unrestricted funds that have been set aside by the trustees for particular purposes.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the charity for particular purposes.

The cost of raising and administering such funds are charged against the specific fund.

1.3 Income

All income is included in the statement of financial activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

The charity recognises legacy income when the amount due can be quantified with reasonable probability and the timing of the receipt is known.

1. Accounting Policies (continued)

1.4 Donated goods, facilities and services

Donated facilities and donated time are recognised in income at their fair value when their economic benefit is probable, it can be measured reliably and the charity has control over the item. Fair value is determined on the basis of the value of the gift to the Charity. For example, the amount the charity would be willing to pay in the open market for such facilities and services. It is not felt that this can be reliably measured for the reporting period presented.

Doncaster and Bassetlaw Teaching Hospitals NHS Foundation Trust provides some office accommodation, facilities and administration support to the charity free of charge.

1.5 Use of Volunteers

No amount is included in the financial statements for volunteer time in line with the SORP (FRS 102). Further detail is given in the Trustees' Annual Report.

A notional amount of time is donated by volunteers to assist with fundraising. Periodically, goods are donated to the Charity and are impractical to value.

1.6 Fundraising and Trading Activities

Income from trading activities includes income earned from fundraising events and trading activities to raise funds for the charity. Income is received in exchange for supplying goods and services in order to raise funds and is recognised when entitlement has occurred.

1.7 Investment income

Investment income is earned through holding assets for investment purposes such as shares and gilts. It includes dividends and interest. Where it is not practicable to identify investment management costs incurred within a scheme with reasonable accuracy the investment income is reported net of these costs. It is included when the amount can be measured reliably. Interest income is recognised using the effective interest method and dividend income is recognised as the charity's right to receive payment is established.

The Trustees have considered the most appropriate policy for the investment of funds and decided to invest in a low risk portfolio of stocks, shares and gilts. Investments are stated at market value. The Statement of Financial Activities includes the net gains and losses arising on revaluations and disposals throughout the year.

The main form of financial risk faced by the charity is that of volatility in equity markets and investment markets due to wider economic conditions, the attitude of investors to investment risk, and changes in sentiment concerning equities and within particular sectors or sub sectors.

1.8 Resources expended

All expenditure is accounted for on an accruals basis, except for grants, which are accounted for in the period in which the charity makes a formal commitment to give grant aid.

Resources expended are allocated to the particular activity where the cost relates directly to that activity. The cost of overall direction and overhead costs of the central function are borne by the unrestricted fund.

Notes to the financial statements for the year ended 31 March 2023

1. Accounting Policies (continued)

1.9 Taxation

The Charity is a registered charity, and as such is entitled to certain tax exemptions on income and profits from investments, and surpluses on any trading activities carried on in furtherance of the charity's objectives. Irrecoverable VAT is charged against the category of resources expended for which it was incurred.

1.10 Financial Instruments

Financial assets and financial liabilities which arise from contracts for the purchase or sale of non-financial items are recognised when performance occurs.

1.11 Allocation of overhead and support costs

Due to the small amounts involved, all costs of generating funds have been allocated as governance costs and apportioned across all funds.

1.12 Cost of generating funds

The cost of generating funds is the cost of investment management fees, audit fees and support costs.

1.13 Fundraising Arrangements

The charity has a Corporate Fundraiser, and they are subject to a bonus scheme, depending on the level of income that has been generated, over and above a financial baseline. They are paid by Doncaster & Bassetlaw Healthcare Services Limited, and their costs are recharged back in full to the charity. For 2020/21 and 2021/22, there were no employees who received employee benefits (excluding employer pension costs) of more than £60k. In occasions, the charity will utilise additional staff on an ad-hoc basis.

1.14 Charitable activities

Costs of charitable activities comprise all costs incurred in the pursuit of the charitable objects of the charity. These costs, where not wholly attributable, are apportioned between the categories of charitable expenditure in addition to the direct costs.

1.15 Realised gains and losses

All gains and losses are taken to the Statement of Financial Activities as they arise. Realised gains and losses on investments are calculated as the difference between sales proceeds and opening carrying value (or purchase date if later). Unrealised gains and losses are calculated as the difference between the market value at the end and opening carrying value (or purchase date if later).

1.16 Tangible Fixed Assets

The charity has a small level of fixed assets to aid fundraising. These have been depreciated over 5 years on a straight line basis, and the depreciation charge is included within the costs of raising funds.

1.17 Debtors

Debtors are measured on the basis of amount due less provision for doubtful debt. Debtors include prepayments and accrued income.

1. Accounting Policies (continued)

1.18 Cash and cash equivalents

Cash and cash equivalents includes cash at bank, cash in hand and deposits held at call with banks and as part of investment portfolios.

1.19 Creditors

Creditors include amounts invoiced to the organisation but not yet paid, along with accrued and committed expenditure.

1.20 Going Concern

The charity meets its day-to-day working capital requirements through cash held in the bank and investments. The charity's forecasts and projections, taking account of possible changes in performance including a range of scenarios, show that the charity should be able to operate within the level of its current facilities. The Trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future and for the period to 31 January 2025, a period of at least 12 months from the date the financial statements were authorised for issue. As such, the going concern basis is used in preparing the financial statements.

The Doncaster and Bassetlaw Hospitals NHS Foundation Trust is the Corporate Trustee and sole beneficiary of the Charity. The Charity has provided funding to the Trust for approved expenditure made on behalf of the Charity. Included in the financial statements as at 31st March 2023 are Creditors of £145k (31st March 2022: £95k). As outlined in note 1.13 the charity has a Corporate Fundraiser who is paid by Doncaster & Bassetlaw Healthcare Services Limited, which is a subsidiary of the Foundation Trust and thus it is also a related party of the Charity.

13 Fund descriptions

Unrestricted funds

These funds are amounts which are not yet designated for a particular project but also where no restriction as to how the funds can be expensed has been placed on the funds by the donor.

Designated funds

The numerous designated funds are projects or fundraising activities being run by the charity where donors can specify the money being donated is for the particular project. These funds are set as to what projects will be run and generally the funds are eligible to be transferred from one to another under the terms of the donations.

Restricted funds

These tend to be a result of one off large donations, regularly from legacies, where the funds are specified to only be spent on a particular type of work. The restrictions do not, usually, restrict the expenditure any further but a close watch is kept as to how these funds are spent and also what opportunities arise to spend the funds on prospective projects.

14 Material Fund Balances

The balance on the Fred & Ann Green Restricted Fund is £4,468k (2021/22: £6,558k). The fund received no income in year, and incurred expenditure of £1,292k, transfers of £395k and investment losses of £433k.

A further breakdown of fund balances is shown on Note 17.

15 Post balance sheet events

There are no post balance sheet events having a material effect on the financial statements.

16 Contingent assets

The charity recognises legacy income when it has received notification of the legacy and has sufficient certainty regarding the amount of the receipt. Where there is uncertainty over the amount of the legacy that will be received, income is not recognised until the estate has been finalised by its executors.

The Fred and Ann Green Legacy Fund relates to a significant legacy that was left to the charity many years ago. This is for activities mainly at Montagu and Doncaster hospitals, within the Doncaster & Bassetlaw Teaching Hospitals NHS Foundation Trust umbrella. There are no restrictions with regards to the type of expenditure this fund can be used for - it has been used for activities as diverse as upgraded medical equipment, clinical building enhancements and a staff/patient shuttle bus between Montagu and Doncaster hospital sites.

The only significant movement between funds is related to a reallocation of investment gains and losses. This is across all the funds within the charity, but has a significant impact on the Fred and Ann Green Legacy Fund. This reallocation of gains and losses ensures the financial impact of the investments is kept within a central, general fund, which allows for more accurate performance management of the investments and ensures smaller individual funds don't experience volatility of investment gains and losses. A review has been done of the conditions from legacies within the restricted fund listing and there are no such conditions to prevent this reallocation.

OBJECTIVES AND ACTIVITIES

Our Charitable Objectives

The Aim of the charity is that:

Charitable funds received by the Charity are accepted, held, and administered as funds and property held on trust for purposes relating to the health service in accordance with the National Health Service Act 2006 by the Corporate Trustee, to benefit patient care and advance the good health and welfare of patients, carers and staff.

In reality, this means that the donations received by the Charity are used to enhance the environment for patients and staff, going above and beyond what is normally expected of the NHS.

In setting our objectives and planning our activities, our Trustees have given careful consideration to the Charity Commission's general guidance on public benefit.

Public Benefit – The Trustees confirm that they have complied with the duty in the Charities Act 2011 to have due regard for the Charity Commission's general guidance on public benefit.

Grant Making – Funded projects are decided upon by the Trustees of the Charity in line with the objectives of the Charity. Projects that are funded by the Charity must support and enhance the work of the Trust and not undermine the provision of the NHS.

Strategic Report

Achievements and Performance

Patients' Welfare and Amenities

As a result of the support of donors both in 2021/22 and previously, the charity has been able to support the following projects in the year:

Shuttle Bus service between Mexborough and Doncaster

The free shuttle bus service between the two hospital sites was made possible by the legacy left by Fred & Ann Green a number of years ago. This service connects the two hospital sites, making access to healthcare and in-patient relatives much easier.

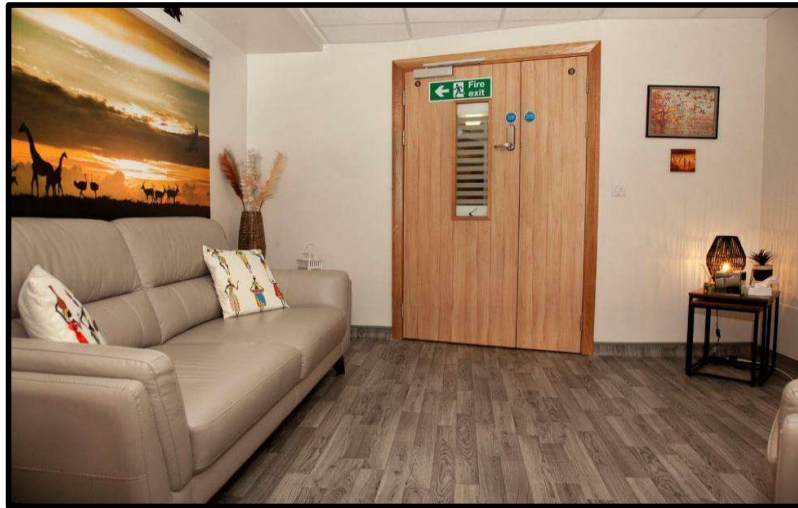
By providing free travel between the two sites to allow relatives and loved ones to visit in-patients, this creates opportunities for patients to receive morale-boosting visits, which in turn, aids recovery and reduces length of stay.

The free shuttle bus also allows better access to out-patient appointments at both sites, which improves the health and wellbeing of patients.

Newly created bereavement room

The newly designed space will be known as the 'Butterfield Suite' and dedicated to the memory of Lorraine Butterfield, an extraordinary Registered Nurse who worked for many years at DRI and who sadly passed away during the pandemic.

The Butterfield Suite is a place where relatives and friends can stay, away from the busy ward, giving them a space to grieve following the loss of a loved one. It offers privacy and dignity as well as facilities to wash and freshen up if required.



Abigail Trainer, Director of Nursing at Doncaster and Bassetlaw Teaching Hospitals (DBTH), said: "The Butterfield Suite is a much-needed addition to our hospital. It will provide a peaceful environment, and somewhere where relatives and friends can go to obtain some privacy at a time when they may need it the most. Losing someone is never easy, and we want to make this time as comfortable as possible, with friends and families receiving appropriate support."



Health professionals within the Emergency Department also believe this space will provide a fitting tribute to their colleague Lorraine, who sadly passed in November 2020 following a brief battle with COVID-19.

Baby Loss Awareness Week

Doncaster and Bassetlaw Teaching Hospitals lit up their buildings in the Baby Loss Awareness Week colours, pink and blue, throughout the week, along with some other buildings in the local area including Retford Town Hall,

This year Baby Loss Awareness Week explored the theme of wellbeing and encouraging those affected by pregnancy and baby loss to share what helped them to recover and build a life after loss.



The special events planned for the week were organised by the Trust's bereavement midwives, Matt Proctor and Rhian Morris. They said: "We hope that some of the events planned for Baby Loss Awareness Week will enable open conversations around pregnancy loss, therefore helping others feel comfortable sharing their experiences."



Staff Welfare and Amenties

It is widely acknowledged that a proportion of donors gifting to the Charity wish for the staff to benefit as much as patients.

Whilst controls are in place to ensure such expenditure is appropriate and in line with NHS values, it is important to acknowledge the hard work that staff perform and go above and beyond for patients on a daily basis.

Some of the items purchased include:

- Training courses allowing staff to develop professionally and personally, beyond their current role.
- Retirement vouchers, as a "thank-you" for spending a substantial length of time providing a service to the people of Doncaster, Worksop and the surrounding areas.
- Office equipment and furnishings, enhancing the staff environment over and above what would normally be expected.

Volunteers and Fundraisers

Our Charity is testament to the generosity of our donors and we are extremely grateful to all who have been involved this year.

The level of support that is received from volunteers and fundraisers is paramount to the Charity and for it to achieve its objectives. Without this, the Charity would not be able to help provide better facilities, provide specialist medical equipment and improve the environment for patients, families and visitors.

It would be impossible to recognise all the volunteers and fundraisers that have supported the Charity in the past, but our sincere thanks goes out to all of them.

One fundraising scheme that has increased in popularity during 2021/22 has been the Christmas Star Appeal.

Throughout the Christmas period, over 30 stars of all shapes and sizes lit up across the buildings which make up Doncaster and Bassetlaw Teaching Hospitals.



The headline sponsor, DFS, have for the second-year running committed £10,000, and in the process have helped to raise over £30,000 which will be directly reinvested into patient care, treatment and facilities.

Review of Charity Activities Year ending 31st March 2022

What are our costs?

Charitable Activities: These are costs related to allowing the charity to meet its objectives. These include direct costs and grants of charitable expenditure.

Raising Funds: Costs related to the running of activities designed to raise funds for the Charity. These costs relate to salaries for staff not performing charitable expenditure, IT costs, transactional finance costs and professional fees for the charity such as audit fees.

Reserves

The Charity aims to hold undesignated reserves sufficient to cover three months operational costs. At the year end the charity held restricted funds of £7,396k and unrestricted funds of £1,877k. The funds held outside of restricted funds are sufficient to cover operational costs for at least three months.

Risk Management

The Trustees have assessed the major risks to which the charity is exposed, in particular those related to the operations and finances of the Trust and are satisfied that systems are in place to mitigate our exposure to the major risks.

The main risk for the charity is the economic uncertainty and to this extent, the Trustees are using investment managers to reduce the level of risk within the investments held. With this in mind, trustees have a risk averse approach to investments, whilst trying to ensure a reasonable level of income into the charity.

Future financial performance and position is likely to be determined by the state of the economy, both in terms of the success and stability of the investments held, as well as the level to which donors feel as though they are able to support the charity. While steps can be taken to manage the risk, the risk still remains and could make it difficult for the charity to achieve its objectives in the short to medium term.

During the year, there was a detailed review of our Investment Policy working alongside our investment managers, Aberdeen Standard. This exercise challenged previous risk appetites and ensured that the updated Investment Policy provided a balance between financial flexibility, financial risk and ethical risk.

Investment Performance

The charity is reporting a gain on investments of £581k which is a gain of 6.6% in the year. This is against a gain of 19.7% (£1,436k gain) in the previous year, which was caused by the recovery from the initial impact of Covid-19 on the financial markets. As a comparison, the FTSE 100 had a gain of 11.6% during 2021/22.

The investments were put into a low risk portfolio. The aim was for the investments to exceed the income available through fixed-term, fixed-yield investments provided by UK High Street banks, whose yield is generally around 1%.

Structure, Governance and Management

Doncaster & Bassetlaw Hospitals NHS Foundation Trust Charitable Funds is a registered charity (number: 1057917). It is governed by its Memorandum & Articles of Association.

The Directors of Doncaster & Bassetlaw Teaching Hospitals NHS Foundation Trust act as de-facto Trustees of the Charity, as the NHS Foundation Trust is the corporate Trustee for the Charity.

When an individual ceases to be a Director of the NHS Foundation Trust, they also cease to be a Trustee of the Charity.

The Charity utilises the opinions of a number of governors and key stakeholders to help in its decision making process. This helps provide additional opinions and perspectives into the decision making process and helps ensure the aims of the Charity are being met. However, these are only advisory roles.

No Trustee received any remuneration from the Charity in the financial year 2021/22 for their role with the Charity, although they do receive remuneration for their role with the Foundation Trust.

Our Plans for the Future:

Covid-19 has had a significant impact on many aspects of the NHS Trust, but one of the most significant impacts has been on the health and wellbeing of staff, which can be seen by the increase in charitable activities around staff activities in 2021/22.

It is felt that this is likely to continue into 2022/23 through various activities around staff wellbeing, which will improve the morale of staff, as well as fulfil the wishes of donors who appreciate the efforts of members of staff.

In 2022/23, the main fundraising efforts centre around the Serenity Suite project. The Serenity Suite project is expected to be a dedicated bereavement suite at Doncaster Royal Infirmary, a mobile ultrasound scanner for the Early Pregnancy Unit (EPAU) at Bassetlaw Hospital and refurbishments to two counselling rooms for services across both sites.



Given the level of reserves that the charity has available to it, there is an increased focus on increasing spend over the next few years and this has meant a refresh of the governance arrangements, so expenditure can be approved quickly, but also in line with appropriate governance procedures.

It is hoped that the operational pressures associated with Covid-19 will continue to ease to ensure there is sufficient management resource to help drive and deliver the increased investment.

Statement of Trustee responsibilities

Under charity law, the Trustees are responsible for preparing the Trustees' annual report and accounts for each financial year which show a true and fair view of the state of affairs of the charity and of the excess of expenditure over income for that period.

In preparing these financial statements, generally accepted accounting practice requires that the Trustees:

- State whether the recommendations of the SORP have been followed, subject to any material departures disclosed and explained in the financial statements

- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue its activities.

The Trustees are required to act in accordance with the trust deed and the rules of the charity, within the framework of trust law. The Trustees are responsible for keeping proper accounting records, sufficient to disclose at any time, with reasonable accuracy, the financial position of the charity at that time, and to enable the Trustees to ensure that, where any statements of accounts are prepared by the Trustees under section 132(1) of the Charities Act 2011, those statements of accounts comply with the requirements of regulations under that provision. The Trustees have general responsibility for taking such steps as are reasonably open to the Trustees to safeguard the assets of the charity and to prevent and detect fraud and other irregularities.

The Trustee confirms that it has met the responsibilities set out above and complied with the requirements for preparing the accounts.

1. Accounting Policies

1.1 Basis of preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014, the Charities Act 2011 and UK Generally Accepted Practice as it applies from 1 January 2016.

The charity constitutes a public benefit entity as defined by FRS 102.

After making enquiries, the Trustee is satisfied that the Charity has adequate resources to continue in operational existence for the foreseeable future therefore there are no material uncertainties over going concern.

The financial statements are prepared on a going concern basis under the historical cost convention, modified to include listed investments at market value.

The financial statements are prepared in sterling which is the functional currency of the charity.

The significant accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all years presented unless otherwise stated.

1.2 Funds

Unrestricted funds are available for use at the discretion of the Trustees in furtherance of the general objectives of the charity and which have not been designated for other purposes. Designated funds comprise unrestricted funds that have been set aside by the trustees for particular purposes.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the charity for particular purposes.

The cost of raising and administering such funds are charged against the specific fund.

1.3 Incoming resources

All incoming resources are included in the statement of financial activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

The charity recognises legacy income when the amount due can be quantified with reasonable probability and the timing of the receipt is known.

1. Accounting Policies (continued)

1.4 Donated goods, facilities and services

Donated facilities and donated time are recognised in income at their fair value when their economic benefit is probable, it can be measured reliably and the charity has control over the item. Fair value is determined on the basis of the value of the gift to the Charity. For example, the amount the charity would be willing to pay in the open market for such facilities and services. It is not felt that this can be reliably measured for the reporting period presented.

Doncaster and Bassetlaw Teaching Hospitals NHS Foundation Trust provides some office accommodation, facilities and administration support to the charity free of charge.

1.5 Use of Volunteers

No amount is included in the financial statements for volunteer time in line with the SORP (FRS 102). Further detail is given in the Trustees' Annual Report.

A notional amount of time is donated by volunteers to assist with fundraising. Periodically, goods are donated to the Charity and are impractical to value.

1.6 Fundraising and Trading Activities

Income from trading activities includes income earned from fundraising events and trading activities to raise funds for the charity. Income is received in exchange for supplying goods and services in order to raise funds and is recognised when entitlement has occurred.

1.7 Investment income

Investment income is earned through holding assets for investment purposes such as shares and gilts. It includes dividends and interest. Where it is not practicable to identify investment management costs incurred within a scheme with reasonable accuracy the investment income is reported net of these costs. It is included when the amount can be measured reliably. Interest income is recognised using the effective interest method and dividend income is recognised as the charity's right to receive payment is established.

The Trustees have considered the most appropriate policy for the investment of funds and decided to invest in a low risk portfolio of stocks, shares and gilts. Investments are stated at market value. The Statement of Financial Activities includes the net gains and losses arising on revaluations and disposals throughout the year.

The main form of financial risk faced by the charity is that of volatility in equity markets and investment markets due to wider economic conditions, the attitude of investors to investment risk, and changes in sentiment concerning equities and within particular sectors or sub sectors.

1.8 Resources expended

All expenditure is accounted for on an accruals basis, except for grants, which are accounted for in the period in which the charity makes a formal commitment to give grant aid.

Resources expended are allocated to the particular activity where the cost relates directly to that activity. The cost of overall direction and overhead costs of the central function are borne by the unrestricted fund.

Notes to the financial statements for the year ended 31 March 2022

1. Accounting Policies (continued)

1.9 Taxation

The Charity is a registered charity, and as such is entitled to certain tax exemptions on income and profits from investments, and surpluses on any trading activities carried on in furtherance of the charity's objectives. Irrecoverable VAT is charged against the category of resources expended for which it was incurred.

1.10 Financial Instruments

Financial assets and financial liabilities which arise from contracts for the purchase or sale of non-financial items are recognised when performance occurs.

1.11 Allocation of overhead and support costs

Due to the small amounts involved, all costs of generating funds have been allocated as governance costs and apportioned across all funds.

1.12 Cost of generating funds

The cost of generating funds is the cost of investment management fees, audit fees and support costs.

1.13 Fundraising Arrangements

The charity has a Corporate Fundraiser, and they are subject to a bonus scheme, depending on the level of income that has been generated, over and above a financial baseline. They are paid by Doncaster & Bassetlaw Healthcare Services Limited, and their costs are recharged back in full to the charity. For 2020/21 and 2021/22, there were no employees who received employee benefits (excluding employer pension costs) of more than £60k.

1.14 Charitable activities

Costs of charitable activities comprise all costs incurred in the pursuit of the charitable objects of the charity. These costs, where not wholly attributable, are apportioned between the categories of charitable expenditure in addition to the direct costs.

1.15 Realised gains and losses

All gains and losses are taken to the Statement of Financial Activities as they arise. Realised gains and losses on investments are calculated as the difference between sales proceeds and opening carrying value (or purchase date if later). Unrealised gains and losses are calculated as the difference between the market value at the end and opening carrying value (or purchase date if later).

1.16 Debtors

Debtors are measured on the basis of amount due less provision for doubtful debt. Debtors include prepayments and accrued income.

1.17 Creditors

Creditors include amounts invoiced to the organisation but not yet paid, along with accrued and committed expenditure.

12 Fund descriptions

Unrestricted funds

These funds are amounts which are not yet designated for a particular project but also where no restriction as to how the funds can be expensed has been placed on the funds by the donor.

Designated funds

The numerous designated funds are projects or fundraising activities being run by the charity where donors can specify the money being donated is for the particular project. These funds are set as to what projects will be run and generally the funds are eligible to be transferred from one to another under the terms of the donations.

Restricted funds

These tend to be a result of one off large donations, regularly from legacies, where the funds are specified to only be spent on a particular type of work. The restrictions do not, usually, restrict the expenditure any further but a close watch is kept as to how these funds are spent and also what opportunities arise to spend the funds on prospective projects.

13 Material Fund Balances

The balance on the Fred & Ann Green Restricted Fund is £6,656k (2020/21: £6,139k)

14 Post balance sheet events

15 Contingent assets

OBJECTIVES AND ACTIVITIES

Our Charitable Objectives

The Aim of the charity is that:

Charitable funds received by the Charity are accepted, held, and administered as funds and property held on trust for purposes relating to the health service in accordance with the National Health Service Act 2006 by the Corporate Trustee, to benefit patient care and advance the good health and welfare of patients, carers and staff.

In reality, this means that the donations received by the Charity are used to enhance the environment for patients and staff, going above and beyond what is normally expected of the NHS.

In setting our objectives and planning our activities, our Trustees have given careful consideration to the Charity Commission's general guidance on public benefit.

Public Benefit – The Trustees confirm that they have complied with the duty in the Charities Act 2011 to have due regard for the Charity Commission's general guidance on public benefit.

Grant Making – Funded projects are decided upon by the Trustees of the Charity in line with the objectives of the Charity. Projects that are funded by the Charity must support and enhance the work of the Trust and not undermine the provision of the NHS.

Strategic Report

Achievements and Performance

Patients' Welfare and Amenities

As a result of the support of donors both in 2020/21 and previously, the charity has been able to support the following projects in the year:

Shuttle Bus service between Mexborough and Doncaster

The free shuttle bus service between the two hospital sites was made possible by the legacy left by Fred & Ann Green a number of years ago. This service connects the two hospital sites, making access to healthcare and in-patient relatives much easier.

By providing free travel between the two sites to allow relatives and loved ones to visit in-patients, this creates opportunities for patients to receive morale-boosting visits, which in turn, aids recovery and reduces length of stay.

The free shuttle bus also allows better access to out-patient appointments at both sites, which improves the health and wellbeing of patients.

Rainbow Gardens

In June 2020, colleagues at Doncaster and Bassetlaw Teaching Hospitals (DBTH) started to fundraise with an ambition to create two beautiful spaces in honour of those affected by COVID-19, in particular colleagues, Kevin Smith, Dr Medhat Atalla and Lorraine Butterfield, who sadly passed away from the illness. With a target of £35,000 set for the project, with the help of almost 300 supporters and donations large and small, in just eight weeks the goal had been met, with over £50,000 raised allowing the work on the gardens spaces to get underway.

Richard Parker OBE, Chief Executive at the Trust said: "The kindness shown to the Trust throughout the pandemic has been truly extraordinary, however the support shown to the creation of a pair of Rainbow Gardens was beyond our expectations and I want to share deep thanks on behalf of everyone at DBTH.



Bassetlaw CT Scanner Artwork

During the year, the Charity has commissioned bespoke artwork to help support patient distraction and enhance the environment using art and design in the in-patient waiting area and scan room. Patients can at times be on a CT scanner for up to thirty minutes for some procedures and it's important they are as relaxed as possible.

Sara Elliott, Head of Radiology at Doncaster and Bassetlaw Teaching Hospitals (DBTH), said, " A CT scan can sometimes take up to 30 minutes, and this wonderful wall art helps to create an interesting, stimulating and comforting distraction for patients while they undergo their procedure. This addition has only been made possible by the kind donations sent to the hospital by our local communities, businesses and organisations."

Staff Welfare and Amenities

It is widely acknowledged that a proportion of donors gifting to the Charity wish for the staff to benefit as much as patients.

Whilst controls are in place to ensure such expenditure is appropriate and in line with NHS values, it is important to acknowledge the hard work that staff perform and go above and beyond for patients on a daily basis.

Some of the items purchased include:

- Training courses allowing staff to develop professionally and personally, beyond their current role.
- Retirement vouchers, as a "thank-you" for spending a substantial length of time providing a service to the people of Doncaster, Worksop and the surrounding areas.
- Office equipment and furnishings, enhancing the staff environment over and above what would normally be expected.

Volunteers and Fundraisers

Our Charity is testament to the generosity of our donors and we are extremely grateful to all who have been involved this year.

The level of support that is received from volunteers and fundraisers is paramount to the Charity and for it to achieve its objectives. Without this, the Charity would not be able to help provide better facilities, provide specialist medical equipment and improve the environment for patients, families and visitors.

It would be impossible to recognise all the volunteers and fundraisers that have supported the Charity in the past, but a selection of donors, and their stories, are as follows:

Captain Tom Appeal / NHS Charities Together

The Captain Tom Appeal captured the imagination and support of the public during the early part of 2020/21, with national fundraising reaching in the region of £38m. This funding was directed to NHS Charities Together, who distributed the money across NHS organisations in a number of different tranches.

The Charity has used the funds received in 2020/21 to fund a "thank you" day at the Yorkshire Wildlife Park for staff and families. Initially planned for Autumn 2020, the event had to be rescheduled for September 2021 as a result of growing clinical pressures due to Covid-19. However, it provided an opportunity for the Trust to thank its hard working members of staff, and Trust Directors personally greeted guests, as well as presented a special "thank you" badge to all staff.



Richard Parker OBE, Chief Executive at the Trust said: "A large number of staff have spent a lot of time away from their families and they themselves have had to deal courageously with additional worries and anxieties of having a loved one fighting this disease on the frontline. We want to recognise these truly heroic contributions during the pandemic, and we thought the Yorkshire Wildlife Park provided the perfect opportunity for this. It is a small gesture, but the least we could do for our amazing team."

Captain Tom Appeal / NHS Charities Together (cont.)

The monies received from the Captain Tom appeal have also been used to help create and develop an in-house BAME Network, with the intention of providing a safe space to talk, share experiences and celebrate and support the variety of cultures within the organisation.



As part of this, in September 2021, the Trust was the first NHS organisation to qualify to use the RACE (Reporting Action Composition Education) Equality Code Quality Mark, following assessment.

The Race Equality Code draws learning and recommendations outlined in reports, charters, and pledges, with the aim of supporting organisations who are actively tackling diversity and inclusion challenges. It was launched in October last year as part of Black History Month 2020 by Dr Karl George MBE and a national steering group of experts in governance and racial inequalities.

Suzy Brain England OBE, Chair of the Board, said: "We are committed to being an inclusive employer, and believe that the RACE Code will support us to deliver the highest standards in recruitment, promotion and the development of our employees. From the work we do with schools (encouraging pupils to look at health careers) and in our recruitment to all roles, and the development of our individuals, we want everyone to achieve their aspirations and employ a workforce that mirrors the diverse communities we serve. We worked closely with Dr George from the very inception of the Code and we are now the first NHS organisation to be accredited, of which I am very proud."

Review of Charity Activities Year ending 31st March 2021

What are our costs?

Charitable Activities: These are costs related to allowing the charity to meet its objectives. These include direct costs and grants of charitable expenditure.

Raising Funds: Costs related to the running of activities designed to raise funds for the Charity. These costs relate to salaries for staff not performing charitable expenditure, IT costs, transactional finance costs and professional fees for the charity such as audit fees.

Reserves

The Charity aims to hold undesignated reserves sufficient to cover three months operational costs. At the year end the charity held restricted funds of £7,511k and unrestricted funds of £1,787k. The funds held outside of restricted funds are sufficient to cover operational costs for at least three months.

Risk Management

The Trustees have assessed the major risks to which the charity is exposed, in particular those related to the operations and finances of the Trust and are satisfied that systems are in place to mitigate our exposure to the major risks.

The main risk for the charity is the economic uncertainty and to this extent, the Trustees are using investment managers to reduce the level of risk within the investments held. With this in mind, trustees have a risk averse approach to investments, whilst trying to ensure a reasonable level of income into the charity.

Future financial performance and position is likely to be determined by the state of the economy, both in terms of the success and stability of the investments held, as well as the level to which donors feel as though they are able to support the charity. While steps can be taken to manage the risk, the risk still remains and could make it difficult for the charity to achieve its objectives in the short to medium term.

During the year, there was a detailed review of the Investment Policy working alongside our investment managers, Aberdeen Standard, This exercise challenged previous risk appetites and ensured that the updated Investment Policy provided a balance between financial flexibility, financial risk and ethical risk.

Investment Performance

The charity is reporting a gain on investments of £1,436k which is a gain of 19.7% in the year as a result of the financial market recovery from the initial impact of Covid-19. This is against a loss of 7.8% (£635k loss) in the previous year, which was caused by the initial impact of Covid-19 on the financial markets. As a comparison, the FTSE 100 had a gain of 18% during 2020/21.

The investments were put into a low risk portfolio. The aim was for the investments to exceed the income available through fixed-term, fixed-yield investments provided by UK High Street banks, whose yield is generally around 1%.

Structure, Governance and Management

Doncaster & Bassetlaw Hospitals NHS Foundation Trust Charitable Funds is a registered charity (number: 1057917). It is governed by its Memorandum & Articles of Association.

The Directors of Doncaster & Bassetlaw Teaching Hospitals NHS Foundation Trust act as de-facto Trustees of the Charity, as the NHS Foundation Trust is the corporate Trustee for the Charity.

When an individual ceases to be a Director of the NHS Foundation Trust, they also cease to be a Trustee of the Charity.

The Charity utilises the opinions of a number of governors and key stakeholders to help in its decision making process. This helps provide additional opinions and perspectives into the decision making process and helps ensure the aims of the Charity are being met. However, these are only advisory roles.

No Trustee received any remuneration from the Charity in the financial year 2020/21 for their role with the Charity, although they do receive remuneration for their role with the Foundation Trust.

Our Plans for the Future:

Covid-19 has had a significant impact on many aspects of the NHS Trust, but one of the most significant impacts has been on the health and wellbeing of staff.

As such, there is to be an increased focus in 2021/22 and beyond on making the working environment better for staff, be it in physical changes such as improved staff facilities, or improved mental health support for staff.

Given the level of reserves that the charity has available to it, there is an increased focus on increasing spend over the next few years and this has meant a refresh of the governance arrangements, so expenditure can be approved quickly, but also in line with appropriate governance procedures.

It is hoped that the operational pressures associated with Covid-19 will ease to ensure there is sufficient management resource to help drive and deliver the increased investment.

Statement of Trustee responsibilities

- State whether the recommendations of the SORP have been followed, subject to any material departures disclosed and explained in the financial statements
- State whether the financial statements comply with the trust deed, subject to any material departures disclosed and explained in the financial statements
- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue its activities.

The Trustees are required to act in accordance with the trust deed and the rules of the charity, within the framework of trust law. The Trustees are responsible for keeping proper accounting records, sufficient to disclose at any time, with reasonable accuracy, the financial position of the charity at that time, and to enable the Trustees to ensure that, where any statements of accounts are prepared by the Trustees under section 132(1) of the Charities Act 2011, those statements of accounts comply with the requirements of regulations under that provision. The Trustees have general responsibility for taking such steps as are reasonably open to the Trustees to safeguard the assets of the charity and to prevent and detect fraud and other irregularities.

The Trustee confirms that it has met the responsibilities set out above and complied with the requirements for preparing the accounts.

Opinion

Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

Explanation as to what extent the audit was considered capable of detecting irregularities, including fraud

Irregularities, including fraud, are instances of non-compliance with laws and regulations. We design procedures in line with our responsibilities, outlined above, to detect irregularities, including fraud. The risk of not detecting a material misstatement due to fraud is higher than the risk of not detecting one resulting from error, as fraud may involve deliberate concealment by, for example, forgery or intentional misrepresentations, or through collusion. • We assessed the susceptibility of the charity's financial statements to material misstatement, including how fraud might occur by understanding the potential incentives and pressures for management to manipulate the financial statements, and performed procedures to understand the areas in which this would most likely arise. Based on our risk assessment procedures, we identified manipulation of reported financial performance through improper recognition of revenue, and management override of controls to be our fraud risks.


• Based on this understanding we designed our audit procedures to identify noncompliance with such laws and regulations. Our procedures involved:

1. Accounting Policies

1.1 Basis of preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014, the Charities Act 2011 and UK Generally Accepted Practice as it applies from 1 January 2016.

The charity constitutes a public benefit entity as defined by FRS 102.

After making enquiries, the Trustee is satisfied that the Charity has adequate resources to continue in operational existence for the foreseeable future therefore there are no material uncertainties over going concern.

The financial statements are prepared on a going concern basis under the historical cost convention, modified to include listed investments at market value.

The financial statements are prepared in sterling which is the functional currency of the charity.

The significant accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all years presented unless otherwise stated.

1.2 Funds

Unrestricted funds are available for use at the discretion of the Trustees in furtherance of the general objectives of the charity and which have not been designated for other purposes. Designated funds comprise unrestricted funds that have been set aside by the trustees for particular purposes.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the charity for particular purposes.

The cost of raising and administering such funds are charged against the specific fund.

1.3 Incoming resources

All incoming resources are included in the statement of financial activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

The charity recognises legacy income when the amount due can be quantified with reasonable probability and the timing of the receipt is known.

1.4 Donated goods, facilities and services

Donated facilities and donated time are recognised in income at their fair value when their economic benefit is probable, it can be measured reliably and the charity has control over the item. Fair value is determined on the basis of the value of the gift to the Charity. For example, the amount the charity would be willing to pay in the open market for such facilities and services. It is not felt that this can be reliably measured for the reporting period presented.

Doncaster and Bassetlaw Teaching Hospitals NHS Foundation Trust provides some office accommodation, facilities and administration support to the charity free of charge.

1.5 Use of Volunteers

No amount is included in the financial statements for volunteer time in line with the SORP (FRS 102). Further detail is given in the Trustees' Annual Report.

A notional amount of time is donated by volunteers to assist with fundraising. Periodically, goods are donated to the Charity and are impractical to value.

1.6 Fundraising and Trading Activities

Income from trading activities includes income earned from fundraising events and trading activities to raise funds for the charity. Income is received in exchange for supplying goods and services in order to raise funds and is recognised when entitlement has occurred.

1.7 Investment income

Investment income is earned through holding assets for investment purposes such as shares and gilts. It includes dividends and interest. Where it is not practicable to identify investment management costs incurred within a scheme with reasonable accuracy the investment income is reported net of these costs. It is included when the amount can be measured reliably. Interest income is recognised using the effective interest method and dividend income is recognised as the charity's right to receive payment is established.

The Trustees have considered the most appropriate policy for the investment of funds and decided to invest in a low risk portfolio of stocks, shares and gilts. Investments are stated at market value. The Statement of Financial Activities includes the net gains and losses arising on revaluations and disposals throughout the year.

The main form of financial risk faced by the charity is that of volatility in equity markets and investment markets due to wider economic conditions, the attitude of investors to investment risk, and changes in sentiment concerning equities and within particular sectors or sub sectors.

1.8 Resources expended

All expenditure is accounted for on an accruals basis, except for grants, which are accounted for in the period in which the charity makes a formal commitment to give grant aid.

Resources expended are allocated to the particular activity where the cost relates directly to that activity. The cost of overall direction and overhead costs of the central function are borne by the unrestricted fund.

1. Accounting Policies (continued)

1.9 Taxation

The Charity is a registered charity, and as such is entitled to certain tax exemptions on income and profits from investments, and surpluses on any trading activities carried on in furtherance of the charity's objectives.

Irrecoverable VAT is charged against the category of resources expended for which it was incurred.

1.10 Financial Instruments

Financial assets and financial liabilities which arise from contracts for the purchase or sale of non-financial items are recognised when performance occurs.

1.11 Allocation of overhead and support costs

Due to the small amounts involved, all costs of generating funds have been allocated as governance costs and apportioned across all funds.

1.12 Cost of generating funds

The cost of generating funds is the cost of investment management fees, audit fees and support costs.

1.13 Charitable activities

Costs of charitable activities comprise all costs incurred in the pursuit of the charitable objects of the charity. These costs, where not wholly attributable, are apportioned between the categories of charitable expenditure in addition to the direct costs.

1.14 Realised gains and losses

All gains and losses are taken to the Statement of Financial Activities as they arise. Realised gains and losses on investments are calculated as the difference between sales proceeds and opening carrying value (or purchase date if later). Unrealised gains and losses are calculated as the difference between the market value at the end and opening carrying value (or purchase date if later)

1.16 Debtors

Debtors are measured on the basis of amount due less provision for doubtful debt. Debtors include prepayments and accrued income.

1.17 Creditors

Creditors include amounts invoiced to the organisation but not yet paid, along with accrued and committed expenditure.

12 Fund descriptions

Unrestricted funds

These funds are amounts which are not yet designated for a particular project but also where no restriction as to how the funds can be expensed has been placed on the funds by the donor.

Designated funds

The numerous designated funds are projects or fundraising activities being run by the charity where donors can specify the money being donated is for the particular project. These funds are set as to what projects will be run and generally the funds are eligible to be transferred from one to another under the terms of the donations.

Restricted funds

These tend to be a result of one off large donations, regularly from legacies, where the funds are specified to only be spent on a particular type of work. The restrictions do not, usually, restrict the expenditure any further but a close watch is kept as to how these funds are spent and also what opportunities arise to spend the funds on prospective projects.

13 Material Fund Balances

The balance on the Fred & Ann Green Restricted Fund is £5,227k (2019/20: £5,195k)

14 Post balance sheet events

There are no post balance sheet events having a material effect on the financial statements.

15 Contingent assets

The charity recognises legacy income when it has received notification of the legacy and has sufficient certainty regarding the amount of the receipt. Where there is uncertainty over the amount of the legacy that will be received, income is not recognised until the estate has been finalised by its executors.
