ANNUAL REPORT OF THE COUNCIL OF MANAGEMENT YEAR ENDED 31 MARCH 2025

The council of management have the pleasure of presenting their report and the audited accounts of the charity for the year ended 31 March 2025.

The legal and administrative information set out on page 11 forms part of this report. The financial statements comply with current statutory requirements, the Articles of Association and the Statement of Recommended Practice - Accounting and Reporting by Charities 2005 (Revised 2008).

INTRODUCTION

The charity was incorporated on the 5th May 1995 as a company limited by guarantee and not having a share capital. The company was registered as a charity on 16 September 1996.

OBJECTIVES

The objects for which the charity is established are:

- The advancement of the Christian faith by the proclamation and furtherance of the gospel of God.
- The promotion of the worship of God by any means whatsoever, including the preaching and proclamation of the Christian gospel; the teaching of Christian doctrine and principles; and the printing, production and distribution of Christian literature, media products and other resources.
- The relief of persons in conditions of financial need, or of those persons who are infirm for reasons of old age or sickness.
- The advancement of education on the basis of Christian principles, including the provision of educational establishments, materials and bursaries for the general education of children or adults on the basis of such Christian principles.

ACHIEVEMENTS AND PERFORMANCE

Our objectives are based upon three Charitable Purposes, which are described in the Charities Act 2006 and are for public benefit:

- The advancement of religion.
- The prevention or relief of poverty.
- The advancement of education.

The total spent on charitable activities throughout the course of 2024/25 was £1,409,031. The following provides further information on how funds were spent to support our charitable activities.

The Advancement of Religion

- The provision of suitable facilities for church administration, church meetings, and storage of equipment as well as facilities for children's/youth work, Christian training programmes and community outreach programmes.
- A large proportion of our pastoral care costs are the salaries of our Congregational Pastors who provide pastoral support, mentoring and ministerial services (such as hospital visitation) to people who attend our congregations. It is not only paid pastoral staff providing pastoral care, but a large number of volunteers who work as part of our pastoral support team or as Connect group leaders.
- Providing effective administrative support, business management, and financial systems to ensure the aims of the charity are achieved. Such expenditure covers staff salaries, IT equipment, office equipment, financial systems, training, printing, consumables, safeguarding admin, etc. This is necessary to provide a stable operational base for the charity and enables us to carry out our charitable activities in an efficient, safe and lawful manner.
- Leaders are appointed to ensure that the aims of the charity are achieved through our activities. Our costs include the salaries of our Senior and Executive Pastors, who provide vision and direction to the church as a whole. Expenditure also includes the provision of training and support for leaders and other staff.
- Our church congregations worship together and grow in their faith. We are continually investing in our sound, media and lighting equipment, as well as providing logistical solutions for moving equipment to and from venues to support this.
- Family Church brings people together from a wide variety of social and cultural backgrounds. Our church congregations are culturally diverse, and we work hard to provide activities that appeal to people from all walks of life. Many of the activities we organise have an income through additional donations, contributing to the cost of the event.
- We have youth groups running in Portsmouth, Gosport, Havant & Waterlooville, and Waterside, which provide a wide variety of fun, social and spiritual activities for young people throughout the year. All these groups provide positive opportunities and introduce Christian values to children and young people.
- FORGE is a three-year ministry school that provides opportunities for life-shaping encounters with God, preparing disciples for kingdom living and for the work of the ministry. FORGE launched in September 2022 and runs on a Monday evening from the Empower Centre Portsmouth and follows the academic calendar.
- We distribute books, Bibles, a range of audio and video media and other resources to people attending our meetings and courses. All audio and video recordings produced by Family Church are made publicly available, free of charge, via our website and app.
- We are involved in many initiatives in our communities where our first aim is to show kindness to local people, and as we do this, we often have the opportunity to share how the Christian faith can have a positive impact in people's lives.

- We provide advertising, information and training to our church members and the wider community. Our activities have a greater chance of success with the right marketing; church members need up-to-date information in order to support our wide variety of activities, and training materials need to be provided if we are to expect people to make a positive contribution to our charitable work.
- Our children's programme provides a fun and safe environment for children where they are taught Christian values appropriate to their age and level of understanding.
- We utilise support from other organisations to enable us to work more effectively for the public benefit.
- We hold marriage preparation and enrichment courses and conduct wedding ceremonies, as well as funerals and baby dedications.

The Prevention or Relief of Poverty

- We have an ongoing relationship with a number of churches and other organisations that work to prevent and relieve poverty. We supported charities working in Zambia, Angola, Moldova, and Ecuador, as well as supporting our own Family Church congregations and missionaries in the Philippines.
- We supported several individuals who were in financial need and provided assistance to those in crisis situations. This has involved assisting with rent payments, providing emergency loans, and purchasing necessary items of furniture and white goods etc.
- We provided emergency food hampers to those who do not have basic provisions because of financial hardship. We currently operate our Community Food Support programme in two locations (Portsmouth and Gosport), receiving referrals from local agencies such as YouTrust and local Housing Offices.
- We run a franchise of Baby Basics in Portsmouth, providing hampers to expectant/new mothers with provisions for mother and baby, usually taking the form of a Moses Basket full of nappies, wipes, feeding items, high chairs, cots, bedding, pushchairs, clothes, toys, small furnishings, etc. Referrals come from local healthcare professionals.
- We have also contributed to good mental and physical health through our pastoral care. This has included many home, care home and hospital visits by our pastors and dedicated volunteers who serve in our pastoral support teams.

The Advancement of Education

We contribute to the spiritual and moral education of children and young people through many of our activities, including our Sunday morning services and Trailblazers youth groups.

We ran Messy Church in Portsmouth and community kids' events at Easter and Christmas.

We engaged with the Assemblies of God Young Lions and Young Lions Juniors programmes, which saw children and young people attend weekend events to further unlock and develop their leadership skills even at a young age.

Family Church Global Outreach

We seek to support charitable work overseas. In the last year, we have made financial contributions to charities in many poverty-stricken nations. Our support currently extends to Overland Missions (Zambia, Angola, and Egypt), Stella's Voice (Moldova), Verdad Viviente Christian Church (Ecuador), as well as Family Church Makati in Manila, Philippines. We also provide regular support to a number of missionaries (individuals and families) who work with organisations in other countries that provide relief to those in poverty and share the Christian message.

We stay connected through newsletters, emails and video calls. We also hold an annual 'Global Sunday' in each of our Family Church congregations, where we showcase the organisations and missionaries that we support so that people can see what is achieved through the financial support that is provided by Empower Global.

VOLUNTEERS

The Trustees recognise the importance of our volunteers. Worship services and community projects wouldn't be possible without the commitment of our volunteer workforce. Volunteers exist at every level of the organisation, and we're working to ensure they are managed as effectively as our paid staff.

PRINCIPAL RISKS AND UNCERTAINTIES

As Empower Global is primarily funded by the generosity of Church members, the Trustees recognise that the recent and ongoing increase in the cost of living has the potential to impact heavily on the income of the charity, and, therefore, its ability to carry out its objectives. A reserves policy, along with monthly and quarterly reviews of financial reports, helps to manage this risk. As a public-facing organisation with regular open-door events, Empower Global carries out risk management training with relevant staff to ensure effective assessments are carried out. The charity employs a full-time Business Manager who is delegated the oversight of Health and Safety across the organisation and is also responsible for sourcing and maintaining suitable insurance cover. Safeguarding is woven into the fabric of the organisation through the use of safer recruitment practices, robust policies which are regularly reviewed and updated, and appropriate training for staff, volunteers, leaders, safeguarding leads and trustees.

PREMISES

Portsmouth

The Empower Centre Portsmouth (83-87 Kingstons Road, Portsmouth, PO2 7DX) continues to be the headquarters of Empower Global and Family Church. As well as being the venue for our smaller gatherings and meetings, the premises help facilitate the rapidly expanding work of our community teams.

Gosport

The Empower Centre Gosport (Layton Road, Bridgemark, PO13 0JQ) has continued to serve the congregation and local community through the ongoing work of the pastoral and community teams.

Havant & Waterlooville

The Empower Centre Havant provides a warm and inviting space for both church gatherings and community events. The Waterlooville congregation continues to make use of the local Community Centre.

Waterside

The lease of 19A The Marsh, Hythe, Southampton, ends at the end of November 2025, following acceptance of our offer to purchase St Francis Church in Langley, Southampton. This will become the new Empower Centre Waterside, where all services and midweek gatherings will take place. The acquisition of this building is exciting and opens the door to building lasting relationships with the local community. The congregation is set to move in January 2026.

PRINCIPAL FUNDING SOURCES

Funding for Empower Global comes principally from the donations of those who attend Family Church. Additional donations come from individuals who do not attend Family Church, but who wish to support our charitable work (particularly our community projects and overseas work). The charity does not use a professional fundraiser, but employs a bid writer. No complaints have been received in relation to fundraising.

Individuals who attend Family Church make regular financial donations to support the work of the charity and donors are encouraged to sign a Gift Aid declaration in order to maximise their giving.

Empower Global has been the grateful recipient of several grants made by local authorities and businesses seeking to support our community work.

RELATIONSHIPS WITH OUR LOCAL COMMUNITIES

All of our congregations are part of their local community. We are pleased to be able to invest in events and projects that serve the people in those communities and strengthen the relationships we've formed.

In Portsmouth, we continue to offer our Tots and Toys group that runs on Monday mornings during term time. Messy Church runs on the third Wednesday of the month. At Christmas, our team provide Christmas hampers to local families in need. This includes a traditional Christmas dinner, gifts for all the family and a bag of treats.

Across the year, the Community Food Support programme provided food parcels to families across Portsmouth and Gosport. This was made possible by the ongoing support of Portsmouth City Council, several businesses and the kind generosity of our community. Our referring bodies include local schools, Health Visitors, Social Workers, Advice Portsmouth and Citizens Advice, among others.

FINANCIAL REVIEW

On a monthly basis, the finance team produces management reports showing the performance of each of our church congregations as well as the charity as a whole. Our accounting structure is based on an accrual system to allow us better opportunities to manage the finances more effectively, whilst maintaining strict controls over spending so that the charity's resources are used sensibly and efficiently. Budgets are regularly reviewed and amended in line with our financial position.

At the end of March 2025, total funds stand at £1,239,989 (2024: £1,278,582), of which £429,520 are general funds (2024: £381,517), £630,733 are funds designated by the trustees for various uses (2024: £639,801), and £179,736 are restricted funds (2024: £257,264). The trustees note the significant reduction in funds at the close of the financial year, largely due to the significant amount of Baby Basics stock that has been distributed throughout the year.

None of the Directors/Trustees were paid during this period. No individual member of staff is in receipt of a stipend/salary in excess of £60,000, including all payments relating to the provision of a suitable manse, where appropriate.

Reserves Policy

The current policy requires the equivalent of 8 weeks of expenditure to remain in reserves, and the Church has long held a healthy surplus to this requirement. This is reviewed annually and in line with any stipulation from our mortgage provider, Kingdom Bank.

INVESTMENT POWERS AND RESTRICTIONS

The charity is authorised to invest the monies of the charity not immediately required for its purposes, in or upon such investments or property as may be thought fit, subject to such conditions as may be imposed or required by law and subject as provided by the Articles of Association.

PLANS FOR THE FUTURE

Growth of Family Church

We will continue to help Christians grow in their faith through a wide variety of initiatives. This includes providing meaningful worship services and effective Bible teaching; running appropriate courses to equip Christians in their daily lives; helping Christians to develop mutually supportive friendships through small group activities; providing opportunities to get involved in the charity's community and global outreach; and training and supporting church leaders.

We want to have a positive impact on our communities and will continue to provide services to our local communities, networking with other organisations wherever possible. Through the work we do in our local communities, we hope people will realise the positive impact that the Christian faith can have on their lives. We encourage people who attend Family Church to share their faith with others. For this reason, we expect the number of people attending the congregations of Family Church to grow.

Leadership

After nearly 28 years of pioneering and leading Family Church, Andy & Gina Elmes will be stepping down from their role as Senior Pastors at the end of January 2026, and handing the leadership of Family Church to Steuart and Carla Payne.

This is a significant moment in the journey of the church, filled with emotion, reflection, and anticipation. We are confident that this next chapter will be filled with fresh vision, strength, and fruitfulness under Steuart & Carla's leadership, called by God to lead Family Church into its next chapter. The trustees are confident in their leadership and excited about the next season, whilst recognising the legacy left by Pastors Andy & Gina and all that they have sown into the organisation.

Multi-Congregational Church

In support of our desire to provide local communities with a place of worship reflecting the style and values of Family Church, we launched a new congregation in Southsea in October 2024. This involved a large commitment from the Portsmouth congregation, and we saw church members stepping up to take on new voluntary roles. As we equip and send people from Family Church to open new congregations, we provide numerous opportunities for church members to be involved in Christian ministry.

Alongside the numerical growth of our congregations, we are continuing to increase the number of small groups that run during the week. Our *Connect Groups* help to maintain meaningful friendships amongst individuals who are part of our wider church community.

As a member of the Assemblies of God Great Britain, we support the drive to see more Churches planted across the country and are considering how best we can facilitate this.

Community Projects

We will continue to work in our communities, aiming to develop our community and outreach programmes. We will continue to use our buildings in Portsmouth, Gosport, Havant, and Waterside to run activities and projects that enrich our communities, as well as hire local facilities when needed.

Through Family Church Global Outreach and Overland Missions, we will continue supporting overseas mission projects and individuals involved in relief work throughout the world.

Suitable Premises for all Congregations

For the long-term stability of the charity, we are committed to the acquisition and development of premises for all of our congregations, starting with a local 'hub' for each congregation and moving toward premises that provide enough auditorium space for Sunday services. Our recent Empower Centre Waterside project is a great example of this in action.

THE COUNCIL OF MANAGEMENT

The Charity is managed by the Council of Management, which is also known as our board of Trustees. There are 23 paid employees, of which 9 are full-time (6 Pastoral, 2 Operational, 1 Facilities) and 14 part-time (4 Pastoral, 7 Operational and 3 Facilities) as of 31 March 2025, engaged in carrying out the Charity's objectives. They are assisted and supported by a large number of volunteer workers.

The Council of Management has implemented a risk management strategy which reviews, on an annual basis, the risks that the charity may face. Systems and procedures are designed to manage the risks identified and to minimise the potential impact on the charity should any of these risks materialise.

The Trustees delegate the day-to-day running of the charity to the Senior Leaders and Managers. The Trustees commissioned the creation of a Governance Health Policy, which is intended to clarify responsibilities and decision-making abilities within the management of the charity. Currently, Trustees are involved in decisions that have a lasting financial impact. Examples include the creation of new paid roles and the sale or purchase of property. The Trustees hold ultimate responsibility for decisions on salaries and pay reviews. They are responsible for the salaries of senior members of staff.

RECRUITMENT AND APPOINTMENT OF THE COUNCIL OF MANAGEMENT

The Council of Management of Empower Global takes seriously the recruitment and appointment of members of the Council. Potential trustees are recruited on the basis of their existing interest and involvement in the charity and the skills and experience they add to the Council. Trustees are appointed by the Council of Management through election in accordance with the Articles of Association. Three new Trustees were appointed to the board early in the financial year.

TRUSTEES' RESPONSIBILITIES

The Trustees are responsible for preparing the Annual Report and the financial statements in accordance with applicable law and United Kingdom Generally Accepted Accounting Practice (UK GAAP). Company law requires the Directors to prepare for each financial year, financial statements, which give a true and fair view of the state of affairs of the company and of the surplus or deficit for that period. In preparing those accounts, the Directors are required to:

- select suitable accounting policies and then apply them consistently;
- make judgements and estimates that are reasonable and prudent;
- state whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the accounts;
- prepare the accounts on the going concern basis unless it is inappropriate to presume that the company will continue in operation.

The Directors are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the company and to enable them to ensure that the accounts comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

As far as the Directors are aware, there is no relevant audit information of which the auditors are unaware. Each Director has taken all the steps that they ought to have taken as a Director in order to make themselves aware of any relevant audit information and to establish that the company's auditors are aware of that information.

This report has been prepared in accordance with the special provisions for small companies under Part 15 of the Companies Act 2006, and in accordance with the Statement of Recommended Practice - Accounting and Reporting by Charities (effective 2019).

INDEPENDENT AUDITORS' REPORT TO THE MEMBERS OF EMPOWER GLOBAL

(Company limited by guarantee and not having a share capital)

We have audited the financial statements of Empower Global for the year ended 31 March 2025, which comprise the Statement of Financial Activities, Balance Sheet, Cash flow Statement and the related notes. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards including Financial Reporting Standard 102: The Financial Reporting Standard applicable to the UK and Republic of Ireland (United Kingdom Generally Accepted Accounting Practice).

In our opinion, the financial statements:

- give a true and fair view of the state of the charitable company's affairs as at 31 March 2025, and of its income and expenditure for the year ended;
- have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice; and

Based on the work we have performed, we have not identified any material uncertainties relating to events or conditions that, individually or collectively, may cast significant doubt on the charitable company's ability to continue as a going concern for a period of at least 12 months from when the financial statements are authorised for issue.

Other information

The trustees are responsible for the other information. The other information comprises the information included in the annual report other than the financial statements and our auditor's report thereon. Our opinion on the financial statements does not cover the other information and, except to the extent otherwise explicitly stated in our report, we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If we identify such material inconsistencies or apparent material misstatements, we are required to determine whether there is a material misstatement in the financial statements or a material misstatement of the other information. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact.

Opinions on other matters prescribed by the Companies Act 2006

In our opinion, based on the work undertaken in the course of the audit:

- the information given in the trustees' report for the financial year for which the financial statements are prepared is consistent with the financial statements; and
- the trustees' report has been prepared in accordance with applicable legal requirements.

Matters on which we are required to report by exception

We have nothing to report in respect of the following matters in relation to which the Companies Act 2006 and the Charities (Accounts and Reports) Regulations 2008 require us to report to you if, in our opinion:

- adequate accounting records have not been kept or returns adequate for our audit have not been received from branches not visited by us;
- the financial statements are not in agreement with the accounting records and returns;
- certain disclosures of trustees' remuneration specified by law are not made;
- we have not received all the information and explanations we require for the purposes of our audit; or
- the trustees were not entitled to prepare the financial statements in accordance with the small companies regime and take advantage of the small companies exemption in preparing the Trustees' Annual Report and take advantage of the small companies exemption from the requirement to prepare a strategic report.

Responsibilities of the trustees

As explained more fully in the trustees' responsibilities statement, set out on page 16, the trustees are responsible for the preparation of the financial statements and for being satisfied that they give a true and fair view, and for such internal control as they determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the trustees are responsible for assessing the charitable company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the trustees either intend to liquidate the charitable company or to cease operations, or have no realistic alternative but to do so.

Our responsibilities for the audit of the financial statements

We have been appointed as auditor under Companies Act 2006 and report in accordance with the Act and relevant regulations made or having effect thereunder.

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs (UK) will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

Irregularities, including fraud, are instances of non-compliance with laws and regulations. We design procedures in line with our responsibilities, outlined above, to detect material misstatements in respect of irregularities, including fraud. The extent to which our procedures are capable of detecting irregularities, including fraud is detailed below:

The engagement partner ensured that the engagement team collectively had the appropriate competence, capabilities and skills to identify or recognise non-compliance with applicable laws and regulations.

We identified the laws and regulations applicable to the charitable company through discussions with trustees and other management and we assessed the extent of compliance with the laws and regulations identified above through making enquiries of management and inspecting legal correspondence.

INDEPENDENT AUDITORS' REPORT TO THE MEMBERS OF EMPOWER GLOBAL

We assessed the susceptibility of the charitable company's financial statements to material misstatement, including obtaining an understanding of how fraud might occur, by making enquiries of management as to where they considered there was susceptibility to fraud, their knowledge of actual, suspected and alleged fraud and considering the internal controls in place to mitigate risks of fraud and non-compliance with laws and regulations.

To address the risk of fraud through management bias and override of controls, we performed analytical procedures to identify any unusual or unexpected relationships, tested journal entries to identify unusual transactions and investigated the rationale behind significant or unusual transactions.

In response to the risk of irregularities and non-compliance with laws and regulations, we designed procedures which included, but were not limited to:

- agreeing financial statement disclosures to underlying supporting documentation;
- reading the minutes of meetings of those charged with governance; and
- enquiring of management as to actual and potential litigation and claims.

There are inherent limitations in our audit procedures described above. The more removed that laws and regulations are from financial transactions, the less likely it is that we would become aware of non-compliance. Auditing standards also limit the audit procedures required to identify non-compliance with laws and regulations to enquiry of the trustees and other management and the inspection of regulatory and legal correspondence, if any.

Material misstatements that arise due to fraud can be harder to detect than those that arise from error as they may involve deliberate concealment or collusion.

1 ACCOUNTING POLICIES

a) Basis of accounting

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the FRS 102 (effective January 2019) and the Companies Act 2006.

The charity meets the definition of the public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note.

The accounts have been prepared on the going concern basis. There are no material uncertainties about the charity's ability to continue.

b) Income

All income is included in the Statement of Financial Activities when the charitable company is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

- Donations and legacies are received by way of donations and are included in full in the Statement of Financial Activities when receivable.
Grants (including government grants), when entitlement is not conditional on the delivery of a specific performance by the charity, are recognised when the charity becomes unconditionally entitled to the grant.
- Investment income is included when receivable.
- Trading income is accounted for when earned.
- Donated items for distribution are stated at fair value.

c) Expenditure

Expenditure is recognised on an accruals basis as a liability is incurred. It includes any VAT and is reported as part of the expenditure to which it relates:

- Charitable expenditure comprises of those costs incurred by the charitable company in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.
- All costs are allocated between the expenditure categories of the Statement of Financial Activities on a basis designed to reflect the use of the resource. Costs relating to a particular activity are allocated directly.

d) Tangible fixed assets

Tangible fixed assets are included in the accounts at cost, with items over £1,000 being capitalised.

Depreciation is provided on fixed assets (with the exception of land) to spread the cost over the estimated useful lives of the relevant assets at the following rates:

Motor vehicles	25% reducing balance
Fixtures and equipment	20% straight line
Computer equipment	3 years straight line
Buildings	2% straight line
Building improvements	2% straight line and 20% straight line

e) Stocks

Stocks held at the year end for distribution are stated at fair value, ie an approximation to their shop cost or a discounted amount where appropriate (for example second hand items).

f) Leases

Rentals paid under operating leases are charged to the Statement of Financial Activities on a straight-line basis over the lease term.

g) Pension contributions

The charitable company participates in a defined contribution pension scheme. Contributions are charged to the Statement of Financial Activities for the year in which they are payable to the scheme. The assets of the scheme are held and managed separately from those of the charitable company.

h) Fund accounting

Funds held by the charitable company are either:

Unrestricted general funds	Funds which can be used in accordance with the charitable objects at the discretion of the trustees.
Designated funds	Funds set aside by the trustees out of unrestricted general funds for specific future purposes or projects, or reflecting investment in property.
Restricted funds	Funds that can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

2 LEGAL STATUS OF THE CHARITY

The charitable company was incorporated on 5 May 1995 in England and Wales and was registered on 26 September 1996 with the Charity Commission in England and Wales. The charity is a public benefit entity.

The registered office of the charity is The Empower Centre, 83-87 Kingston Road, Portsmouth, Hampshire, PO2 7DX.

The charitable company is limited by guarantee and has no share capital. The liability of each member in the event of winding-up is limited to £1.

Church Growth and Vision Fund

Each Family Church congregation raises funds periodically towards the continued growth of the church. These donations are used for resourcing specific community outreach projects, for purchasing equipment, and for activities that facilitate growth. 10% of funds raised by each congregation are directed toward the national growth fund for projects that impact the whole church rather than a specific congregation.

Family Church Global Outreach

Members of Family Church can donate money specifically to overseas missions that the church supports. Such donations are allocated to the Family Church Global Outreach Fund which is used to support the work of organisations throughout the world in the relief of persons in conditions of financial need and to assist in their care. Where monthly costs exceed the amount raised through restricted donations, unrestricted funds are released to offset the balance.

Food Support

Members of Family Church can donate money to Food Support, the department of Family Church that provides social welfare to local communities. Such donations are allocated to this fund and used primarily for the provision of food and other essential items to local people. Where costs exceed the amount raised through restricted donations, unrestricted funds are released to offset the balance. This fund also includes the value of donations in kind. (NB this project was previously called "Caring Hands.")

Baby Basics

Members of Family Church can donate money to Baby Basics, a department of Family Church that provides social welfare to local communities. Such donations are allocated to this fund and used primarily for the provision of essential baby related items to local families. Where costs exceed the amount raised through restricted donations, unrestricted funds are released to offset the balance. This fund also includes the value of donations in kind.

Community

A fund for various community projects, mainly covered by external grants.

Community Funday

The Management Team set aside unrestricted funds for annual Community Fun Days. These funds, in addition to restricted grants that are provided by other organisations, are used to cover the costs of running these community events. These funds are temporary by nature and do not accumulate balances. Where event costs exceed the amount raised through the designated funds and the restricted grants, unrestricted funds are released to offset the balance.

Household Support Fund

This is a restricted fund in our Portsmouth congregation with funds provided by a grant from Portsmouth City Council for use on buying baby supplies and food for the needy.

SEN

Connect4Communities

This is a restricted fund in our Gosport congregation with funds provided by grants from Hampshire County Council, specifically for supporting those in the community with emergency food and other essential items.

Youth Trailblazers

'Youth Trailblazers' is the youth ministry of Family Church (formerly Momentum). It has undertaken fund raising and received donations to help fund the cost of equipment and youth activities generally.

Ladies Ministry

The ladies ministry of Family Church runs events throughout the year, including breakfasts, retreats and conferences.

One Body Coordinator

The One Body restricted fund is made up of donations from local churches and charities that are funding the role of 'One Body Coordinator' over a period of two years. This individual contracted for this role serves the local churches of Portsmouth by coordinating meetings and encouraging networking.

Southsea Benefact

A grant from Benefact Trust for the first six months of hire of Portsmouth Grammar School for Sunday services.

16 RELATED PARTY TRANSACTIONS
