### **Independent examiner's report to the trustees on the financial statements of The D'Almeida Charitable Trust.**

I report on the financial statements of The D'Almeida Charitable Trust for the year ended 31 December 2021 which comprise the statement of financial activities and the statement of assets and liabilities.

#### **Respective responsibilities of trustees and examiner**

As the charity's trustees you are responsible for the preparation of the accounts, you consider that the audit is not required for this year under section 144 of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed.

#### **Basis of independent examiner's report**

It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from you as trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

#### **Independent examiner's statement**


In connection with my examination, no matter has come to my attention:


