REPORT OF THE TRUSTEES FOR THE YEAR ENDED 30 SEPTEMBER 2021

The trustees present their report with the financial statements of the charity for the year ended 30 September 2021. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

The charity objectives are as follows:

- 1) To advance for the benefit of the public the education of young persons, including pupils at schools, universities, or other centres of education principally for the inhabitants of the neighbourhood (the area of benefit), by ensuring that due attention is given to the physical education of such persons, as well as to the development and the education of such persons to participate in gymnastics and dance.
- 2) To provide or assist in the organisation or provision of facilities for physical recreation in the interests of social welfare in any part of the area of benefit with the objective of improving the conditions of life for such persons who are under the age of 25 and who by reason of their youth and social and economic circumstances have need for such facilities as provided in the Recreational Charities Act 1958.

Public benefit

The Trustees have consulted the guidance made available by the Charity Commission for England and Wales on the Public Benefit requirement of the Charities Act 2011. The Trustees are confident that they have complied with their duty under section 4 of the Charities Act 2011 in that they have had due regard to public benefit guidance published by the Commission.

ACHIEVEMENT AND PERFORMANCE

Charitable activities

During the year, the charity has received grants following national and local lockdowns as a result of covid. In order to continue the provision of the charity's objectives, the charity has made a donation of £51,909 to Europa Gym Centre CIC, to allow the centre to continue as a CIC for the benefit of the public.

FINANCIAL REVIEW

Financial position

During the year, the charity received grants of £45,121 from the Local Authority and made subsequent donations to Europa Gym Centre CIC of £51,909 to assist with the continued running of the Gymnastics Centre during a difficult period, following Covid and lockdowns.

During the year, the Charity received a donation of £1,000 from Europa Gym Centre CIC and the CIC also confirmed that previous support costs of £3,463 paid by them, would not be recovered.

Reserves policy

The Charity manages its reserves policy to allow any surplus to be donated to Europa Gym Centre CIC, to allow the continuance of the CIC, for the benefit of the users of the facility and the public.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its governing document, a deed of trust and constitutes an unincorporated charity.

Charity constitution

The Charity Constitution was adopted by a Trust Deed on 29 February 1996.

As the charity trustees of the Trust you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ('the Act').





1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.
