Structure, governance and management

Governing document

The charity is registered with the Charity Commission in England and Wales under number 1059070 and is constituted under a Trust deed dated 16 October 1996.

Organisational structure

The management of the charity is the responsibility of the trustees who are elected and co-opted under the terms of the Trust deed. All trustees give of their time freely and are unpaid.

The trustees are empowered to pay any part of the capital and income for the benefit of such charitable purposes or institutions within or outside of the United Kingdom in such manner and in such proportion as the trustees in their discretion determine.

Related parties

Benmar Textiles Limited is considered to be a related party as the trustees of the charity are also directors of that company. The company has supported the funds for the charity by making donations during the year.

Objectives and activities

Objectives and aims

The objective of the charity is to support other charitable bodies and associations.

This is achieved by making donations and grants to other charitable bodies and associations at the trustees' discretion. The grant making policy is such that the charity receives requests for funding from a wide range of organisations and these are evaluated individually by the trustees. In making their assessment of requests the trustees have regard to how best the receiving charity will employ the funds in providing support to their beneficiaries. No preference is made to institutions involved in any particular charitable activity.

Public benefit

In setting the objectives the trustees have referred to the guidance in the Charity Commission's general guidance and given careful consideration to the Charity Commission's public benefit guidance.

Achievements and performance

Charitable activities

There have been no changes in the objectives of the charity since the last annual report. The charity has met these aims by making donations and grants to a number of institutions.

During the year the charity made donations and grants totalling £52,660 (2022 - £37,500) to 12 charitable bodies and associations.

Financial review

Financial position

The closing fund represents the unrestricted funds arising from donations received and also the free reserves of the charity. The balance at the year end of £2,984 (2022 - £1,016) is in line with the trustees' expectations and the reserves policy of the charity.

Reserves policy

It is the policy of the charity to maintain a low level of reserves, making donations to institutions as and when funds are available to it.

Risk management

The trustees have assessed the major risks to which the charity is exposed and are satisfied that they have taken all necessary steps to mitigate those risks.

Future plans





Year ended 5 April 2023

1. General information

The charity is a public benefit entity and a registered charity in England and Wales and is unincorporated. The address of the principal office is C/O Benmar textiles Limited, Cheetwood Road, Off Broughton Street, Manchester, M8 8AQ.

2. Statement of compliance

These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland', the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)) and the Charities Act 2011.

3. Accounting policies

Basis of preparation

The financial statements have been prepared on the historical cost basis, as modified by the revaluation of certain financial assets and liabilities and investment properties measured at fair value through income or expenditure.

The financial statements are prepared in sterling, which is the functional currency of the entity.

Going concern

There are no material uncertainties about the charity's ability to continue.

Disclosure exemptions

The financial statements do not include a cash flow statement because the charity as a small reporting entity is exempt from the requirement to prepare such a statement.

Judgements and key sources of estimation uncertainty

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the amounts reported. These estimates and judgements are continually reviewed and are based on experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

Fund accounting

Unrestricted funds are available for use at the discretion of the trustees to further any of the charity's purposes.

Designated funds are unrestricted funds earmarked by the trustees for particular future project or commitment.

Restricted funds are subjected to restrictions on their expenditure declared by the donor or through the terms of an appeal, and fall into one of two sub-classes: restricted income funds or endowment funds.

The grant-making policy is such that the Foundation receives requests for grants from a wide range of organisations and are evaluated individually by the Trustees.

ACHIEVEMENTS AND PERFORMANCE

The charity has made a total of more than 100 grants to charitable institutions.

FINANCIAL REVIEW

Reserves policy

It is the policy of the charity to maintain a low level of reserves, making donations to institutions as and when funds are made available to it. Donations are made at the discretion of the Trustees.

During the year, donations of £47,000 were received from Benmar Textiles Limited, a company registered in England and Wales. The company is considered to be a related party as the Trustees of the charity are also the directors of that company.

The Trustees intend to continue making grants available to other charitable bodies and associations as funds become available.

During the year the Foundation received donations of £40,000 and have taken reasonable steps for the detection and prevention of fraud and other irregularities.
