ONE EIGHTH OF THE INCOME FOR THE PROMOTION OF EDUCATION IN EARL SHILTON IN SUCH WAYS AS THE TRUSTEES THINK FIT. THE REMAINING EIGHTH FOR OR TOWARDS THE BENEFIT OR SUPPORT OF THE CHOIR AND MAINTENANCE OF THE CHURCH CLOCK AT THE PARISH CHURCH OF EARL SHILTON IN SUCH MANNER AS THE TRUSTEES THINK FIT.
