(D) TO ADVANCE RELIGIOUS EDUCATION AND WORSHIP IN ACCORDANCE WITH THE DOCTRINE AND PRINCIPLES OF THE CHRISTIAN FAITH BY MEANS OF BIBLE CLASSES, SUNDAY SCHOOLS AND OTHERWISE.
