During the current period we have put on four concerts;-

1. 9<sup>th</sup> November 2023 St Botolph's without Bishopsgate featuring music by little known female composers
2. 14<sup>th</sup> December 2023 in St Botolph's without Bishopsgate our usual Christmas carol concert
3. 21<sup>st</sup> March 2024 in St James, Sussex Gardens performing JS Bach's St John Passion with professional soloists and orchestra
4. 13<sup>th</sup> June 2024 in St Botolph's without Bishopsgate performing psalms, folksongs and spirituals
5. 13<sup>th</sup> July in St Botolph's without Bishopsgate a day workshop with some guest singers

The music for all concerts was prepared in weekly rehearsals with one all day rehearsal for three of them.

Concert audiences were between 80 and 200 with concessionary tickets available for students, etc. The audience members are a mix of regular attendees and those new to our concerts; all comment on the high quality of the performances.

Posters, publicity and programmes were designed by choristers. All committee members devoted significant time to organising the choir's activities. All singers do private practice and preparation of the music before rehearsals.

We gave four successful concerts during the year with the Bach St John Passion being particularly notable and well received by a large audience of around 200. Our audiences have slowly increased over the year as people return to normal activities after the restrictions imposed during Covid.

Reserves are held to cover any losses we might make on a concert and , in the case of the St John Passion to subsidise the cost of the performance, principally engaging professional musicians as soloists and orchestral players and hiring a more suitable larger venue.

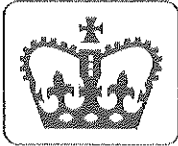
