Summary of the main achievements during the year

The girls are enjoying the guiding programme and the numbers of those achieving bronze, silver and gold awards is increasing.

We hold just over £42,000 in a high interest bond. We aim to use the interest earned to donate in line with our objectives. The total unrestricted funds held at the year end were £61,899 (2023: £57,421).
