Fundraising events have continued to be affected by the Covid 19 pandemic, but a student successfully raised about £1600 the majority of which was being raised for new webcams for the school.

Funds are coming in from the school lottery, virginmoneygiving, Salvation Army, school lottery and others.

The Zebra café was a project to give the older students some work and social experiences. Unfortunately, Gary has informed me that they haven't been able to return to the project and advises us to have the money already given by Wasp, returned.

Applications for Grants were successfully made over the year by Helene Bacchus, business administrator and Karen Moss, teaching assistant for the playground. Together with a Covid fund, there only remains 6k to raise for stage 4.

We have completed our Financial Policy.

A review of the process on how to transfer money between WASP and the school, and the collection of receipts, was carried out.

Vanessa Johnson announced her intention to step down as treasurer and trustee. It has been challenging trying to find new trustees/ a new treasurer, but we will continue our search.
