Report of the Trustees incorporating the Directors' report for the purposes of the Companies Act 2006

The trustees have pleasure in submitting their report and the financial statements of the charity for the year ended 31 August 2022.

The trustees have adopted the provisions of the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and the Republic of Ireland ("SORP FRS 102"), effective January 2019, in preparing the annual report and accounts of the charity.

The company is exempt under Section 60 of the Companies Act 2006 from the requirement to use the word 'limited' in its title.

Governing instrument

The charity was incorporated in England on 15 August 1996 as a private company limited by guarantee, and its governing documents are its memorandum and articles of association. It changed its name by special resolution on 2 October 2010 to Lejeune Clinic for Children with Down Syndrome.

Principal activity and achievements during the period

The charity's principal activity is to promote the care and treatment of children who have Down Syndrome, and to provide specialist assessment and advice that can improve all aspects of such children's development.

The charity runs online Teletherapy sessions in Speech & Language Therapy for small groups of babies and their parents and primary school children. The charity also runs parent training Webinars in Physiotherapy, Occupational Therapy and Speech & Language Therapy. In July 2022 the Charity recommenced its Early Intervention Groups ("EIG") for small groups of children in premises in Sloane Square, Central London, providing Speech & Language Therapy, to children and advice to their parents and carers.

Reserves policy and risk management

The trustees are satisfied that free reserves are more than adequate to fund the operations of the charity for the next twelve months. The charity's reserves policy is to make sure that there are adequate reserves to cover foreseeable operating costs for at least three months. The trustees have assessed the main risks to which the company might be exposed and do not consider that there are any that are likely to impinge on the charity's ability to carry out its functions during the next twelve months.

Report of the Trustees (continued)

Charity's organisation

The charity's operations are run by a clinic manager on behalf of the trustees, who meet at least twice a year and take all decisions, based where necessary on advice given. The charity ceased clinical activities in December 2015, but now provides EIG sessions (Early Intervention Group) each month in Central London, with up to 10 children in each session. Since the COVID-19 Coronavirus pandemic, the charity has provided EIG webinar sessions.

The charity's articles of association require there to be at least three trustees, but there is no maximum. One third of the trustees retire at each annual general meeting, although they are eligible for re-election. New trustees are appointed by the serving trustees from amongst people of known ability who are interested in the trust's work.

Results

The net movement in funds retained for the period was a surplus of £26,225 as set out in the accounts on pages 8 - 10.

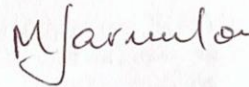

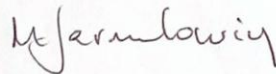

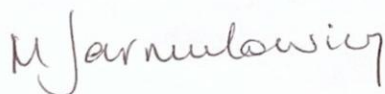
