TO PROMOTE THE PROTECTION, MAINTENANCE AND ENHANCEMENT OF LOCAL GREEN SPACES FOR THE BENEFIT OF WILDLIFE AND THE PUBLIC, IN LINE WITH THE GREEN INFRASTRUCTURE AND DIVERSITY POLICIES IN THE HORSHAM DISTRICT PLANNING FRAMEWORK AND THE STORRINGTON, SULLINGTON AND WASHINGTON NEIGHBOURHOOD PLAN (IN DEVELOPMENT), IN PARTICULAR BUT NOT EXCLUSIVELY BY PROVIDING COMMENTS ON DEVELOPMENT PROPOSALS.
