The Trustees are pleased to present their report together with the financial statements of the Charity for the year ended 5 April 2024. Legal and administrative information set out on page 1 forms part of this report.

RECRUITMENT AND APPOINTMENT OF TRUSTEES

In selecting persons to be appointed trustees, the trustees take into account the benefits of appointing a person who through residence, occupation, employment or otherwise has special knowledge of the area of benefit or who is otherwise able by virtue of his or her personal or professional qualifications to make a contribution to the pursuit of the objects or the management of the trust.

In 2023/24 we made no changes to our group of trustees.

OBJECTIVES AND ACTIVITIES

The main object of the Trust is to provide small grants which make a big difference to alleviate suffering from chronic disease and poverty, to people who would otherwise not receive that relief. During the year the Trust has continued to receive donations and to distribute them to the causes commensurate with the aims.

The trustees have had due regard to guidance published by the Charities Commission on public benefit in deciding what activities the Charity should undertake. During the year the Trust has continued to receive donations and to distribute them to the causes for which it was set up thus meeting the public benefit requirement.

Sept 2023	Youth and Women for Social Empowerment (YWSOEE)	Wakiso District, Uganda Support for a community based organisation in Nkonkonjeru cell, Kyengeru town council, to construct a pit latrine at Aspire High School. The project enabled a wing of latrines for girls, and a second one for boys, including incineration for menstrual waste. Until the project was complete, the school lacked sufficient latrines meaning that boys and girls were using the same facilities, which lacked any doors or privacy, and was at risk of physically collapsing. The hospital chosen for the project serves 5 villages with nearly 37,000 people, with 26,000 of them being women and girls. Prior to the solar installation, the hospital had no access to electricity, and this seriously undermined the services available during difficulties, and especially at night. This solvable problem had been resulting in the tragic death of 25-40 babies and 20-35 pregnant women each year.	230903	£1,600
Dec 2023	Sisters of Immaculate Heart of Mary	Village in Isiolo, Nairobi, Kenya Replacement of a 10,000-litre water tank brought down in storms.	231101	£1,800
Dec 2023	The Mustard Seed Project	Kenya Grant given during 'the Big Give' who pledged to double our grant. In 2022, Kenya's government said that all 12–14-year-olds had to leave primary school and go to secondary school, but there were no new schools or classrooms to accommodate them. The government then revised their decision, saying that some primary schools could keep their 12- to 15-year-olds if they could provide a Junior Secondary School section. Mustard Seed fundraised to provide a feeding programme for their poorest students, and to ensure their school meets government requirements, including providing a playground.		£2,040
Dec 2023	Concord Trust	Tamilnadu, India To dig a bore hole in Kil Kalpattu Village, where locals had been on a hunger strike, demanding drinking water.	231003	£2,000

1 ACCOUNTING POLICIES

The principal accounting policies adopted are as follows:

(a) Basis of Accounting

These financial statements have been prepared under the historical cost convention.

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their financial statements in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019) – (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102).

The Charity constitutes a public benefit entity as defined by FRS102.

(b) Value Added Tax

The Charity is not registered for VAT purposes and all costs are inclusive of VAT.

(c) Resources Expended and Basis of Allocation of Costs

Expenditure is included when incurred.

Donations payable are charged in the accounts when made.

(d) Income Recognition

Items of income are recognised and included in the accounts when all of the following criteria are met:

- The Charity has entitlement to the funds;
- any performance conditions attached to the item(s) of income have been met or are fully within the control of the Charity;
- there is sufficient certainty that receipt of the income is considered probable; and
- the amount can be measured reliably.

For legacies, entitlement is taken as the earlier of:

- the date on which the Charity is aware that probate has been granted;
- the estate has been finalised and notification has been made by the executor(s) to the Trust that a distribution will be made; or
- when a distribution is received from the estate.

Receipt of a legacy, in whole or in part, is only considered probable when the amount can be measured reliably and the Charity has been notified of the executor's intention to make a distribution. Where legacies have been notified to the Charity, or the Charity is aware of the granting of probate, and the criteria for income recognition have not been met, then the legacy is treated as a contingent asset and disclosed if material.

(e) Funds Accounting

Funds held by the Trust are:

Unrestricted general funds - these are funds, which can be used in accordance with the charitable objects at the discretion of the Trustees.

Designated funds - these are funds set aside by the Trustees out of unrestricted general funds for specific future purposes or projects.

Restricted funds - these are funds that can only be used for particular restricted purposes within the objects of the Trust. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.
