for the Year Ended 30 April 2024

The trustees present their report with the financial statements of the charity for the year ended 30 April 2024. OBJECTIVES AND ACTIVITIES

Activities for achieving objectives & public benefit

From the outset of the charity in 1997, the founding document showed the main aim of the charity to be the advancement of the Christian faith. The vision has remained the same; only the methods of presenting and achieving the vision, has changed over the years.

Our nation is constitutionally Christian and we believe that the proclamation of the gospel of Christ, which is the main aim of the charity, is of public benefit.

The Trustees continue to comply with their duties having due regard to guidance on public benefit.

ACHIEVEMENT AND PERFORMANCE

Charitable activities

Introduction

Another year of overcoming despite after effects of the lockdown continuation the 7-year plan coming into its final year, the continuation being on the theme of imminency in relation to the coming of the Lord Jesus to the sky.

Despite the challenge of many years of persecutions and threatenings particularly from 2010 when we were threatened to be "destroyed through official channels", God's grace has overcome, the gates of hell have not prevailed - it is as if the model of the Early Church is being restored.

What is sad is the fact that the nation around us is in serious decline as we know it, particularly in view of the coronavirus crisis, rapidly increasing injury and death rates, our appointment being to present JESUS AS LIFE opposing the signs of death all around us.

To do this we have continued to present our Judeo-Christian heritage in line with our Constitutional Acts, we continuing to promote policies and procedures in line with our own British Constitution rather than being under the laws of a global order, nation after nation rejecting God and coming under the pestilences, famines and earthquakes prophesied in God's Word.

To be protected from this, we must give ear to what is in our Constitutional Acts, our Head of State on oath promising to uphold them.

Trustees on many occasions have fought any attempt to change these constitutional demands seeing such action as an act against the very heart and foundations of our nation. Clear signs of a growing totalitarian state were all around us, and so by presenting the nation's spiritual and temporal foundations we looked to bring stability and counteract the growing atmosphere of fear and control.

Trustees therefore support the statement of President Harry Truman in relation to Great Britain for our laws (not those influenced by foreign power) like the American Bill of Rights are Biblical in nature, and that if we do not have this fundamental moral background then we end up with a Totalitarian Government which does not believe in rights for anyone but the state, the nature of our life under the EU, this being a constitutional rather than political statement.

Part 1: The Intercessions

From the 1920's onwards our spiritual founder Rees Howells (whose College we have now restored) emphasized the importance of intercession. Indeed, it is our firm conviction that it is because of the intercession that went on in the College during the years of the Second World War, that conditions were made for a nation to not only continue its freedom but hold onto its Christian heritage and be able to take the Gospel to "every creature".

We exist today with the same passion, the ministry having travelled to specific locations, for specific purposes to maintain the puritan heritage of our nation, a heritage that gives the necessary freedom and resources to fulfil the call of God on all true Christians.

Travelling intercessions were restored this year during March 2023 in Northern Ireland, details to follow.

Over many years now amazing intercessions have taken place through Brian Mason, who had been trained by Samuel Rees Howells, taking place in many locations, and are featured on the ministry's youtube channel, and at ECCTV.ORG. Now under the heading "Rees Howells Intercession" we continue that ministry, remembering first in this intercession report his passing to glory.

Part 2: What God Has built in the Land of the Covenanters Will Grow and Grow, despite Opposition

After years of persecution, the ministry was called to move from its North Wales base to a land that is steeped in Christian history, we restoring with its newly painted exterior the "White House" of Whithorn moving in the mantle of St Ninian. Truly after years of battle Candida Casa was again amongst the people of Whithorn. From the year 390 to now, the White House proclaiming Christ Jesus is now restored livestreaming all over the world, making this mission a worldwide one!

The ministry recognized however that the country was entering a new era, with the freedom fought for over two world wars being removed, thus the following prophecy right at the beginning of the financial year was given so that trustees might be aware. There was a further significant increase in prophecies over this year, 36 in year 20 to 21; 53 last year in 21 to 22 and now 117 this year, a 55% increase from last year. The following scripture is undoubtedly our ethos in this build up to the Rapture, to remove the blinded eyes of the people from the vagrancies of the "god of this world", and to take heed of what is being said here, the prophecies of the year including clear warning to move away from what are clearly spirits of control looking to dominate the people.

Part 4: The Bible College & The Bible College Lecture Channel

David P Griffiths: In 1997 God gave clear instruction to have in our Declaration of Trust provision for a College. This we did and under the guidance of the Holy Ghost God led our ministry to join together with Brian Mason who had trained under Samuel Rees Howells, Brian passing away this year (2022) in August.

This College is free from the governmental system of textual criticism, instead choosing to have its ethos in the place where the College was spiritually born, in Southwest Scotland.

Here the Covenanters pledged their lives against the religious system, and where Rees Howells made his opening declaration on seeing their Solemn League and Covenant written in blood. The Covenanters had upheld the Royal Priesthood of Believers and the Protestant line of scripture whereas those who have taken over the College buildings at Swansea have chosen the Romanist route of the codices of Vaticanus, Sinaiticus and Alexandrinus, codices that hold the doctrines of the Rome that denies the Trinity and the resurrection, even the virgin birth as it applies to believers, doctrines both Rees Howells and the Covenanters were passionate about.

The College therefore moved to the Cradle of Christianity in Scotland offering courses of sound doctrine taking on the establishment order as it has done with the Nestle Aland infiltration of the Evangelical Pentecostal Movements as well as challenging the establishment order of the national churches in both England and Scotland.

We continue as with the intercessions at Cardoness House with the founding declaration of our College being on behalf of our nation whose Constitution is exactly in line with the bold declaration of Rees Howells, a declaration now being supported by many Roman Catholics who are coming to us expressing their alarm at Rome and its move away from orthodoxy.

The Spirit of God came on me to fight that Church: it was God's anger in me towards the Church of Rome, keeping those five hundred million souls in darkness on the Continent and elsewhere. I entered into a world where fellowship with people was not to count, the only fellowship was with those martyrs who had laid down their lives for the liberty of the Gospel. When I saw that Deed, (of the Covenanters) the Strength of God came into me and changed my body from clay to steel!" DIRECT QUOTE FROM REES HOWELLS

Rees Howells was not only referring to Rome but a Nicolaitan priesthood system that prevented direct contact with God, it being those of the Episcopal faith that slaughtered covenant after covenant.

God was restoring the Bible College of Wales my dad knew as a student in the 1930's. They say to us today that you cannot go back but the Bible says:

The whole ethos of the Bible College of Wales came about during the early years, one of going through great pains and sufferings to be glorified together in a glorious result that only the Lord can take the glory.

This is so far away from the counterfeit that has been set up in Swansea of the charismatic movement. This is a surrender level so great and that we have kept to the Antioch line of scripture is so remarkable and so important and this relates into the courses we offer.

With the following scripture ringing in our ears, the hard work in setting up courses, mark schemes etc. in line with true scripture is taking place knowing that the University system of sand inevitably will fall, and only that which has held to the true Word will stand. We have always known that it is right therefore never to affiliate with the system of the Deep State, but to be separate, be holy and honouring unto God.

On offer at no charge therefore are the African, Asia, International & UK/USA Diplomas, and from this base we offer degree level courses up to doctorate level, our accreditation being in God rather than the "god of this world".

This course gives a Biblical Base in preparation for our other studies that includes The Anointing Course. The study deals with The Anointing on Jesus, The Anointing Within, Personal Leading of the Holy Ghost, Standing On the Word, The Anointing of the Five Fold Ministry Gifts, The Preaching Anointing, The Teaching Anointing, The Pastoring Anointing, The Prophet's Anointing, The Apostolic Anointing, How to Increase the Anointing, Yielding to the Anointing, Peculiar Anointings, The Healing and Corporate Anointings.

In the course "How To Be Led by the Spirit of God", Spirit Consciousness, the differential between Soul and Spirit, the Inward Witness, the Fleece and the Inner Witness are all covered. Moving by the inner witness empowered by the Holy Ghost is so important. I talk with so many who profess to be Christian who talk with the natural mind. It is not being Christian for this is enmity against God, Peter being referred to as "Satan" in Matthew 16 when using natural rationale.

Romans 10:9-10 Authorized (King James) Version (AKJV)

(9 - that if thou shalt confess with thy mouth the Lord Jesus, and shalt believe in thine heart that God hath raised him from the dead, thou shalt be saved. 10 - For with the heart man believeth unto righteousness; and with the mouth confession is made unto salvation.)

The course therefore through the Word brings the conditions for the believer to continuously hear from God, and acting according to the Word being given at that time. This is for the empty vessel, not the intellectually charged individual who simply wants God to bless his/her decisions.

The Jesus the Healer Course emphasizes THE HEALER rather than healing bringing the conditions through the Word for 100% manifestation of healing in given situations. Reasons why people do not move in their healing are given be it that Christ Jesus won the victory at Calvary. There are many reasons and we cover this intensely in the course, for healing was won at Calvary and the manifestation of this is to occur through the ministers of God perfected through the Word of God.

The Other Jesus Course shows the counterfeit which is all over the world at this time.

The course begins looking at the warnings of Isaiah and Paul bringing out the two distinct lines of scripture, one from Antioch and the other from Alexandria, Egypt that combined the gnosis together with spirituality. From here we have today's Alpha course and this is examined in the context of its Anglican and Romanist roots.

Within this context has come textual criticism and the Alexandrian Bibles that forever change at the whim of the Vatican and Bible Societies bringing confusion to once great movements.

The course deals with Taoism and its infiltration into Methodism and the new revivals of the Emerging Church, a movement that began at Fuller Seminary in the United States, taking over orthodox movements all over the World, including the Pentecostal denominations, and even the original Bible College of Wales.

In preparation also was a very important course in relation to the future of the nation that constitutionally had let in foreign laws binding charities, NGO's and business to a global Deep State Agenda that was highly illegal. Also a course on "The Overcoming Life."

FINANCIAL REVIEW

Financial position

Reserves held at 30th April 2024 totalled £146,045 (2023 - £141,985).

Principal funding sources

The income generated for legacy and donations totalled £99,019(2021 - £55,280).

Going concern

After making appropriate enquiries, the trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. For the reason, they continue to adopt the going concern basis in preparing the financial statements. Further details regarding the adoption of the going concern basis, can be found in the accounting policies.

In October 2019, a serious incident report was made, relating to former Trustee and Minister Clive Stanley Bate, the objective of this report being clearly to prove that as in the ministry of Jesus on earth, we have had in our midst an infiltrator who has betrayed us, failed to keep to Biblical Ministry Protocol, and in addition administrative and financial protocol clearly laid out in the Policies and Procedures of the Charity.

The report also shows how the actions of this former trustee and minister have placed great financial burden on trustees and pressure at a time when the Ministry was moving its Ministry Headquarters from North Wales to South West Scotland, the spiritual home of the Bible College of Wales, the home of the Covenanters and where Rees Howells had the vision for the College in the 1920's, a vision that is being successfully restored by this ministry.

The Report also shows how other trustees have come to the fore backing the ministry with designated offerings to cover the losses caused by the actions of Clive Stanley Bate, also other givers who have seen the pressure we have been under have responded accordingly with financial gifts, building up a platform for complete financial recovery.

In March 2024, the result of this is that the Court according to Chris of Vale of Glamorgan Council will take out a LIABILITY ORDER (not an enforcement order against the ministry.) This of course affects our reputation and so it is important to pay the £6,020-84 as soon as possible so as to remove the order.

We still plead our innocence, however, with the defence that follows placing in context events that lead up to this summons. The written Constitution of the nation <https://www.jesusrapturesoon.org/constitution> however demands law to be applied with law and justice in mercy, this Constitution sadly no longer it would seem to be in practice in Britain so before God we issue our defence asking you to seek God over what you should give to clear what is demanded from unjust law.

This site took over from the original site in October 2017 having a much more modern format. This is our training site that gives our ethos and heart in relation to "reaching every creature" with the Gospel. The main menu that has many sub - headings are as follows:

1) HOME PAGE: This page explicitly lays down the reason we are here - to restore the Heart of Biblical Training and Ministry away from the textual critics. We clearly show on this page the line of scripture we abide by, that which has come from Antioch rather than Alexandria from where the charismatics that have taken over the original Bible College building have embraced. It is clear from study of Rees Howells heart that he would fundamentally therefore oppose that which is now coming out of those buildings which is of Roman Catholic origin, Rees Howells saying this on receiving his witness about the Covenanters in South West Scotland: The Spirit of God came on me to fight that Church: it was God's anger in me towards the Church of Rome, keeping those five hundred million souls in darkness on the Continent and elsewhere. I entered into a world where fellowship with people was not to count, the only fellowship was with those martyrs who had laid down their lives for the liberty of the Gospel. When I saw that Deed, (of the Covenanters) the Strength of God came into me and changed my body from clay to steel!"

What is interesting that now in 2023 Roman Catholic after Roman Catholic comes to us expressing concerns over the denial of orthodoxy from Rome. This denial runs right across both Roman Catholic and Protestant "churches". It is therefore with this heart of righteous anger that we run the Original Vision of the Bible College of Wales, setting people free from the curse of Rome rather than embracing it. This opening page clearly shows too the open fight we are having today with post-modernists, and we show this quote from Paul Smith Today postmodernists dismiss the idea of absolute truth; epistemology, the study of knowledge, is still a hot button issue. Why do some postmodernists stand in the pulpits of Christian churches as ministers of our Lord Jesus Christ? They are pretenders with invisible garments; they are as naked as the proverbial emperor! Clearly we show a need for an absolutist College hence the great works that has been going on, that despite persecution, threat and abuse is growing and growing. What we need is a larger staff to cope with demand. Subpages show statistics and The Calling of God on our lives.

On the SUBPAGE "The Calling of God" a clear objective is given "to reach every creature with the Gospel" with 5 key tasks being undertaken to achieve this.

In our publication What We Stand For, a non-establishment Christianity it becomes obvious why we have moved to the land of the Covenanters, the inspiration of Rees Howells to form the College.

Part 9 - The Development of the Ministry at Whithorn - The Rees Howells Dimension

"That's God", the guidance is right declared Rees Howells. Where was this, but in Southwest Scotland at the Anwoth Parish.

With all the persecution of our ministry in Wales, God called us in effect to "shake the dust off our feet." We had witnessed corruption after corruption and with the Spirit moving in us we knew that it was right to move the ministry to a place of peace, to a land of the Covenanters from where Rees Howells received his original vision.

It is to here we therefore have come with a new title - THE BIBLE COLLEGE OF WALES - THE ORIGINAL VISION.

However, with the effects of the pandemic and consequent lockdowns we started to notice a change in the country that was even affecting the Machars Peninsula where we are based. Traditional family values, the ability to express one's heart and above all being able to remind the country of its Judeo-Christian heritage was not only being suppressed, but as the ex-anointed challenged David, we were having to tackle the same spirits.

The country was clearly on a collision course with God but if we continue to stand on the ROCK it will be the country that falls, not us! The national education system has forgotten God, and so God was choosing his David to face the Goliath of the new "woke culture" leading to the collapse of the national system. Programming took place throughout the year increasing the schedule as from July 2022.

Our Schedule included extending our livestreaming & recorded platforms that now includes Vimeo, Rumble, Odysee, Facebook & Twitter as well as youtube. The censorship policies of youtube encouraged us to look elsewhere which we did.

The huge benefit of Vimeo is the service they provide for producing programme starters, finishers and trailers. We continued to use WIRECAST which has become much more sophisticated providing the ability for strap lines and improved graphics thus giving us a much more professional approach.

The College continued with students around the world, its operations we look to extend once our staff levels increase, we are missing the work of Canon Brian Mason in this area particularly, but God will provide, we know this!

The Lord has led us into certain areas of programme production having our doors open to those looking for the Lord, not us, but the Lord. With THE MIRACLE HEALING SERVICE we looked for viewers to attend to the words of the Lord, to find them, obey the Lord's instructions and move in the healing he died for two thousand years ago. We gave this priority over medical interventions that have their origins in HEK 293 - that we understand has emanated from the practice of medics in ending the lives of children in wombs. Our approach is LIFE all the way along the line, and LIFE IS A PERSON - the Lord Jesus Christ, his death and not the death of an innocent child.

The PENTECOSTAL CHURCH SERVICE continued Sunday mornings emphasizing the pre-eminence of Christ Jesus and who we are as THE TRUE CHURCH IN HIM!

The CONSTITUTION KEEPER programme continuously upheld the written Constitutional acts of the UK and how by not keeping them the nation was in serious danger, God continuing to use "Babylons" to bring nations that have promises to HIM in line.

5. Through our marriage counseling program at least five hundred couples who were contemplating divorce have been reconciled and are living happily.
6. Our programs and Sunday services are aired live online with thousands of viewers from all over the world.
7. Our Mission House which has 10 bedrooms and all other facilities, is used to bring many people with broken hearts to bring healing to their bodies and souls in the Name of Jesus.

I think these details would help.

Our banking is with Barclays Bank

RISK: Business interruption

CONTROLS: Ensure business interruption cover is on our insurance policy

However, it seems business interruption does not include the effects of government lockdowns, the removal of Christian teaching from schools that is running alongside the effects of the sexualisation of children.

ACTION - FIGHT WITH ALL WE HAVE GOT TO PROTECT THE CHARITY FROM UNCONSTITUTIONAL ACTIVITY

SUGGESTED RISK RATING (if cover in place): H

3) Financial Controls and Records

CONTROLS: Regulating through issue of regular financial reports, checking and approving invoices by more than one trustee, Chartered accountancy.

Challenge the legality of Emerging Church takeovers, and government legal actions that embrace the UN, WEF agenda over the constitution of the nation. What would reduce the risk would be the change from a trust to a CIO, the risk being high due to the WEF agenda.

CONTROLS: Little cash held at Charity premises, fidelity insurance cover

RISK: of overspend particularly in view of lack of response to giving outside the circle of trustees and Council of Reference.

CONTROLS: Detailed budget approved annually at AGM with detailed reports regularly going to trustees for checking.

SUGGESTED RISK RATING: H

7) Compliance with Tax Regulations

RISK: ignorance of rules

CONTROLS: Courses for trustees, regular checking by professional help.

SUGGESTED RISK RATING: M - suggest agenda item to trustees to reduce to L

8) Decision Making

RISK: Charity may face legal actions resulting in financial penalties

CONTROLS: A decision book be kept of everyday decisions to be checked by trustees

SUGGESTED RISK RATING: H - suggest agenda item to trustees to reduce to L particularly in view of large amount of government enquiries

9) Contracts

RISK: Risk of legal challenge due to non-compliance with terms of contract.

CONTROLS: Have a trustee read contracts and present report at meetings, seek legal advice.

SUGGESTED RISK RATING: L - if controls in place.

SUGGESTED RISK RATING: M - normally L but NT Christianity is alien to modern day legal processes.

12) ABSENCE OF PROCEDURES SECRETARY/HI TECH OPERATOR -

RISK: With understaffing in the Charity there is a risk of non-operation should specialist staff be unavailable for long periods.

CONTROLS: We need to get more staff and train them in the operations of the Charity. At present staff are doing more than one job and over stretched.

SUGGESTED RISK RATING: H - this issue needs to be addressed.

13) COMPLAINTS HANDLING

RISK: Risk of action against the Charity, possibly resulting in drain of financial resources.

RISK: Possibility of tribunals and financial penalties

CONTROLS: Regular updates, advice received from IR, checks by Chartered Accountant

SUGGESTED RISK RATING: L - until we move to CIO when procedures will need to be introduced

17) Honesty/Integrity

RISK: Possibility that Charity may be brought into disrepute and undergoing of time-consuming investigations by the Charity Commission.

CONTROLS: Code of conduct agreed, accurate accounting practices and monitoring of operations.

SUGGESTED RISK RATING: M - if controls in place - also strategy getting over the targeting of RC groups determined to destroy the charity through legalism.



As the charity trustees of the Trust you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ('the Act').





1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

Financial reporting standard 102 - reduced disclosure exemptions

The charity has taken advantage of the following disclosure exemptions in preparing these financial statements, as permitted by FRS 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland':

- the requirements of Section 7 Statement of Cash Flows;
- the requirement of paragraph 3.17(d);
- the requirements of paragraphs 11.42, 11.44, 11.45, 11.47, 11.48(a)(iii), 11.48(a)(iv), 11.48(b) and 11.48(c);
- the requirement of paragraph 33.7.

Income

All income is recognised once the charity has entitlement to the income, it is probable that the income received and the amount of income receivable can be measured reliably.

For legacies, entitlement is taken as the earlier of the date on which either: the charity is aware that probate has been granted, the estate has been finalised and notification has been made by the executor(s) to the Trust, that a distribution will be made, or when a distribution is received from the estate. Receipt of a legacy, in whole or in part, is only considered probable when the amount can be measured reliably and the charity has been notified of the executor's intention to make a distribution. Where legacies have been notified to the charity, or the charity is aware of the granting of probate, and the criteria for income recognition has not been met, the legacy is treated as a contingent asset and disclosed if material.

Income tax recoverable in relation to donations received under Gift Aid or deeds of covenant is recognised at the time of the donation.

Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefit will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The cost of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs that are not attributable to a single activity, are apportioned between those activities on a basis consistent with the use of resources. Central staff costs are allocated on the basis of time spent and depreciation charges are allocated to the portion of the asset's use.

Governance costs are those incurred in connection with administration of the charity and compliance with constitutional and statutory requirements.

Charitable activities and Governance costs are costs incurred on the charity's educational operations, including support costs and costs relating to the governance of the charity apportioned to charitable activities.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Interest receivable

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the charity; this is normally upon notification of the interest paid or payable by the bank.

Cash at bank and in hand

Cash at bank and in hand includes cash and short term highly liquid investments with a short term maturity of three months or less, from the date of acquisition or opening of the deposit or similar account.

Debtors

Trade and other debtors are recognised at the settlement amount after any trade discount offered. prepayments are valued at the amount incurred, net of any trade discounts due.

Liabilities & provisions

Liabilities are recognised when there is an obligation at the Balance Sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably. Liabilities are recognised at the amount that the charity anticipates it will pay to settle the debt or the amount it has received as advance payments for the goods and services it must provide. Provisions are measured at the best estimate of the amounts required to settle the obligation. Where the effect of the time value of money is material, the provision is based on the present value of those amounts, discounted at the pre-tax discount rate that reflects the risks specific to the liability. The unwinding of the discount is recognised within interest payable and similar charges.

Financial instruments

The charity only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value, with the exception of bank loans which are subsequently measured at amortised cost using the effective interest method.
