The charity does not have a specific policy with regards to the level of reserves held.

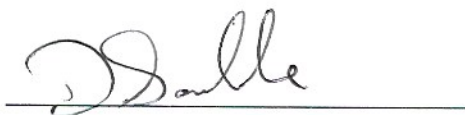
**OBJECTIVES AND ACTIVITIES**

to state whether particular matters have come to my attention.

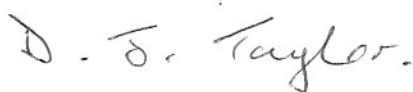
### **Basis of Independent Examiner's report**

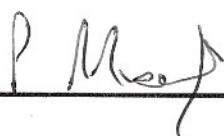
