Activities: a. holding the Regimental Collection of the Queen's Own Oxfordshire Hussars upon trust, upholding the traditions of the Regiment, and perpetuating its deeds and actions;b. making grants of money out of accumulated income only of the Trust Fund to relieve the distress of former members of the Regiment and their widows and orphans.
