Objects: (A) TO RELIEVE PERSONS WHO ARE IN CONDITIONS OF NEED OR HARDSHIP OR WHO ARE AGED OR SICK OR WHO ARE HOMELESS AND TO RELIEVE THE DISTRESS CAUSED THEREBY IN SUCH PARTS OF THE WORLD AS THE TRUSTEES MAY FROM TIME TO TIME THINK FIT;(B) TO ADVANCE THE CHRISTIAN FAITH IN ACCORDANCE WITH THE STATEMENT OF BELIEFS APPEARING IN THE SCHEDULE HERETO IN SUCH OTHER PARTS OF THE WORLD AS THE TRUSTEES MAY FROM TIME TO TIME THINK FIT;(C) TO RELIEVE UNEMPLOYMENT OF THOSE IN FINANCIAL AND ECONOMIC NEED IN PARTICULAR BY THE PROVISION OF TRAINING FOR EMPLOYMENT AND ADVICE AND OTHER ASSISTANCE TO ENABLE SUCH PERSONS TO BECOME SELF SUPPORTING(D) TO PROMOTE AND FULFIL SUCH OTHER CHARITABLE PURPOSES BENEFICIAL TO THE COMMUNITY IN THE LOCATIONS WHERE THE CHARITY MAY FROM TIME TO TIME BE OPERATING

Activities: 1. to relieve persons who are in conditions of need or hardship or who are aged or sick or homeless and relieve the distress caused thereby in such parts of the world as the trustees from time to time see fit.2. to advance the Christian faith in accordance with the Charity's statement of beliefs in such parts of the world as the trustees may from time to time see fit.
