Activities: Maintenance and enhancement of the canal in both Devon (watered) and Somerset (unwatered) through monthly working parties and collaboration with partners, particularly regarding the historical structures. Presentations about canal history are given to local bodies. Currently developing a Park'nGlide

scheme to carry visitors from a car park to Taunton town centre by water using electric boats
