1) Principal Accounting Policies

Basis of Accounting

**Accountants Independent Examination to the Trustees on the Unaudited Accounts of the Charity
Yad Toiva (The Kind Hand Trust)
For the Year Ended 31 March 2021**

We report on the financial statements of Yad Toiva (The Kind Hand Trust) for the Year Ended which comprise the Statement of Financial Activities, the Balance Sheet and the related notes. These financial statements have been prepared, under the historical cost convention, and in accordance with the recommendations in Accounting and Reporting By Charities: Statement of Recommended Practice (Issued 2015), and the Financial Reporting Standard for Smaller Entities 102 (effective 2016), and the accounting policies set out therein.

Respective Responsibilities Of Trustees and Reporting Accountants

As described on page 3, the trustees of the charity are responsible for the preparation of the accounts, and they consider that the audit requirement of section 144 of the Charities Act 2011 (the Act) does not apply.
