SUCH OTHER CHARITABLE PURPOSES THAT WILL BENEFIT THE COMMUNITY THAT THE MEMBERS SHALL DECIDE. 4. THE TRUST WILL REMAIN NON-PARTY IN POLITICS AND NON-SECTARIAN IN RELIGION AND MUST NOT DISCRIMINATE ON THE GROUND OF RACE, SEX, RELIGIOUS OR POLITICAL BELIEFS OR OTHER OPINION.
