2023 Annual Report of Plymouth Branch Trustees Report.

The Branch Membership stands at 240 Members and continues to operate for meetings and social gatherings from the WO's & SR's Mess HMS DRAKE, courtesy of the Mess President.

Sadly 9 Branch Members 'Crossed the Bar' in 2023 - *Shipmate Colin Roberts (Ex CPO RN)* - *Shipmate Doreen Watson. (Assoc Member)* - *Shipmate Michael Peakman (ex CPO RN)* - *Shipmate Joe Dolphin (ex CPO RN)* - *Shipmate Mike Gee (ex RM)* - *Shipmate Carmen Elbro (ex-WREN)* - *Shipmate Charles 'Chris' Jones (ex CPO RN)* - *Shipmate Jim Paterson (ex PO RN)*. ***May They Rest in Peace.***

The Branch Main Committee, (Trustees), conduct Branch affairs in accordance with our Supplemental Royal Charter Rules and Bye-Laws in conjunction with the Charity Commission directives in meeting our Royal Naval Association's Objects as outlined in Article 3 & 4. Over this past year the Branch has continued to support the Royal Navy providing Mentors for Part One Trainees at HMS RALEIGH. Further support is provided to the Royal Navy by the Branch in our participation by Branch Members and the Standard Bearer at the many Naval ceremonial events held across the City. We also, at the request of the Naval Base Funeral Officer, give support to grieving families at the funerals of Shipmates who died in Service.

Support of Naval Veterans and their families is at the heart of the Branch Committee's focus; much importance is attached to providing and the arranging of meetings and social events. In 2023, as well as the monthly meetings, we have visited museums, held several dinner dances, including our Annual Gala Dinner at which we hosted the City Lord Mayor and our own National President, we visited RNA Saltash for a quiz night, a skittle evening with scampi & chips in a village pub and a wonderful Mess Dinner aboard Admiral Lord Nelson's Flag Ship at the Battle of Trafalgar HMS VICTORY. Thanks to the Social Committee a fulsome calendar of events from Tot Night in the Mess to Armed Forces Day on Plymouth Hoe, giving Members a broad choice of things to be involved in, so helping to counter the possibility of loneliness and isolation and the issues that can bring with it.

The Welfare Officer is experienced and well placed to give Members help and advice often by sign posting and liaison with the appropriate professional services. We are supportive of Plymouth City's Armed Forces Covenant partnership, whose extensive range of services which includes employment/training to housing, health care and education. The Hon Sec promulgates services, events, advice and helplines via the monthly fact sheet including where to get a Veterans Full English Breakfast followed by soccer exercise at the 'Veterans walking football', to give one example!

Ceremonial. The Branch Standard Bearers supported by Branch Members have paraded our Standard on 52 occasions, nine of these were in support of the Families of Branch Members who had Crossed the Bar and fifteen occasions were at the request of Families whose departed had given service in Naval Services (Veterans). The Branch engaged appropriately with all military and civil parades and such occasions attaching particular importance to Memorial Services Perpetuating the Memory of Our Naval Forces who died in the service of their Country.

Fiscally the Branch finds itself in a much-improved state, as a generous legacy from a WWII Veteran tripled our balance sheet holdings. The lengthy wait for the windfall to materialise, provided ample time for Branch Trustees to study all aspects and possibilities in developing a prudent fiscal plan that would best benefit the charitable aims of the Branch for many years ahead. The Trustees, having closely studied both RNA and Charity Commissions Instruction & Guidance on investment, with the support and approval of the Membership, developed a Fiscal Plan meeting the criteria we set, whereby the bulk of the money would be invested for the long term at the lower risk level as was professionally advised, aiming to provide annual income to meet our charitable responsibilities. Five percent of the windfall was put aside for a one-off donation to RNA Central Office to benefit Members Nationally £10,000. and a further donation to the Plymouth Sea Cadets £1,000. Aside from that donations were made to - Branch Widows Christmas Box, Naval Dockyard Heritage Fund, Dartmoor Trafalgar Memorial/Museum and the Royal Navy Section Ford Park Cemetery Trust. The Trustees are mindful the Sum used to invest in the 'long term investment plan', is designated for the purpose of acquiring a property for the use of the Branch should the need arise.

The year 2023 leaves the Branch in a fiscally sound position currently and for the future. Membership is historically high though attendance is disappointing despite the Committee's efforts to entice and encourage regular participation. Other than that, the Branch has had a most successful year.
