### **Information**

#### **Objectives:**

The principle objective of the company is to promote the education of young people in achieving their full physical, intellectual, social and spiritual potential, in particular by the production of an annual theatrical event.

#### **Constitutional Matters:**

- (i) The company was established by the Executive Committee (trustees) of the City of Coventry Scout County (a registered charity) to operate the Coventry Gang Show.
- (ii) The company is a company limited by guarantee, not having a share capital. The company's constitution is its memorandum and articles of association.
- (iii) The members of the company, the trustees, who have the power to appoint its trustees (its directors for the purposes of the Companies Act), are all members of a sub-committee of The Executive Committee of the City of Coventry Scout County. For this reason the company is a subsidiary of the City of Coventry Scout County.

### **Trustee's (Director's) Report**

The trustees present their report and accounts for the year ended 31 August 2020.

The financial statements comply with the Charities Act 2011, the Companies Act 2006, the Companies Constitution and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard in the UK and Republic of Ireland (FRS 102).

### **Principal Activities**

The company's principal activity during the year continued to be the production of a Gang show, a theatrical event organised by Coventry scouts.

### **Trustees (Directors)**

### **Share Capital**

The company does not have a share capital and there is consequently no register of shareholders interests. No trustee had any interest in a contract with the company at any time.

### **Financial Review**

The overall result for the year was a profit of £12,777. Unrestricted fund reserves amounted to £12,234 at the end of the financial year. During the year the charity received two grants totalling £15,000. Due to the Covid pandemic the charity was unable to carry out its usual theatrical performance and without the two grants would have incurred a loss of £2,223. The loan from the City of Coventry Scout County remains at £11460.

### **Public Benefit**

The trustees believe that the charity meets the regulatory guidelines in terms of qualifying as a Public benefit entity.

### **Reserves Policy**

The trustees consider the most appropriate level of unrestricted reserves would be sufficient to cover the hire of a theatre, which would be approximately £15,000. It is hoped to increase the reserves over the coming years to this level. The charity is currently showing reserves of £12,234 with £11,460 of creditors due to be repaid as and when the charity can afford it.

**Risk Management**

The trustees have examined the major strategic, business and operational risks which the charity faces and confirm that systems have been established to enable regular reports to be produced so that the necessary steps can be taken to lessen the risks.

To present a Gang Show at the Belgrade Theatre and offer the Scouts the development opportunity of performing in a show.

For the year ended 31 August 2020

#### 1 Accounting policies

##### Basis of preparation

The financial statements have been prepared under the historical cost convention with assets and liabilities recognised at cost or transaction values unless otherwise stated in the relevant notes and in accordance with Accounting and Reporting by charities; Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16th July 2014 – (Charities SORP (FRS 102), the Financial Reporting standard applicable in the UK and Republic of Ireland (FRS 102), the Companies Act 2006 and the Charities Act 2011.

The charity meets the definition of a public benefit entity under FRS 102.

The trustees consider that there are no uncertainties about the charity's ability to continue as a going concern.

In preparing the accounts, the trustees have considered whether in applying the accounting policies Required by FRS 102 and the Charities SORP FRS 102 a restatement of comparative items was needed. They have concluded that no restatements were required.

##### Recognition of Income and expenditure

Income and expenditure are accounted for on an accruals basis and accordingly include income earned but not received and expenditure incurred but not paid at the end of the accounting period.

##### Scenery and costumes

Scenery and costumes are written off in the accounting period in which they are acquired.

##### VAT

The company is not registered for VAT. Expenditure therefore includes the related VAT where applicable.

##### Donated services

In accordance with Charities SORP (FRS 102), the economic benefit of time by volunteers is not recognised in the figures.

##### Financial Instruments

The charity only has financial assets and liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value.

##### Tangible fixed assets

Tangible fixed assets are measured at cost less accumulative depreciation and any accumulative impairment losses. Depreciation is provided on all tangible fixed assets, at rates calculated to write off the cost, less estimated residual value, of each asset evenly over its expected useful life, as follows:
