FOR THE YEAR ENDED 31ST MARCH 2022

The trustees present their report and the financial statements for the year ended 31st March 2022. The trustees, who are also directors of Middleham Key Centre Ltd for the purposes of company law and who served during the year and up to the date of this report are set out on page 1.

Structure, Governance and Management

Governing document

The Charity is constituted as a company limited by guarantee and a registered charity and is, therefore, governed by a Memorandum and Articles of Association. Membership is open to anyone over the age of 18.

Appointment of Trustees

The directors of the charitable company ("the charity") are its trustees for the purpose of charity law and throughout the report are collectively referred to as trustees.

The Articles of Association provide that trustees may be appointed by ordinary resolution in general meeting.

Objectives and Activities

The principal activity of the company is that of the provision of educational, training and recreational facilities for the people of Middleham, Leyburn and the surrounding areas.

The charity is organised so that the trustees meet regularly to manage its affairs and to revise and manage identified risks. There are administrators who manage the day to day activities of the charity. Funds are raised primarily from community and commercial bookings, courses and rental income from tenants. Additionally monies are donated and shown in note 2 to the accounts.

When reviewing the charity's objectives, activities and future plans, the trustees have referred to the guidance contained in the Charity Commissions' general guidance on public benefit.

Achievements and Performance and Financial Review

The year from April 2021 was unprecedented as the country came out of lockdowns but some restrictions on gatherings and activities, especially those indoors, continued and changed. These changing restrictions impacted significantly on the reopening of the Key Centre and the resumption of activities and bookings, making planning and income very unpredictable. The centre was helped greatly by government Covid 19 support grant funding, without which the future would have been incredibly difficult to sustain. However, further restrictions impacted the resuming bookings before and around the Christmas season due to the Covid Omicron variant. Once again the centre was supported by a small closures grant for December 2021 and then the announcement of much more significant reopening grants in Spring 2022. The other underpinning factor was the income from the solar panel feed in tariff, which continued regardless. The importance of reopening the centre to enable community groups and activities to resume and continue following the isolation within the community throughout covid was recognised as a priority need. The sole (part time) member of staff continued to work at the centre or, when precluded, working from home with internet access. She was not furloughed at any phase during the pandemic.

Future Developments

In February 2022 the Chair and Company Secretary, Mike and Leslie Sweeting respectively, resigned with just a few weeks' notice due to a short notice relocation to Lincolnshire. In order to continue the charity uninterrupted, a group of 5 x Town Councilors agreed to step in to take over the running of the Centre for the time being – anticipated to be for up to 12 months. During this time they would undertake a complete review of the charity and the centre in the post covid climate and recommend a sustainable strategy for its future role and funding in the community. This review commenced in March and is due to complete and report back to the Town Council within 12 months or less. This work will be complete before the end of the current lease in March 2023. The Trustees also undertook to review current income and expenditure to ensure the cost-effective running of the centre and the charity at least to the end of the lease.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charitable company and which enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charitable company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

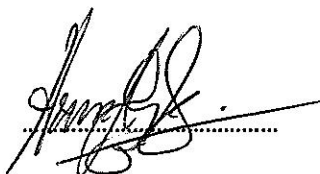

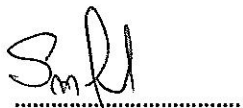

1. Accounting Policies

The principal accounting policies are summarised below. The accounting policies have been applied consistently throughout the year and the preceding year.

1.1. Basis of Accounting

The financial statements are prepared under the historic cost convention and in accordance with the Statement of Recommended Practice - Accounting and Reporting by Charities applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) (effective 1 January 2015) – (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) and the Companies Act 2006. The Principal accounting policies adopted in the preparation of the financial statements are set out below.

1.2. Income

All income is included in the statement of financial activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

Voluntary income is received by way of grants, donations, and gifts and is included in full in the statement of financial activities when receivable.

Income from investments is included in the year in which it is receivable.

1.3. Expenditure

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates.

Fundraising costs are those incurred in seeking voluntary contributions and do not include the costs of disseminating information in support of the charitable activities.

1.4. Tangible Fixed Assets and Depreciation

Tangible fixed assets are stated at cost less accumulated depreciation. Depreciation is provided at rates calculated to write off the cost less residual value of each asset over its expected useful life, as follows:

Plant and machinery	-	25% reducing balance
Solar Panels	-	Straight line over 15 years

1.5. Leasing

Rentals payable under operating leases are charged against income on a straight line basis over the lease term.

REPORT OF THE TRUSTEES (INCORPORATING DIRECTORS' REPORT)

The trustees present their report and the financial statements for the year ended 31st March 2021. The trustees, who are also directors of Middleham Key Centre Ltd for the purposes of company law and who served during the year and up to the date of this report are set out on page 1.

Structure, Governance and Management

Governing document

The Charity is constituted as a company limited by guarantee and a registered charity and is, therefore, governed by a Memorandum and Articles of Association. Membership is open to anyone over the age of 18.

Appointment of Trustees

The directors of the charitable company ("the charity") are its trustees for the purpose of charity law and throughout the report are collectively referred to as trustees.

The Articles of Association provide that trustees may be appointed by ordinary resolution in general meeting.

Objectives and Activities

The principal activity of the company is that of the provision of educational, training and recreational facilities for the people of Middleham, Leyburn and the surrounding areas.

The charity is organised so that the trustees meet regularly to manage its affairs and to revise and manage identified risks. There are administrators who manage the day to day activities of the charity. Funds are raised primarily from community and commercial bookings, courses and rental income from tenants. Additionally monies are donated and shown in note 2 to the accounts.

When reviewing the charity's objectives, activities and future plans, the trustees have referred to the guidance contained in the Charity Commissions' general guidance on public benefit.

Achievements and Performance

The Centre's trading year was disrupted by the Covid-19 from the very start. Lockdown 1 commenced about two weeks before the year began, with all public buildings, including our own, entirely closed.

It is very fortunate that all the planned consolidation from the prior trading year had been implemented. In between lockdowns various improvements to the fabric of the building were made. A take-away business became our tenant for the kitchens just at the start of the lockdowns and saw rapid growth. However, our most established tenant Mike Russell Electronics, had already given notice due to staff relocation.

In between lockdowns the Centre was very successful in attracting new tenants, partly through a policy of upgrading each room or suite as an old tenant departed. As both redundancies in the wider job market and Covid support trickled through, several start-ups were attracted to MKC. The pattern though, was of either outgrowing us or wind-up after six months. At one point, however, we were at full commercial capacity, quite surprising for the troubled times. Constant changes in government Covid regulations and general uncertainty meant that rental and event income was minimal during the same period.

Financial Review

Without the receipt of two substantial grants from the Covid-19 recovery fund via RDC, the Centre would have been forced to cease trading. An unexpected extra was a kind donation from Wensleydale Wheels, which had been forced to wind up during the crisis period. Their policy was to make donations of their remaining funds to organisations that had assisted them with their eco-friendly goals. MKC was thus a recipient.

Our normal budget was made meaningless from the very start, with the effect of Covid hitting our existing tenants hard, not just our own hire and casual use. We extended favourable terms to core tenants for as long as we could. It is encouraging to report zero bad debt arising from this difficult scenario. Those receiving government support were able to pay out of that. Several local societies offered their entire year's rental money, knowing they would receive zero use of the facilities. The main beneficiary of reduced terms voluntarily repaid us in full when they were able. Community support was excellent.

Our only other meaningful revenue generator was the solar array. 2020 benefitted from above average sunny weather, so MKC benefitted from above average income from the energy tariff scheme.

Future Developments

Ironically, because variable costs went down sharply at a point where we were gaining both unusual unearned and earned income, the outcome for the year was really positive. The obvious major challenge is to rebuild the volunteer base. This will take a long time and a lot of effort due to deaths, shielding and other changes of personal circumstances. Most volunteers have permanently stopped because it is unfeasible or impossible to do what they once did. It was already clear that the next generation of retirees in the area have minimal interest in supporting community enterprises, which is affecting many other organisations that are substantially assisted by volunteers. It is unclear how long the Covid emergency will continue, making most planned development, other than on the building fabric, impractical. It is inevitable that work previously done by volunteers will now have to be done by contractors, but reserves are well able to cover this change.

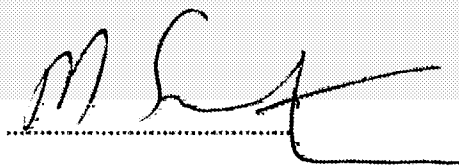

This trading year has been very stable and steady, following the structured time of consolidation and re-organisation in the year prior. It was decided not to put an ongoing emphasis on seeking Grants since they were typically linked to the type of capital projects that are not currently needed. The requirements of the grants also created substantial extra work in the prior three years that cannot be sustained with the volunteer base we have. On 06/11/19, Alex Adams became a Trustee, after a number of years on the management committee.

It was good to see the Centre flourishing and stable after a period of change. Only the last few weeks of operations were affected by the onset of the Covid-19 pandemic. There was no financial effect at all in the trading year. Community and occasional room bookings have continued to look very similar to the two prior years, but there has been a welcome increase on the commercial side.

All elements of the review undertaken with our Custodian Trustees, Middleham Town Council in 2018-19, have now been incorporated into current best practice during this operational year.

Financial Review

For a second year the wider community did not have either a Mayor's Ball nor a Stables Open Day. Traditionally the Centre's budget had been predicated upon donations deriving from our support of both major events. We had revised the budget to operate more from income, so this was not the challenge it had been the year before. It is great to be able to report that revenues are now independent of both donations and of grants, meaning that the Centre's business activities now entirely support its community and charitable functions.

The solar array makes a substantial contributor ongoing, particularly now that loan repayments are complete. Revenue from this source provides a cushion against any potential loss of tenancy income in the coming year. As the calendar year came to an end, there was the 'usual' flurry of tenant departures and arrivals. Costs had already been reduced post-review, but because there were several commercial vacancies for a period, some funds had to be transferred from the reserve account. The number of commercial room bookings rose, and, together with the commercial rate rise, ensure that the gap will be closed by end of Q1 of the coming year.

The Key Centre continued to trade in line with its policy of re-investing modest profit into the fabric and future of this community facility, using the commercial lettings to finance that community emphasis.

Future Developments

The Key Centre is being marketed more widely, particularly on social media. The price rise for commercial lettings was implemented, with no issues. The financial plan for the forthcoming year is based on attempting to keep permissible commercial letting at its maximum. This is now the main way to avoid passing on increased costs to our community users without incurring a trading deficit.

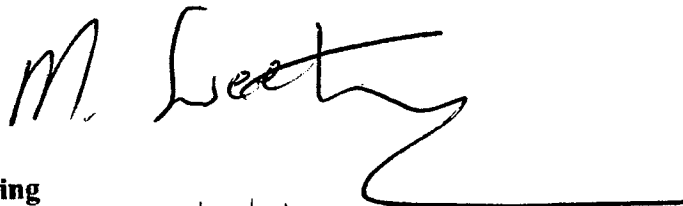

1. Accounting Policies

The principal accounting policies are summarised below. The accounting policies have been applied consistently throughout the year and the preceding year.

1.1. Basis of Accounting

The financial statements are prepared under the historic cost convention and in accordance with the Statement of Recommended Practice - Accounting and Reporting by Charities applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) (effective 1 January 2015) – (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) and the Companies Act 2006. The Principal accounting policies adopted in the preparation of the financial statements are set out below.

1.2. Income

All income is included in the statement of financial activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

Voluntary income is received by way of grants, donations, and gifts and is included in full in the statement of financial activities when receivable.

Income from investments is included in the year in which it is receivable.

1.3. Expenditure

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates.

Fundraising costs are those incurred in seeking voluntary contributions and do not include the costs of disseminating information in support of the charitable activities.

1.4. Tangible Fixed Assets and Depreciation

Tangible fixed assets are stated at cost less accumulated depreciation. Depreciation is provided at rates calculated to write off the cost less residual value of each asset over its expected useful life, as follows:

1.5 Leasing

Rentals payable under operating leases are charged against income on a straight line basis over the lease term.

15. Related party transactions

The building was transferred from the ownership of Middleham Key Partnership Ltd, which was subsequently liquidated, to Middleham Town Council as Guardian Trustees in March 2013 and a licence agreement approved.

16. Company limited by guarantee

Middleham Key Centre limited is a company limited by guarantee and accordingly does not have a share capital.

Every member of the company undertakes to contribute such amount as may be required not exceeding £10 to the assets of the charitable company in the event of its being wound up while he or she is a member or within one year after he or she ceases to be a member, for the payment of the charity's debts and liabilities contracted before he or she ceases to be a members, and of the costs, charges and expenses on winding up, and for the adjustment the rights of the contributories among themselves.
