Trustees' Annual Report

St Peters Parents Teacher Association

For the year ended 31 July 2025

1. Objectives and Activities

The PTA exists to advance the education and wellbeing of pupils at the school by raising funds and providing resources and experiences that enhance school life. During the year, the trustees focused on delivering inclusive community events, growing sustainable fundraising streams, and using funds raised to directly benefit pupils across all year groups.

2. Achievements and Performance

Impact on the Children

During the 2024–2025 academic year, the trustees are pleased to report a significant positive impact from fundraising activities, representing one of the PTA's largest annual contributions in over five years.

Funds were used to provide a wide range of resources and support, including:

- Installation of shade for the KS1 playground
- New books for the school library
- Waterproof jackets and high-visibility vests for Little Fishes
- Fans for classrooms
- Leavers' crosses and prayer books
- End-of-year production overhead costs
- Additional equipment and resources requested by the school

Summary of the Year

The Annual General Meeting was held on Thursday 24 October 2024 online via Zoom. The trustees opted to return to an online format, following evaluation of previous in-person events which, although enjoyable, did not lead to increased volunteer engagement.

Throughout the year, efforts continued to promote the PTA and strengthen governance. New committee members joined in voting and officer roles, helping to build resilience

within the core officer group. All officers continued in their existing roles, although several long-standing members stepped down at the end of the year.

Overall, this was one of the PTA's most successful years, with new events introduced, strong community engagement, and significant growth in the pre-loved uniform operation, supported by the installation of a dedicated PTA uniform shed.

3. Fundraising Activities

Key fundraising events and outcomes during the year included:

Bonfire Night

Bonfire Night was again a highlight of the school calendar. A new events lead joined this year, supported by the outgoing lead to ensure a smooth handover. Advance ticket sales and the cashless system worked well, contributing to the event's success.

Christmas and Advent Activities

The PTA provided the school Christmas tree and nativity scene, along with decorations in school colours. The class Christmas tree decoration competition ran for its third year and continued to be popular with pupils. A new initiative involving children's artwork being turned into gift items was trialled successfully. The PTA also supported the Winchester Round Table Santa Sleigh collections.

Film Night

A whole-school film night was reintroduced for the first time since before Covid. Feedback was largely positive, and trustees believe this is an event that could be run multiple times in future years.

Wine Tasting

A wine tasting event was held at the school and received overwhelmingly positive feedback. The event benefited from professional expertise and partial donation of wine, and also helped strengthen the school community through social engagement.

Summer Fete

Despite initial weather-related challenges, the trustees made the decision to postpone the fete by one week. This resulted in a successful outdoor event with strong attendance and fundraising outcomes, raising over £5,000 for the school.

Sports Day

The PTA reintroduced the community tent, serving refreshments provided by families. Feedback was positive, though the trustees noted the need to review volunteer capacity for future years.

Second-Hand Uniform

The second-hand uniform initiative continued to grow significantly. Additional volunteer

support was recruited, and a dedicated uniform shed was purchased and installed, enabling regular monthly openings. The trustees are exploring further improvements, including termly events and digital ordering options.

Additional income was generated through donations, the 100 Club, ASDA cash pot funding, and card donations following the school production. Increasing awareness of the 100 Club remains a priority for the coming year.

4. Financial Review

The charity generated just under £26,970 in gross income during the year and spent over £32,460 on charitable activities supporting the school. The trustees consider this level of expenditure appropriate in light of reserves held at over £27,000 as at 01/08/2024, and the direct benefit delivered to pupils.

5. Plans for Future Periods

In the coming year, the trustees plan to:

- Continue delivering successful core events
 - Build volunteer capacity and succession planning
 - Develop the second-hand uniform operation further
 - Increase regular income streams such as the 100 Club

The trustees confirm that the charity has complied with its duty to have due regard to public benefit guidance published by the Charity Commission in carrying out its charitable purposes.



Academic Year 2021 - 2022

The Annual General Meeting (AGM) was held on 20 October 2021 and new members were welcomed to the Committee. The Second General Meeting (SGM) also took place on 20 October 2021 when myself and Nancy Harman agreed to continue our roles as Chair and Vice Chair (respectively) along with the support of Ian and Janet Urquhart who remain Honorary Treasurer and Vice Treasurer. Ania Slinn and Asia Ennis also remain in their roles as Secretary and Vice Secretary. **Note** that this will be the last year 'Office Holders' retain their roles.

The PTA approached the new academic year with optimism, managing the easing of COVID restrictions to fully embrace delivering larger events such as Bonfire Night and the Summer Fete. It was wonderful to engage Cohorts from lower down the school and have them experience larger, whole school events.

Bonfire Night - £5,418

On the 6th November 2019 the Bonfire Committee delivered the first Bonfire Night since Covid restrictions came into force. The event was hugely popular due in part to the fact that no other Bonfire Events were taking place in Winchester. The team delivering the event were considerate of the anxiety many still held about large events and so numbers to this event were restricted. Pre-sale tickets and some careful management on the entrance gate meant the event was delivered safely and successfully securing a healthy profit. Special thanks to the Bonfire Committee members, Helen Turvey, Joanne Sheehan and Jon Peacock for all their hard work as well as a special mention to the wonderful Treasury team and stalwart volunteers, Mairead Mulhull and Mariangela Simonata-Moore.

Christmas Tree and Crib display

With the success of the Christmas Nativity Display last year, the PTA again set up the crib outside school. The tree and lights were kindly donated by the Patterson family and the wonderful display made by parent, Jon Peacock, was there for all to enjoy.

Easter Lenten message board

The St Peter's School & PTA blackboard became a beacon of positivity during lent. Messages from the teaching staff as well as those sent in by parents/carers were written up, every day from Ash Wednesday to Easter Sunday.

Summer Fete - £5,454

On the 25th June 2022 the Summer Fete made a spectacular comeback. Carefully curated by Nancy Harman the Fete was a superb blend of large, show stopper stalls (Zorbing) and smaller free events (Circus Skills and Mini-Professors). The atmosphere was wonderful and the team of volunteers excelled themselves with special thanks to the Shepherd family for their dedication to the 'Toy Stall' and to the 'plant stall' organisers who started planning, cultivating and securing donations just after Christmas. The 'experienced' supported the 'not-so-experienced' and created a day of great fun and

entertainment. We enjoyed the involvement of school staff who performed wonderfully on the Bar, Games pitch and even created their own competition (Guess the shoe). The event continues to be a real combined effort, giving true meaning to Parent, Teacher Association.

Smaller, dependable funding streams performed well during the year. Our thanks again to Janet Urquhart for coordinating a new type of 2nd hand uniform sale and thanks to Evy Obert and Cat Felstead for running 100 Club. With the profit made on both bigger and smaller events we were able to fund all our commitments for the school this year as well as securing a healthy pot of money for future school investment.

This year the PTA bought a beautiful new piano for the music department, helped buy bibles for pupils, prayer books for reception classes, small wooden crosses for school leavers and part funded the fabulous school summer performance of the Jungle Book. The PTA also invested in an event marquee as the previous one went into well earned retirement.

The effort this year has generated a lot of interest in the PTA from cohorts lower down the school which is welcome to those now intending to step down from 'Office Holder' duties on the PTA. Our PTA is something to be proud of and we look forward to working with the school to use our funds to support the education and environment of our students. We continue to draw upon the experience and creativity of our Teachers and Parents to help support the children. All ideas are welcome and the door is always open to anyone wanting to join the committee.
