Accounts

BEHT Annual Report April 2024 to March 2025

Reserves Policy:

BEHT does not employ staff or own property. The trustees undertake all the work voluntarily for which they do not claim any remuneration or personal expenses. The funds donated are for specific purposes related to BEHT's objectives, and BEHT ensures that they are expended for those purposes as soon as is practicable. There is therefore no necessity for the trustees to hold unrestricted reserves. As a rule, restricted funds are also not held for extended periods of time.

Grant Making Policy:

The Trustees raise funds and make grants to other charities in line with BEHT's charitable objectives in India.

Charity's activities and achievements during the year:

BEHT raised £ 147,621 in 2024-5 of which £ 147,304 were donations and £ 317 was through bank interest received.

BEHT donated £ 2,476 towards sponsorship for educating under privileged children projects in India. Normally, much bigger amount would be donated towards the education project but due to the issue with FCRA certification for BET & HAT (Indian sister charities), funds have not been transferred. Hopefully, this will be resolved soon and the intended amounts will be donated.

2024 was a difficult year for two of our trustees. Ajay Gudka suffered a cardiac arrest in December 2023 and he has undergone an open-heart bypass surgery in May 2024. Meena Modi has also undergone an open-heart surgery in April 2024. Luckily, both have recovered well and are back to normal health. Due to this, BEHT did not hold its annual event at the end of 2024.

Investments Selection Policy:

BEHT receives funds for specific purposes, which it aims to pay out as soon as practicable. Thus, surplus cash funds are only invested on a short-term basis in a deposit account at the best rates available.

Review of Major Risks:

BEHT does not hold any tangible assets or employ staff. In respect of the funds which are donated to BEHT for specific purposes, the trustees and major donors make regular visits to India and ensure that funds are being spent for the purposes for which they have been given. They identify future requirements, take photographic evidence of progress made and report to donors in the UK by way of email, website, newsletter and at events through presentations.

BEHT Annual Report April 2023 to March 2024

Reserves Policy:

BEHT does not employ staff or own property. The trustees undertake all the work voluntarily for which they do not claim any remuneration or personal expenses. The funds donated are for specific purposes related to BEHT's objectives, and BEHT ensures that they are expended for those purposes as soon as is practicable. There is therefore no necessity for the trustees to hold unrestricted reserves. As a rule, restricted funds are also not held for extended periods of time.

Grant Making Policy:

The Trustees raise funds and make grants to other charities in line with BEHT's charitable objectives in India.

Charity's activities and achievements during the year:

BEHT raised £ 104,766 in 2023-4 of which £ 104,636 were donations and £ 130 was through bank interest received.

BEHT donated £ 86,050 towards sponsorship for educating under privileged children projects in India.

BEHT managed to publish its annual newsletter which was distributed to our database of about seven hundred persons electronically.

BEHT could not hold its annual event at the end of 2023 due to the issues with the Bushey Arena venue which was booked quite early on in the year. Without any notice, the venue cancelled our booking stating staffing issue. Efforts were made to contact the venue management but that proved difficult as well.

Investments Selection Policy:

BEHT receives funds for specific purposes, which it aims to pay out as soon as practicable. Thus, surplus cash funds are only invested on a short-term basis in a deposit account at the best rates available.

Review of Major Risks:

BEHT does not hold any tangible assets or employ staff. In respect of the funds which are donated to BEHT for specific purposes, the trustees and major donors make regular visits to India and ensure that funds are being spent for the purposes for which they have been given. They identify future requirements, take photographic evidence of progress made and report to donors in the UK by way of email, website, newsletter and at events through presentations.

BEHT Annual Report April 2022 to March 2023

Reserves Policy:

BEHT does not employ staff or own property. The trustees undertake all the work voluntarily for which they do not claim any remuneration or personal expenses. The funds donated are for specific purposes related to BEHT's objectives, and BEHT ensures that they are expended for those purposes as soon as is practicable. There is therefore no necessity for the trustees to hold unrestricted reserves. As a rule, restricted funds are also not held for long periods of time.

Grant Making Policy:

The Trustees raise funds and make grants to other charities in line with BEHT's charitable objectives in India.

Charity's activities and achievements during the year:

After the covid pandemic, 2022 was the year of recovery. Gradually, all aspects of life returned to normal even though there was an underlying ease of venturing out in public places. BEHT held its annual event in November 2022, a musical evening with dinner. It was a sold-out event with 280 people. BEHT published its annual newsletter which was distributed to 5800 Oshwal addresses. This continued awareness of our activities in India has helped in receiving donations from a few new donors and many existing donors.

BEHT raised £ 139,940 in 2022-3 of which £ 132,818 were donations, £6,987 was raised through our event in November and £ 135 was through bank interest received.

BEHT donated £ 159,750 out of which, £ 139,750 went towards the Education projects of renovating Gir Ness schools and sponsorship for educating under privileged children and £ 20,000 towards the health and elderly welfare projects in India.

In India, the Gir Ness Schools programme was completed after almost two years. There were many issues with this project – covid, weather and strict Forestry Department regulations but in the end, total of 24 schools were renovated and handed over to the local Government. All these schools are primary schools from standard one to five, which only gives a basic education of reading, writing and arithmetic. Generally, it is believed that the local population which lives in the Gir forest, the Maldharis, do not study further. To encourage them to study further, BEHT with BET in India have agreed to help educate 100 of the Gir forest children to study further in our main school in Chaparda.

Investments Selection Policy:

BEHT receives funds largely for specific purposes, which it aims to pay out as soon as practicable. Thus, surplus cash funds are only invested on a short-term basis in a deposit account at the best rates available.

Review of Major Risks:

BEHT does not hold any tangible assets or employ staff. In respect of the funds which are donated to BEHT for specific purposes, the trustees and major donors make regular visits to India and ensure that funds are being spent for the purposes for which they have been given. They identify future requirements, take photographic evidence of progress made and report to donors in the UK by way of email, website, newsletter and at events through presentations.

BEHT Annual Report April 2021 to March 2022

Reserves Policy:

BEHT does not employ staff or own property. The trustees undertake all the work voluntarily for which they do not claim any remuneration or personal expenses. The funds donated are for specific purposes related to BEHT's objectives, and BEHT ensures that they are expended for those purposes as soon as is practicable. There is therefore no necessity for the trustees to hold unrestricted reserves. As a rule, restricted funds are also not held for long periods of time.

Grant Making Policy:

The Trustees raise funds and make grants to other charities in line with BEHT's charitable objectives in India.

Charity's activities and achievements during the year:

From March 2020, covid 19 virus has had a devastating effect on every aspect of life for everyone throughout the world. UK, like many other countries, went into a lockdown to prevent Coronavirus spreading. All activities came to a standstill and almost everyone was working from home until July 2021. After August, the lockdown was slowly eased over the next few months as most of the population was now fully vaccinated. There were still restrictions in place for large gatherings and, people were still bit wary of mixing in public. Hence, BEHT has had no events throughout this year but donations from regular donors continued to be received.

In India, it was a similar situation and normality started returning to all our schools from January 2022. BEHT with its Indian partner, BET, started the Gir Ness schools programme of helping to build or renovate schools in 25 settlements in the Gir Sanctuary in Gujarat. Gir is famous for its lions and the Government has created a sanctuary to protect the wildlife in this area. This area is strictly controlled with the Maldharis (local tribe) living in this area. Government has provided schools for this population but most were built about 50 years ago without any renovation since then. The Gir Ness project is to help renovate and where required, build new schools in 25 of these settlements.

The hospital has had a very busy period during the pandemic and did a wonderful job in helping covid patients at the height of the pandemic. Through the help of hundreds of donors in UK, BEHT managed to raise over £ 70,000 for an Oxygen plant which helped to save many lives.

Despite not having any events, BEHT managed to raise £ 203,623 through our Covid appeal. Out of this amount, BEHT donated £ 69,720 towards the Education & Gir Ness projects and £ 84,638 towards the health projects in India.

Investments Selection Policy:

BEHT receives funds largely for specific purposes, which it aims to pay out as soon as practicable. Thus, surplus cash funds are only invested on a short-term basis in a deposit account at the best rates available.

Review of Major Risks:

BEHT does not hold any tangible assets or employ staff. In respect of the funds which are donated to BEHT for specific purposes, the trustees and major donors make regular visits to India and ensure that funds are being spent for the purposes for which they have been given. They identify future requirements, take photographic evidence of progress made and report to donors in the UK by way of email, website, newsletter and at events through presentations.
