Fees are kept low in order to include all and many receive funded places. Support for children with SEN families in need. Before and after school club 1 locations. We still have not returned to the pre covid capacity of provision for Before and After School Clubs. Holiday Play Schemes - held over the majority of school closures. Children are given the opportunity to partake in sport, art and music activities. They are in a safe environment thus preventing them from roaming the streets or alone in an empty house. Social Services and CAMS (Children and Mental Health) refer families in need. The Play Schemes have still not returned to the pre covid capacity of provision Forest School Training and Parent Courses - for both staff and families, regular contact with parents allow us to identify where intervention and support is required.

Para 1.20	<p>Grove Community Project is now in its 29^h year</p> <p>The past year has continued to be a challenge with continued Covid infections and staff isolating. We still have not resumed all services prior to Covid, as demand has been down and we have been mindful of the increased risk of staff absentee resulting from children attending from different schools and ages. Parents continue to work from home wherever possible which allows them to look after their children at the same time and save on Childcare costs.</p> <p>We continue to offer specific expertise in supporting children with SEN and take referrals from other professionals.</p> <p>We continue to assess and refer children with specific needs to the relevant agencies, then work together in development of individual plans. Equally important is the support that we offer to the families of these children.</p> <p>Families in need or crisis are offered support and can access a free place.</p> <p>The majority of our children have English as a second language. Specialist Teachers focus on communication, language and literacy and the benefits are clearly seen.</p> <p>Music and singing is an important part of our curriculum, families attend weekly sessions where they share music and rhyme in their home language.</p> <p>We promote a healthy lifestyle and living for all our children and families. Staff access</p>

		<p>training and deliver workshops to parents around healthy eating and oral health. The stability of staff remain a great asset, alongside a shared passion to embrace the Reggio Emilia approach to Early Years Education. Our outside space, an outdoor classroom and Forest School is an important part of our teaching (most of our children have no access to outdoor space at home) We provide suitable waterproof clothing for them. Trips to the local Botanical Gardens where the children can experience a natural environment, go on Nature Trails and build dens has been proven to enhance the learning and development of the children. Participation in local networks enables us to create relationships with local groups and schools, allowing us to share information and practice that benefits all.</p> <p>Much of our After School and Holiday Playschemes have been on hold over the pandemic, we have reopened one of our After School provision which is restricted to just one school.</p> <p>Our last Ofsted inspection rated us as Good and we had a new routine inspection at our After School Club that confirmed we meet all the statutory requirements</p>




