**Trustees' annual report
For the year ended 5 April 2023**

The trustees are pleased to present their annual report together with the financial statements of the charity for the year ending 5 April 2023.

Structure Governance & Management

The organisation was registered with the Charity Commission on 11 January 1999 under a declaration of trust dated 5 November 1998.

The trustees are required to meet at least twice a year. The trustees are generally responsible for the running of the trust with most of the day to day work completed by the chair of trustees and secretary. The other trustees support this where necessary.

Objects and activities

Service of Hope is a UK based trust that raises money to support work with vulnerable groups in the North East of Brazil. The charitable objects are:

- to further the religious and other charitable work of the Anglican Episcopal church in the territory covered by the diocese of North East Brazil as at 5 November 1998
- to relieve persons resident in the country of Brazil who are in conditions of need hardship or distress by reason of their social and economic circumstances

The charity's main sources of income come from regular donations from individuals, churches and religious groups from across the UK. The trustees have general powers to raise and receive funds and apply them to the objects of the Charity.

Currently, grants are given to support the work of a non-governmental project in Olinda, Brazil called "Casa de Meu Pai" (My Father's House). The project was founded by Ian and Simea Meldrum, Anglican vicars, who work with people who live in local deprived communities in Olinda, in the state of Pernambuco. Their work supports vulnerable children and families at risk. The Non-Governmental Organisation (NGO) is now primarily run by a team of workers, a group of non-executive directors and the President Ian Meldrum. Over the years it has moved from being based in a house, offering accommodation to boys at risk, to now being fully focused on delivering community programmes in locally deprived areas of the city. This is often done in partnership with other organisations and churches, and includes delivering a wide range of classes, holiday clubs, homework clubs, parental support and cooking classes and general social care support to families and children using community centres.

Objects and activities (continued)

In practise the donations from individuals are given primarily to support the work of the “My Father’s House” project, although it does also have the ability to offer Grants to other organisations fulfilling the objectives should the trustees choose. A small amount from donations goes towards the administration of Service of Hope. Currently, it has been decided that Service of Hope will continue to only support My Father’s House, due to the limited funds that are being raised by the charity. Donors understand that administration costs incurred by the charity will be funded from gift aid reclaimed and any unrestricted donations.

Summary of the main activities

£25,994 has been donated to Service of Hope during this year. This has included donations from individuals, churches, and other religious organisations supporting the work. Although some regular donations have continued, Service of Hope has continued to see a decline in donations. As the Cost of Living Crisis in the UK continues and becomes worse, the charity is continuing to see the repercussions of this through regular monthly donors decreasing amounts or stopping donating all together.

During 2022-2023 recruiting Trustees to support this work still proves difficult. The difficulties of this are connected with the primary support for the work coming from elderly people, who are either too old to support practically or lack the experience of working digitally that is required. With the ongoing Trustee concern and a decrease in donations these areas currently hold the biggest risk for the charity. As with previous years, ongoing conversations are continuing between Service of Hope and My Father’s House around these issues, and grants will only be given inline with the donations Service of Hope is receiving. A meeting took place in the UK with Ian Meldrum (My Father’s President) this year to discuss these issues and concerns, and he was made aware that the monthly grant to the project might decrease.

Financial summary

The charity received £24,846 in donations towards the work of the charity. £24,126 of these donations have been treated as restricted donations, specifically for the My Father’s House project in Olinda. The charity also received £1,148 from gift aid claims during this period.

Reserves policy

Free reserves at 5 April 2023 were £6,403 (2022: £5,387).

The trustees consider that, due to the grant-making nature of the charity, that free reserves should be sufficient to cover any outstanding liabilities at the year end. Any reserves after liabilities will be put towards grants given for the following year.

Future Plans – 2023-2024

The Trustees have so far not been successful in raising the profile of the charity and in seeking new Trustees to work with Service of Hope. The Trustees are aware of the risks this is causing and are working closely with My Father's House to make sure that they are also aware of this. As a part of this we have decreased the monthly grant to My Father's House to make sure that it is reflective of the donations coming in.

Towards the end of this financial year Trustees met and discussed the possibility of closing Service of Hope down within the next 18 months and according to donations decreasing further to Service of Hope. This is being monitored closely and grant donations to My Father's House have been decreased in order to enable Service of Hope to continue supporting the work in Brazil for as a long as possible. Formal procedures for closing that charity have not been started yet, but it is being discussed and explored as an option. Ongoing reviews around this will take place through 2023 – 2024 between the Trustees and My Father's House. Trustees are currently clear that Service of Hope is at risk and are working to manage this and review the options to the charity appropriately



Currently, it has been decided that Service of Hope will continue to only support My Father's House, due to the limited funds that are being raised by the charity. Donors understand that administration costs incurred by the charity will be funded from gift aid reclaimed and any unrestricted donations.

Following from the Covid Pandemic in 2020-2021, My Father's House continued to deliver activities in a safe way, gradually increasing the number of individuals allowed in sessions, according to the Brazilian Covid guidelines. This year also saw some major flooding in Olinda, and so further food packages were given out by the charity to the communities they are working with.

Summary of the main activities

£26,296 has been donated to Service of Hope during this year. This has included donations from individuals, churches, and other religious organisations supporting the work. Service of Hope continues to get regular donations through these methods, which include regular monthly donors, but has seen a decrease in the regular giving this financial year. This may be due to the aftermath of Covid-19 Pandemic from individuals not being able to afford to give regularly anymore. We are also aware that many of our supporters are elderly and may have been affected by the Pandemic negatively.

During 2021-2022 recruiting Trustees to support this work still proves difficult. The difficulties of this are connected with the primary support for the work coming from elderly people, who are either too old to support practically or lack the experience of working digitally that is required. The biggest current risk to the charity acknowledged by the Trustees is currently its succession and elder supporters and deceased donors. The trustees continue to maintain conversations with My Father's House and review the situation regularly, both from the perspective of My Father's House and Service of Hope. This year, this included an in person meeting with Ian Meldrum in the UK where the future plans of the project were discussed. The trustees continue to review this situation and to seek out potential Directors. The Sheffield based social enterprise A Mind Apart, has had Service of Hope as their supported charity for many years. Trustees have discussed the possibility of working with A Mind Apart to bring in new trustees, using their contacts and appealing to those that work with A Mind Apart, as a clear connection to the work. This will be explored further during 2022-2023.

We will continue to engage directly with My Father's House Management in Brazil via video conferencing and other digital means as well as in person where possible.

Donations have dropped during 2021-2022, and the Trustees will continue to monitor the situation accordingly. The Trustees are aware of the need to increase the profile of the work to attract new donors and new trustees, and will look at ways to do this during 2022-2023. My Father's House will continue to receive a monthly grant of £2,200, but it has been agreed that this will be reviewed periodically and may change according to Service of Hope's financial situation throughout the year.





The project was founded by Ian and Simea Meldrum, Anglican vicars, who work with people who live in a shanty town at the Church called Agua Viva (Living Waters). Their work is about supporting homeless children at risk and families who are very poor with no love in their lives. The Non-Governmental Organisation (NGO) is now primarily run by a team of workers, a group of non-executive directors and the President Ian Meldrum.

In practise the donations from individuals are given primarily to support the work of the "My Father's House" project, although it does also have the ability to offer Grants to other organisations fulfilling the objectives should the trustees choose. Currently, it has been decided that Service of Hope will continue to only support My Father's House, due to the limited funds that are being raised by the charity. Donors understand that administration costs incurred by the charity will be funded from gift aid reclaimed and any unrestricted donations.

During 2020-2021 the global Pandemic, Covid-19 continued to affect both the UK and Brazil. The work at My Father's House was able to continue for much of the year due to working with vulnerable groups within Olinda. During lockdown, the organisation organised and delivered food parcels and made visits to families as permitted by Brazilian laws. As soon as they were able to, in line with Brazilian national and local laws, they resumed controlled face-to-face work. Digital exclusion is a big issue across Brazil, so face-to-face work became increasingly necessary for My Father's House

Objects and activities (continued)

The international move to a more digital way of working did allow for the Service of Hope Trustees to connect virtually with the precedent of the project, which helped to increase communication between Service of Hope and My Father's House. We hope to continue this way of working, whilst it is not possible to easily travel to the UK or Brazil.

Summary of the main activities

£29,250 has been granted to Service of Hope during this year. These grants have included donations from monthly grant commitments and extra donations during November and December to support the extra costs required during the Christmas period. Some of this extra donation was given from a Sheffield based company called Yes Tax who wanted to support the work of the project in Brazil. Service of Hope has received other donations from individuals, churches and groups to support this work, and continues to get regular donations through these methods, which include regular monthly donors.

During 2020-2021 recruiting Trustees to support this work still proves difficult. The difficulties of this are connected with the primary support for the work coming from elderly people, who are either too old to support practically or lack the experience of working digitally that is required. The biggest current risk to the charity acknowledged by the Trustees is currently it's succession and elder supporters and donors deceasing. The trustees continue to maintain conversations with My Father's House and review the situation regularly, both from the perspective of My Father's House and Service of Hope. Historically supporters have been gained from UK volunteers and church groups visiting the project in Brazil short term and choosing to support it financially when they have returned. Due to Covid, this has not been possible, and thus any hopes to explore a volunteer programme has been paused. The Secretary, instead, is working with My Father's House to deliver some online meetings with My Father's House for those supporting and interested in supporting the work in the UK.

In planning our activities, the trustees have considered the Charity Commission's guidance on public benefit and have considered the Charity Commission guidance on working internationally.

Financial summary

The charity received £29,250 in donations towards the work of the charity. £28,720 of these donations have been treated as restricted donations, specifically for the My Father's House project in Olinda. The charity also received £2,936 from gift aid claims during this period. £747 was spent on the administrator and other office/general expenses.

Reserves policy

Free reserves at 5 April 2021 were £5,076 (2020: £2,777).

The trustees consider that, due to the grant-making nature of the charity, that free reserves should be sufficient to cover any outstanding liabilities at the year end. Any reserves after liabilities will be put towards grants given for the following year.

Future Plans – 2021-2022


In light of Covid-19 the trustees continue to review the safeguarding practices of Service of Hope and the project supported. We will continue to engage directly with My Father's House Management in Brazil via video conferencing and other digital means, whilst travel is restricted between the UK and Brazil. Due to Brazil managing the Covid-19 situation differently to the UK, it is felt that it would not be sensible to travel to Brazil whilst they are still coping with the pandemic and making sure the country is vaccinated. We will continue to review this periodically.

There was not a drop in donations during 2020-2021, but we have seen a drop of donations in 2021-2022 thus far. This has meant that the charity may complete 2022 with less money in reserves. Because of this, we are prioritising communication with donors and encouraging them to engage with us and My Father's House through video meetings, where the President of My Father's House can share with donors and others interested in the work virtually. Priority will also be given during 2021-2022 to updating the website and social media content.

In years where donor levels drop, expense levels also drop accordingly, with Grant giving to My Father's House being reviewed periodically. Grants are only committed to when there are sufficient funds.

As the charity trustees of the Charity you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ('the Act').


