The Trustees are pleased to present their annual report along with the financial statements of The Broad Cairn Foundation for the year ended 31 December 2024.

STRUCTURE, GOVERNANCE AND MANAGEMENT

a) Constitution

The charity was formed under a Declaration of Trust dated 14 January 1999.

The Trustees who served during the year and to the date of signing this report were:

No Trustee had any interests in the charity.

b) Method of election of Trustees

New or additional Trustees are appointed by deed. Every future Trustee must sign a declaration of willingness to act as a Trustee before he or she is eligible to vote at any meeting of the Trustees. The current Trustees ensure that an appropriate induction programme is undertaken in the event of a new appointment. To date, Trustees have been recruited with their specific skills and experience in mind, although further training is undertaken where necessary.

c) Organisational structure and decision making

The Foundation's principal office is 10 New Square, Lincoln's Inn, London WC2A 3QG.

The Trustees meet at least once a year to consider appeals for grants, the current and future financial position of the Foundation and longer term strategy. Day to day responsibility for the running of the Foundation has been delegated to a small team of suitably qualified individuals employed by the Grosvenor Family Office by way of an annual service agreement, with an annual management fee being charged.

The Foundation does not employ any staff directly.

The Foundation has regard to the seven principles of good governance and best practice which are set out in the Charity Governance Code.

d) Risk Management

The major risks to which the charity is exposed as identified by the Trustees have been reviewed, and procedures have been established to mitigate those risks.

The key risks that have been identified and which are carefully monitored are:

- Poor performance of the investment portfolio leading to a material financial loss of our main source of funding. This has been mitigated by diversification of investments and regular performance monitoring;
- Risk of fraud or failure of internal financial controls which is mitigated by shared authorisation procedures; and
- Misappropriation of grant funding which is mitigated by due diligence in advance of awarding funds and receipt of an impact report for grants greater than £5,000.

A full risk assessment is undertaken on an annual basis by the Trustees.

OBJECTIVES AND ACTIVITIES

a) Objectives

Objectives (as set out in the Trust Deed) are that the assets of the charity are held on trust for such exclusively charitable objects or purposes in any part of the world as the Trustees may from time to time determine.

b) Aims

The charity is a grant making foundation that aims principally to address social welfare issues by supporting appropriate registered charities.

c) Statement of public benefit

The Trustees confirm they have paid due regard to the guidance produced by the Charity Commission when reviewing the Foundation's aims and objectives and are satisfied that the charitable activities and projects funded through grant making are of direct benefit to the public. The Trustees' responsibility is to ensure that the monies are being spent in line with the charity's aims and objectives. For grants greater than £5,000 the Trustees request an impact report from the recipient charities explaining how the donation has been utilised.

d) Grant Making Policy

The Foundation concentrates its grant making activities almost exclusively on smaller charities where its contribution can make a real difference. The Trustees' grant making priorities are:

- ***Disadvantaged Children and Young People.***
To help disadvantaged young people and to enable them to participate in society by providing support and activities which develop their skills, confidence and aspiration.
- ***Third World infrastructure and development.***
To assist charities supporting the third world, especially those supporting infrastructure such as clean water and agricultural improvements.
- ***Conservation and sustainable development.***
To help promote conservation and the sustainable use of the world's scarce resources for the benefit of those whose lives depend on them and for future generations.
- ***Heritage.***
To support the renovation and conservation of historic buildings and monuments.

Support is given mainly by grants to appropriate registered charities. On occasion, the Foundation may support charities that are exempt or exempted from registration, or projects where the grant is for an exclusively charitable purpose. Proposals are likely to be invited by the Trustees, and in general the Foundation does not fund unsolicited appeals. Grants are not made to individuals.

ACHIEVEMENTS AND PERFORMANCE

a) Review of activities and financial review

The financial statements below give details of the financial transactions in the year and the financial position at the year end.

Total income for the year of £74,026 (2023: £96,859) was £22,833 lower due to a reduction in donations received of £24,856 offset by £2,023 increased investment income. Expenditure totalling £26,595 was £30,787 lower (2023: £57,382), largely due to a decrease in grant making of £31,336. Grants totalling £16,100 (2023: £47,436) were awarded during the year.

ACHIEVEMENTS AND PERFORMANCE (CONTINUED)

Nine grants were awarded, with an average size of £1,789. The largest grant was £10,000 to The Grand Bahama Children's Home, which provides a haven for children in the Northern Bahamas. The charity has provided care for over a thousand children since its establishment almost 50 years ago.

The distribution target (for funding of grant making and support costs) which is based on 4% of the opening investment portfolio value, was £55,000 for the year. Actual expenditure on charitable activities of £23,239 was under target and the Trustees will seek to rectify this as soon as possible in future financial years.

b) Investment policy and performance

The Trustees have wide investment powers and a policy of seeking a fair balance between capital growth and income yield.

The market value of investments (including cash held within the portfolio) increased to £1,451,859 (2023: £1,375,093), an increase of 5.6%. The overall return for the year was 8.1% compared to a benchmark return of 6.5% (CPI plus 4%).

Since 2022, the investments have been held in Cazenove's Charity Sustainable Multi-Asset Fund. The Trustees met with Cazenove during the year to discuss asset allocation and performance and will continue to monitor performance going forward.

OTHER

a) Reserves policy

The Foundation's funds are all unrestricted and may be used in furtherance of its charitable objects. The risk associated with not having adequate reserve balances is therefore considered to be low.

The Trustees policy is to retain 12 months of funding in cash, being approximately £58,000 based on year end investment values. The cash balance held of £98,693 was more than this due to lower charitable expenditure in the year.

The investment portfolio is held in funds which have daily liquidity should any unforeseen circumstances arise.

At the balance sheet date, the Trustees are satisfied that the current level of available funds meets the Foundation's requirements. Unrestricted funds at 31 December 2024 are £1,546,405 (2023: £1,442,402).

b) Plans for future periods

The Trustees will continue to support the activities set out above by the awarding of grants.

c) Going concern

Having considered the charity's reserves and commitments, the Trustees believe that the Foundation will be able to maintain positive cashflows for at least 12 months from the date of signing the financial statements. As a result, the going concern basis of accounting remains appropriate.

d) Auditor

A resolution for the reappointment of UHY Hacker Young as the charity's auditor will be proposed at a future Trustee meeting.

Opinion

We have audited the financial statements of The Broad Cairn Foundation ("the charity") for the year ended 31 December 2024 which comprise the Statement of Financial Activities, the Balance Sheet and notes to the financial statements including significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" (United Kingdom Generally Accepted Accounting Practice).

In our opinion the financial statements:

- give a true and fair view of the state of the charity's affairs as at 31 December 2024 and of the charity's incoming resources and application of resources for the year then ended;
- have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice; and
- have been prepared in accordance with the requirements of the Charities Act 2011.

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (UK) (ISAs (UK)) and applicable law. Our responsibilities under those standards are further described in the auditor's responsibilities for the audit of the financial statements section of our report.

We are independent of the charity in accordance with the ethical requirements that are relevant to our audit of the financial statements in the United Kingdom, including the Financial Reporting Council's (the 'FRC's') Ethical Standard, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Conclusions relating to going concern

In auditing the financial statements, we have concluded that the trustees' use of the going concern basis of accounting in the preparation of the financial statements is appropriate.

Based on the work we have performed, we have not identified any material uncertainties relating to events or conditions that, individually or collectively, may cast significant doubt on the charity's ability to continue as a going concern for a period of at least twelve months from when the financial statements are authorised for issue.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the course of the audit or otherwise appears to be materially misstated. If we identify such material inconsistencies or apparent material misstatements, we are required to determine whether there is a material misstatement in the financial statements or a material misstatement of the other information. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact.

We have nothing to report in this regard.

Responsibilities of trustees

As explained more fully in the trustees' responsibilities statement, the trustees are responsible for the preparation of the financial statements and for being satisfied that they give a true and fair view, and for such internal control as the trustees determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the trustees are responsible for assessing the charity's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the trustees either intend to liquidate the charity or to cease operations, or have no realistic alternative but to do so.

Auditors' responsibilities for the audit of the financial statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs (UK) will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

Irregularities, including fraud, are instances of non-compliance with laws and regulations. We design procedures in line with our responsibilities, outlined above, to detect material misstatements in respect of irregularities, including fraud. The extent to which our procedures are capable of detecting irregularities, including fraud is detailed below.

How the audit was considered capable of detecting irregularities, including fraud:

Our approach to identifying and assessing the risks of material misstatement in respect of irregularities, including fraud and non-compliance with laws and regulations was as follows:

- we identified the laws and regulations applicable to the charity through discussions with management, and from our commercial knowledge and experience in the sector;
- we focused on specific laws and regulations which we considered may have a direct material effect on the accounts or the operations of the charity, including the Charities Act 2011;
- we assessed the extent of compliance with the laws and regulations identified above through making enquiries of management and inspecting correspondence; and
- identified laws and regulations were communicated within the audit team and the team remained alert to instances of non-compliance throughout the audit.

We assessed the susceptibility of the charity's accounts to material misstatement, including obtaining an understanding of how fraud might occur, by:

- making enquiries of management as to where they considered there was susceptibility to fraud, their knowledge of actual, suspected and alleged fraud; and
- considering the internal controls in place to mitigate risks of fraud and non-compliance with laws and regulations.

To address the risk of fraud through management bias and override of controls, we:

- performed analytical procedures to identify any unusual or unexpected relationships;
- tested journal entries to identify unusual transactions;
- assessed whether judgements and assumptions made in determining the accounting estimates set out in the accounting policies were indicative of potential bias, and
- investigated the rationale behind significant or unusual transactions.

In response to the risk of irregularities and non-compliance with laws and regulations, we designed procedures which included, but were not limited to:

- agreeing financial statement disclosures to underlying supporting documentation;
- reading minutes of meetings of those charged with governance; and
- enquiring of management as to actual and potential litigation and claims.

There are inherent limitations in our audit procedures described above. The more removed that laws and regulations are from financial transactions, the less likely it is that we would become aware of non-compliance. Auditing standards also limit the audit procedures required to identify non-compliance with laws and regulations to enquiry of the trustees and other management and the inspection of regulatory and legal correspondence, if any.

Material misstatements that arise due to fraud can be harder to detect than those that arise from error as they may involve deliberate concealment or collusion.

NOTES TO THE FINANCIAL STATEMENTS YEAR ENDED 31 DECEMBER 2024

1. GENERAL INFORMATION

The Broad Cairn Foundation is an unincorporated charity registered in England and Wales (charity number 1073929), governed by its Declaration of Trust. Its principal office is 10 New Square, Lincoln's Inn, London WC2A 3QG.

2. ACCOUNTING POLICIES

(a) Basis of preparation

The financial statements have been prepared under the historical cost convention, as modified by the revaluation of fixed asset investments, and in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard in the UK and Republic of Ireland Charities SORP (FRS 102) (second edition - October 2019), the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland 102 (FRS102) (January 2022) and the Charities Act 2011.

The functional currency of the Foundation is in pounds sterling as the Foundation operates and receives income in the UK and the accounts have been rounded to the nearest pound.

The charity constitutes a public benefit entity as defined by FRS 102.

The financial statements have been prepared to give a 'true and fair view' and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair' view. This departure has involved following the Charities SORP (FRS102) rather than the Accounting and Reporting by Charities: Statement of Recommended Practice (SORP 2005), which has since been withdrawn.

The principal accounting policies are set out below.

(b) Going concern

The charity's activities, together with the factors likely to affect its future development, performance and position are set out in the Trustees Report which also describes the financial position of the charity including its cash, investments, distributions and reserves policy. Taking these into consideration and the fact that all funds are unrestricted, the Trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. Therefore, the Trustees consider there to be no material uncertainties and they continue to adopt the going concern basis of accounting in preparing the annual report and financial statements.

(c) Investments

Listed investments are valued at the market price from a recognised stock exchange at the balance sheet date. Realised and unrealised gains and losses on investments are included in the Statement of Financial Activities.

Realised gains and losses on investments are calculated as the difference between sale proceeds and opening market value (or value at the date of purchase if later). Unrealised gains and losses are calculated as the difference between the market value at the year end and opening market value (or value at the date of purchase if later).

Investment management fees are included in the Statement of Financial Activities as cost of raising funds. Third party charges on the underlying assets are reflected in the fund valuations and are not paid directly to the managers.

(d) Income and Expenditure

Income is accounted for in the Statement of Financial Activities when the Foundation is legally entitled to the income, and the amount can be quantified with reasonable accuracy and is probable to be received. Income from investments is treated as receivable when the investment is quoted ex-dividend. Donation income is recognised in the Statement of Financial Activities in the period that it is received. Other income and all expenditure are accounted for on an accruals basis. Grants payable are payments made to third parties in the furtherance of the charitable objects of the Trust. Costs of raising funds comprise investment management costs associated with managing the Foundation's investments.

Included in charitable expenditure are the audit fee and management fee which are allocated to charitable activities.

Expenditure includes attributable VAT which cannot be recovered.

(e) Taxation

On the basis that the activities fall within charitable purposes and the funds are applied only for these purposes, no provision for taxation is made.

(f) Fund Accounting

All funds are unrestricted and can be used in accordance with the Foundation's charitable objects at the discretion of the Trustees.

(g) Financial Instruments

Financial assets and financial liabilities are recognised when the charity becomes a party to the contractual provisions of the instrument.

Investments are initially recognised at transaction value and subsequently measured at fair value.

Other debtors are recognised at the settlement amount due. Cash at bank and cash in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account. Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

(h) Critical accounting judgements and key sources of estimation uncertainty

In the application of the charity's accounting policies, the Trustees are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

NOTES TO THE FINANCIAL STATEMENTS (CONTINUED) YEAR ENDED 31 DECEMBER 2024

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

The Trustees do not consider there are any critical judgements or sources of estimation uncertainty requiring disclosure.

The Trustees are pleased to present their annual report along with the financial statements of The Broad Cairn Foundation for the year ended 31 December 2023.

STRUCTURE, GOVERNANCE AND MANAGEMENT

a) Constitution

The charity was formed under a Declaration of Trust dated 14 January 1999.

The Trustees who served during the year and to the date of signing this report were:

Rebecca Priestley

No Trustee had any interests in the charity.

b) Method of election of Trustees

New or additional Trustees are appointed by deed. Every future Trustee must sign a declaration of willingness to act as a Trustee before he or she is eligible to vote at any meeting of the Trustees. The current Trustees ensure that an appropriate induction programme is undertaken in the event of a new appointment. To date, Trustees have been recruited with their specific skills and experience in mind, although further training is undertaken where necessary.

c) Organisational structure and decision making

The Foundation's principal office is 10 New Square, Lincoln's Inn, London WC2A 3QG.

The Trustees meet at least once a year to consider appeals for grants, the current and future financial position of the Foundation and longer term strategy. Day to day responsibility for the running of the Foundation has been delegated to a small team of suitably qualified individuals employed by the Grosvenor Family Office by way of an annual service agreement, with an annual management fee being charged.

The Foundation does not employ any staff directly.

The Foundation has regard to the seven principles of good governance and best practice which are set out in the Charity Governance Code.

d) Risk Management

The major risks to which the charity is exposed as identified by the Trustees have been reviewed, and procedures have been established to mitigate those risks.

The key risks that have been identified and which are carefully monitored are:

- Poor performance of the investment portfolio leading to a material financial loss of our main source of funding. This has been mitigated by diversification of investments and regular performance monitoring;
- Risk of fraud or failure of internal financial controls which is mitigated by shared authorisation procedures; and
- Misappropriation of grant funding which is mitigated by due diligence in advance of awarding funds and receipt of an impact report for grants greater than £5,000.

A full risk assessment is undertaken on an annual basis by the Trustees.

OBJECTIVES AND ACTIVITIES

a) Objectives

Objectives (as set out in the Trust Deed) are that the assets of the charity are held on trust for such exclusively charitable objects or purposes in any part of the world as the Trustees may from time to time determine.

b) Aims

The charity is a grant making foundation that aims principally to address social welfare issues by supporting appropriate registered charities.

c) Statement of public benefit

The Trustees confirm they have paid due regard to the guidance produced by the Charity Commission when reviewing the Foundation's aims and objectives and are satisfied that the charitable activities and projects funded through grant making are of direct benefit to the public. The Trustees' responsibility is to ensure that the monies are being spent in line with the charity's aims and objectives. For grants greater than £5,000 the Trustees request an impact report from the recipient charities explaining how the donation has been utilised.

d) Grant Making Policy

The Foundation concentrates its grant making activities almost exclusively on smaller charities where its contribution can make a real difference. The Trustees' grant making priorities are:

- ***Disadvantaged Children and Young People.***
To help disadvantaged young people and to enable them to participate in society by providing support and activities which develop their skills, confidence and aspiration.
- ***Third World infrastructure and development.***
To assist charities supporting the third world, especially those supporting infrastructure such as clean water and agricultural improvements.
- ***Conservation and sustainable development.***
To help promote conservation and the sustainable use of the world's scarce resources for the benefit of those whose lives depend on them and for future generations.
- ***Heritage.***
To support the renovation and conservation of historic buildings and monuments.

Support is given mainly by grants to appropriate registered charities. On occasion, the Foundation may support charities that are exempt or exempted from registration, or projects where the grant is for an exclusively charitable purpose. Proposals are likely to be invited by the Trustees, and in general the Foundation does not fund unsolicited appeals. Grants are not made to individuals.

ACHIEVEMENTS AND PERFORMANCE

a) Review of activities and financial review

The financial statements below give details of the financial transactions in the year and the financial position at the year end.

Total income for the year of £96,859 (2022: £40,793) was £56,066 higher due to donations received of £39,856 and £16,210 additional investment income (following the change in asset allocation during 2022). Expenditure totalling £57,382 was £8,863 higher (2022: £48,519), largely due to an increase in grant making of £9,196. Grants totalling £47,436 (2022: £38,240) were awarded during the year.

Sixteen grants were awarded, with an average size of £2,965. The following grants in excess of £5,000 were made: £10,000 to The UK Friends of Mustique (supports charitable causes in the islands of St Vincent and the Grenadines); £7,702 to Lancaster & District Homeless Action (support for homeless people in the Lancashire area); £7,702 to Escape 2 Make (wellbeing groups in the Lancaster district); £5,000 to BEST - Be a Better You (youth programmes in and around Swindon) and £5,000 to the Disasters Emergency Committee Turkey-Syria Earthquake Appeal.

The distribution target (for funding of grant making and support costs) was reviewed during the year and increased from 3% to 4% of the opening investment portfolio value. For 2023, this equated to £54,000. Expenditure on charitable activities of £54,060 was therefore in line with target.

b) Investment policy and performance

The Trustees have wide investment powers and a policy of seeking a fair balance between capital growth and income yield.

The market value of investments (including cash held within the portfolio) increased to £1,375,093 (2022: £1,344,588), an increase of 2.3%. The overall return for the year was 6.7% compared to a benchmark return of 7.8% (RPI plus 4%). The opening weighting to property contributed to the underperformance against benchmark, as did continued inflationary pressures throughout the year.

In 2022, the Trustees appointed Cazenove Capital as manager, having for many years held assets with Cazenove on a custody only basis. At the start of 2023, the assets were predominantly invested in Cazenove's Charity Sustainable Multi-Asset Fund with a legacy investment held in CCLA's COIF Charities Property Fund. This holding was realised during the year and reinvested in the Sustainable Multi-Asset Fund. The Trustees met with Cazenove during the year to discuss asset allocation and performance.

OTHER

a) Reserves policy

The Foundation's funds are all unrestricted and may be used in furtherance of its charitable objects. The risk associated with not having adequate reserve balances is therefore considered to be low.

The Trustees policy is to retain 12 months of funding in cash, being approximately £55,000 based on year end investment values. In January 2024, the Trustees agreed to invest £23,550 of the donations received in 2023 with Cazenove, bringing the cash balance more in line with target.

The investment portfolio is held in funds which have daily liquidity should any unforeseen circumstances arise.

At the balance sheet date, the Trustees are satisfied that the current level of available funds meets the Foundation's requirements. Unrestricted funds at 31 December 2023 are £1,442,402 (2022: £1,369,099).

b) Plans for future periods

The Trustees will continue to support the activities set out above by the awarding of grants.

c) Going concern

Having considered the charity's reserves and commitments, the Trustees believe that the Foundation will be able to maintain positive cashflows for at least 12 months from the date of signing the financial statements. As a result, the going concern basis of accounting remains appropriate.

d) Auditor

A resolution for the reappointment of UHY Hacker Young as the charity's auditor will be proposed at a future Trustee meeting.

Opinion

NOTES TO THE FINANCIAL STATEMENTS YEAR ENDED 31 DECEMBER 2023

1. GENERAL INFORMATION

The Broad Cairn Foundation is an unincorporated charity registered in England and Wales (charity number 1073929), governed by its Declaration of Trust. Its principal office is 10 New Square, Lincoln's Inn, London WC2A 3QG.

2. ACCOUNTING POLICIES

(a) Basis of preparation

The financial statements have been prepared under the historical cost convention, as modified by the revaluation of fixed asset investments, and in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard in the UK and Republic of Ireland Charities SORP (FRS 102) (second edition - October 2019), the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland 102 (FRS102) (January 2022) and the Charities Act 2011.

The functional currency of the Foundation is in pounds sterling as the Foundation operates and receives income in the UK and the accounts have been rounded to the nearest pound.

The charity constitutes a public benefit entity as defined by FRS 102.

The financial statements have been prepared to give a 'true and fair view' and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair' view. This departure has involved following the Charities SORP (FRS102) rather than the Accounting and Reporting by Charities: Statement of Recommended Practice (SORP 2005), which has since been withdrawn.

The principal accounting policies are set out below.

(b) Going concern

The charity's activities, together with the factors likely to affect its future development, performance and position are set out in the Trustees Report which also describes the financial position of the charity including its cash, investments, distributions and reserves policy. Taking these into consideration and the fact that all funds are unrestricted, the Trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. Therefore, the Trustees consider there to be no material uncertainties and they continue to adopt the going concern basis of accounting in preparing the annual report and financial statements.

(c) Investments

Listed investments are valued at the market price from a recognised stock exchange at the balance sheet date. Realised and unrealised gains and losses on investments are included in the Statement of Financial Activities.

Realised gains and losses on investments are calculated as the difference between sale proceeds and opening market value (or value at the date of purchase if later). Unrealised gains and losses are calculated as the difference between the market value at the year end and opening market value (or value at the date of purchase if later).

Investment management fees are included in the Statement of Financial Activities as cost of raising funds. Third party charges on the underlying assets are reflected in the fund valuations and are not paid directly to the managers.

(d) Income and Expenditure

Income is accounted for in the Statement of Financial Activities when the Foundation is legally entitled to the income and the amount can be quantified with reasonable accuracy and is probable to be received. Income from investments is treated as receivable when the investment is quoted ex-dividend. Other income and all expenditure are accounted for on an accruals basis. Grants payable are payments made to third parties in the furtherance of the charitable objects of the Trust. Costs of raising funds comprise investment management costs associated with managing the Foundation's investments.

Included in charitable expenditure are the audit fee and management fee which are allocated to charitable activities.

Expenditure includes attributable VAT which cannot be recovered.

(e) Taxation

On the basis that the activities fall within charitable purposes and the funds are applied only for these purposes, no provision for taxation is made.

(f) Fund Accounting

All funds are unrestricted and can be used in accordance with the Foundation's charitable objects at the discretion of the Trustees.

(g) Financial Instruments

Financial assets and financial liabilities are recognised when the charity becomes a party to the contractual provisions of the instrument.

Investments are initially recognised at transaction value and subsequently measured at fair value.

Other debtors are recognised at the settlement amount due. Cash at bank and cash in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account. Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

(h) Critical accounting judgements and key sources of estimation uncertainty

In the application of the charity's accounting policies, the Trustees are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

NOTES TO THE FINANCIAL STATEMENTS (CONTINUED) YEAR ENDED 31 DECEMBER 2023

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

The Trustees do not consider there are any critical judgements or sources of estimation uncertainty requiring disclosure.

The Trustees are pleased to present their annual report along with the financial statements of The Broad Cairn Foundation for the year ended 31 December 2022.

STRUCTURE, GOVERNANCE AND MANAGEMENT

a) Constitution

The charity was formed under a Declaration of Trust dated 14 January 1999.

The Trustees who served during the year and to the date of signing this report were:

No Trustee had any interests in the charity.

b) Method of election of Trustees

New or additional Trustees are appointed by deed. Every future Trustee must sign a declaration of willingness to act as a Trustee before he or she is eligible to vote at any meeting of the Trustees. The current Trustees ensure that an appropriate induction programme is undertaken in the event of a new appointment. To date, Trustees have been recruited with their specific skills and experience in mind, although further training is undertaken where necessary.

c) Organisational structure and decision making

The Foundation's principal office is 10 New Square, Lincoln's Inn, London WC2A 3QG.

The Trustees meet at least once a year to consider appeals for grants, the current and future financial position of the Foundation and longer term strategy. Day to day responsibility for the running of the Foundation has been delegated to a small team of suitably qualified individuals employed by the Grosvenor Family Office by way of an annual service agreement, with an annual management fee being charged.

The Foundation does not employ any staff directly.

The Foundation has regard to the seven principles of good governance and best practice which are set out in the Charity Governance Code.

d) Risk Management

The major risks to which the charity is exposed as identified by the Trustees have been reviewed, and procedures have been established to mitigate those risks.

The key risks that have been identified and which are carefully monitored are:

- Poor performance of the investment portfolio leading to a material financial loss of our main source of funding. This has been mitigated by diversification of investments and regular performance monitoring;
- Risk of fraud or failure of internal financial controls which is mitigated by shared authorisation procedures; and
- Misappropriation of grant funding which is mitigated by due diligence in advance of awarding funds and receipt of an impact report for grants greater than £5,000.

A full risk assessment is undertaken on an annual basis by the Trustees.

OBJECTIVES AND ACTIVITIES

a) Objectives

Objectives (as set out in the Trust Deed) are that the assets of the charity are held on trust for such exclusively charitable objects or purposes in any part of the world as the Trustees may from time to time determine.

b) Aims

The charity is a grant making foundation that aims principally to address social welfare issues by supporting appropriate registered charities.

c) Statement of public benefit

The Trustees confirm they have paid due regard to the guidance produced by the Charity Commission when reviewing the Foundation's aims and objectives and are satisfied that the charitable activities and projects funded through grant making are of direct benefit to the public. The Trustees' responsibility is to ensure that the monies are being spent in line with the charity's aims and objectives. For grants greater than £5,000 the Trustees request an impact report from the recipient charities explaining how the donation has been utilised.

d) Grant Making Policy

The Foundation concentrates its grant making activities almost exclusively on smaller charities where its contribution can make a real difference. The Trustees' grant making priorities are:

- ***Disadvantaged Children and Young People.***
To help disadvantaged young people and to enable them to participate in society by providing support and activities which develop their skills, confidence and aspiration.
- ***Third World infrastructure and development.***
To assist charities supporting the third world, especially those supporting infrastructure such as clean water and agricultural improvements.
- ***Conservation and sustainable development.***
To help promote conservation and the sustainable use of the world's scarce resources for the benefit of those whose lives depend on them and for future generations.
- ***Heritage.***
To support the renovation and conservation of historic buildings and monuments.

Support is given mainly by grants to appropriate registered charities. On occasion, the Foundation may support charities that are exempt or exempted from registration, or projects where the grant is for an exclusively charitable purpose. Proposals are likely to be invited by the Trustees, and in general the Foundation does not fund unsolicited appeals. Grants are not made to individuals.

ACHIEVEMENTS AND PERFORMANCE

a) Review of activities and financial review

The financial statements below give details of the financial transactions in the year and the financial position at the year end.

Total income for the year of £40,793 (2021: £53,156) was £12,363 lower due to a decrease in donations received of £20,000 offset by £7,637 additional investment income. Expenditure totalling £48,519 was £3,049 lower (2021: £51,568), largely due to a decrease in grant making of £2,660. Grants totalling £38,240 (2021: £40,900) were awarded during the year.

Thirteen grants were awarded, with an average size of £2,942. The largest grants were £10,000 to The Rainbow Centre (a local community organisation in Scarborough), £5,000 to Disaster Relief (for Queensland & New South Wales flood relief) and £4,998 to the Anton Mzimba Foundation Education Trust.

ACHIEVEMENTS AND PERFORMANCE (CONTINUED)

The distribution target for 2022 (for funding of grant making and support costs) was £45,000 (being 3% of the opening investment portfolio value in accordance with the Trustees' previously agreed distribution policy). Total expenditure of £48,519 was slightly above target.

b) Investment policy and performance

The Trustees have wide investment powers and a policy of seeking a fair balance between capital growth and income yield.

The market value of investments (including cash held within the portfolio) decreased to £1,344,588 (2021: £1,489,406), a decrease of 9.7%. The overall return was -7.5% compared to a benchmark of 17.4% (RPI plus 4%). The underperformance against the benchmark was due to the 10.5% increase in the consumer price index in the 12 months to December 2022 largely due to the soaring cost of energy and food, both attributable in part to the ongoing conflict in Ukraine. 2022 was a tumultuous year for stock markets in general with negative returns in almost all asset classes.

During the year, the Trustees reviewed the investment portfolio and after consideration of several investment proposals, agreed to appoint Cazenove Capital as manager. The portfolio had previously been held with Cazenove on a custody only basis and comprised several funds diversified across asset class. The portfolio is now largely invested in Cazenove's Charity Responsible Multi-Asset Fund.

OTHER

a) Reserves policy

The Foundation's funds are all unrestricted and may be used in furtherance of its charitable objects. The risk associated with not having adequate reserve balances is therefore considered to be low.

The Trustees policy is to retain 12 months of funding in cash, being approximately £40,000 based on year end investment values. The year-end cash balance of £41,079 is in line with this.

Furthermore, the investment portfolio is predominantly held in funds which have daily liquidity should any unforeseen circumstances arise.

At the balance sheet date, the Trustees are satisfied that the current level of available funds meets the Foundation's requirements. Unrestricted funds at 31 December 2022 are £1,369,099 (2021: £1,524,330).

b) Plans for future periods

The Trustees will continue to support the activities set out above by the awarding of grants.

c) Going concern

Having considered the charity's reserves and commitments, the Trustees believe that the Foundation will be able to maintain positive cashflows for at least 12 months from the date of signing the financial statements. As a result, the going concern basis of accounting remains appropriate.

d) Auditor

UHY Kent LLP trading as UHY Hacker Young were appointed as auditor in January 2023. A resolution for the reappointment of UHY Kent LLP as the charity's auditor will be proposed at a future Trustee meeting.

Statement of disclosure to the Auditor

As far as the Trustees are aware:

- there is no relevant audit information of which the charity's auditor is unaware; and
- the Trustees have taken all the steps that they ought to have taken as a Trustee to make themselves aware of any relevant audit information and to establish that the charity's auditor is aware of that information.

Opinion

Responsibilities of trustees

In preparing the financial statements, the trustees are responsible for assessing the charity's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the trustees either intend to liquidate the charity or to cease operations, or have no realistic alternative but to do so.

Auditor's responsibilities for the audit of the financial statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs (UK) will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

Irregularities, including fraud, are instances of non-compliance with laws and regulations. We design procedures in line with our responsibilities, outlined above, to detect material misstatements in respect of irregularities, including fraud. The extent to which our procedures are capable of detecting irregularities, including fraud is detailed below.

We assessed the susceptibility of the charity's accounts to material misstatement, including obtaining an understanding of how fraud might occur, by:

- making enquiries of management as to where they considered there was susceptibility to fraud, their knowledge of actual, suspected and alleged fraud; and
- considering the internal controls in place to mitigate risks of fraud and non-compliance with laws and regulations.

To address the risk of fraud through management bias and override of controls, we:

- performed analytical procedures to identify any unusual or unexpected relationships;
- tested journal entries to identify unusual transactions;
- assessed whether judgements and assumptions made in determining the accounting estimates set out in the accounting policies were indicative of potential bias, and
- investigated the rationale behind significant or unusual transactions.

1. ACCOUNTING POLICIES

(a) Basis of Accounting

The financial statements are prepared under the historical cost convention, with the exception of investments which have been included at market value, in accordance with the Statement of Recommended Practice "Accounting and Reporting by Charities (SORP 2019)" applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102), effective 1 January 2019.

The charity has taken advantage of the provisions in the SORP for charities applying FRS 102 Update Bulletin 1 not to prepare a Statement of Cash Flows.

The charity constitutes a public benefit entity as defined by FRS 102.

(b) Going concern

The charity's activities, together with the factors likely to affect its future development, performance and position are set out in the Trustees Report which also describes the financial position of the charity including its cash, investments, distributions and reserves policy. Taking these into consideration and the fact that all funds are unrestricted, the Trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. Therefore, the Trustees consider there to be no material uncertainties and they continue to adopt the going concern basis of accounting in preparing the annual report and financial statements.

The functional currency of the charity is pounds sterling as the charity operates and received income in the UK.

The principal accounting policies are set out below.

(c) Investments

Listed investments are valued at the market price from a recognised stock exchange at the balance sheet date. Realised and unrealised gains and losses on investments are included in the Statement of Financial Activities.

Realised gains and losses on investments are calculated as the difference between sale proceeds and opening market value (or value at the date of purchase if later). Unrealised gains and losses are calculated as the difference between the market value at the year end and opening market value (or value at the date of purchase if later).

The Foundation has holdings in two Charity Authorised Investment Funds. Investment management fees are reflected in the fund valuations and are not paid directly to the managers.

NOTES TO THE FINANCIAL STATEMENTS (CONTINUED) YEAR ENDED 31 DECEMBER 2022

(d) Income and Expenditure

Income is accounted for in the Statement of Financial Activities when the Foundation is legally entitled to the income and the amount can be quantified with reasonable accuracy and is probable to be received. Income from investments is treated as receivable when the investment is quoted ex-dividend. Other income and all expenditure are accounted for on an accruals basis. Grants payable are payments made to third parties in the furtherance of the charitable objects of the Trust. Costs of raising funds comprise investment management costs associated with managing the Foundation's investments.

Included in charitable expenditure are the audit fee and management fee which are allocated to charitable activities.

(e) Taxation

On the basis that the activities fall within charitable purposes and the funds are applied only for these purposes, no provision for taxation is made.

(f) Fund Accounting

All funds are unrestricted and can be used in accordance with the Foundation's charitable objects at the discretion of the Trustees.

(g) Financial Instruments

Financial assets and financial liabilities are recognised when the charity becomes a party to the contractual provisions of the instrument.

Investments are initially recognised at transaction value and subsequently measured at fair value.

Other debtors are recognised at the settlement amount due. Cash at bank and cash in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account. Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

(h) Critical accounting judgements and key sources of estimation uncertainty

In the application of the charity's accounting policies, the Trustees are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

The Trustees do not consider there are any critical judgements or sources of estimation uncertainty requiring disclosure.

The Trustees are pleased to present their annual report along with the financial statements of The Broad Cairn Foundation for the year ended 31 December 2021.

STRUCTURE, GOVERNANCE AND MANAGEMENT

a) Constitution

The charity was formed under a Declaration of Trust dated 14 January 1999.

The Trustees who served during the year and to the date of signing this report were:

No Trustee had any interests in the charity.

b) Method of election of Trustees

New or additional Trustees are appointed by deed. Every future Trustee must sign a declaration of willingness to act as a Trustee before he or she is eligible to vote at any meeting of the Trustees. The current Trustees ensure that an appropriate induction programme is undertaken in the event of a new appointment. To date, Trustees have been recruited with their specific skills and experience in mind, although further training is undertaken where necessary.

c) Organisational structure and decision making

The Foundation's principal office is 10 New Square, Lincoln's Inn, London WC2A 3QG.

The Trustees meet at least once a year to consider appeals for grants, the current and future financial position of the Foundation and longer term strategy. Day to day responsibility for the running of the Foundation has been delegated to a small team of suitably qualified individuals employed by the Grosvenor Family Office by way of an annual service agreement, with an annual management fee being charged.

The Foundation does not employ any staff directly.

The Foundation has regard to the seven principles of good governance and best practice which are set out in the Charity Governance Code.

d) Risk Management

The major risks to which the charity is exposed as identified by the Trustees have been reviewed, and procedures have been established to mitigate those risks.

The key risks that have been identified and which are carefully monitored are:

- Poor performance of the investment portfolio leading to a material financial loss of our main source of funding. This has been mitigated by diversification of investments and regular performance monitoring;
- Risk of fraud or failure of internal financial controls which is mitigated by shared authorisation procedures; and
- Misappropriation of grant funding which is mitigated by due diligence in advance of awarding funds and receipt of an impact report for grants greater than £5,000.

A full risk assessment is undertaken on an annual basis by the Trustees.

OBJECTIVES AND ACTIVITIES

a) Objectives

Objectives (as set out in the Trust Deed) are that the assets of the charity are held on trust for such exclusively charitable objects or purposes in any part of the world as the Trustees may from time to time determine.

b) Aims

The charity is a grant making foundation that aims principally to address social welfare issues by supporting appropriate registered charities.

c) Statement of public benefit

The Trustees confirm they have paid due regard to the guidance produced by the Charity Commission when reviewing the Foundation's aims and objectives and are satisfied that the charitable activities and projects funded through grant making are of direct benefit to the public. The Trustees' responsibility is to ensure that the monies are being spent in line with the charity's aims and objectives. For grants greater than £5,000 the Trustees request an impact report from the recipient charities explaining how the donation has been utilised.

d) Grant Making Policy

The Foundation concentrates its grant making activities almost exclusively on smaller charities where its contribution can make a real difference. The Trustees' grant making priorities are:

- ***Disadvantaged Children and Young People.***
To help disadvantaged young people and to enable them to participate in society by providing support and activities which develop their skills, confidence and aspiration.
- ***Third World Infrastructure and development.***
To assist charities supporting the third world, especially those supporting infrastructure such as clean water and agricultural improvements.
- ***Conservation and sustainable development.***
To help promote conservation and the sustainable use of the world's scarce resources for the benefit of those whose lives depend on them and for future generations.
- ***Heritage.***
To support the renovation and conservation of historic buildings and monuments.

Support is given mainly by grants to appropriate registered charities. On occasion, the Foundation may support charities that are exempt or exempted from registration, or projects where the grant is for an exclusively charitable purpose. Proposals are likely to be invited by the Trustees, and in general the Foundation does not fund unsolicited appeals. Grants are not made to individuals.

ACHIEVEMENTS AND PERFORMANCE

a) Review of activities and financial review

The financial statements below give details of the financial transactions in the year and the financial position at the year end.

Total income for the year of £53,156 (2020: £34,402) was £18,754 higher due to an increase in donations received of £17,000 and additional investment income of £1,754. Expenditure totalling £51,568 was £19,169 higher (2020: £32,399), largely due to an increase in grant making of £18,750. Grants totalling £40,900 (2020: £22,150) were awarded during the year.

Fourteen grants were awarded during the year, with an average size of £2,921. The largest grants awarded were £12,500 to Historic Royal Palaces, £10,000 to The Thin Green Line Foundation, £5,000 to Community Action to Create Hope and £5,000 to The Submariner Memorial Appeal.

ACHIEVEMENTS AND PERFORMANCE (CONTINUED)

The distribution target for 2021 (for funding of grant making and support costs) was £40,000 (being 3% of the opening investment portfolio value in accordance with the Trustees' previously agreed distribution policy). Total expenditure of £51,568 was more than this due to the increased income received in the year.

b) Investment policy and performance

The Trustees have wide investment powers and a policy of seeking a fair balance between capital growth and income yield.

The market value of investments (including cash held within the portfolio) increased to £1,489,406 (2020: £1,321,019), an increase of 12.7%. The overall return of the investment portfolio for the year was 15.3% compared to a benchmark return of 10.9% (RPI plus 4%).

No changes to asset allocation were made during the year. However, the Trustees reviewed the ESG credentials of the portfolio during the year and as a result decided to sell one of the holdings in the global equity asset class and reinvest the proceeds in an alternative fund.

The investment portfolio exceeded the benchmark by 4.4%. Asset allocation made a positive contribution to relative return, in particular the high exposure to equities and property and low weighting in fixed income (which had negative returns over the full year).

The market volatility experienced to date in 2022 driven by concerns over higher inflation, interest rate increases, the slowing pace of economic growth and Russia's invasion of Ukraine will be monitored closely throughout the current year.

OTHER

a) Reserves policy

The Foundation's funds are all unrestricted and may be used in furtherance of its charitable objects. The risk associated with not having adequate reserve balances is therefore considered to be low.

The Trustees policy is to retain 12 months of funding in cash, which is approximately £45,000 based on year end values. The year-end cash balance of £35,265 is below this; however, the charity has no commitments or significant operating expenses which require funding from closing reserves.

In addition, the investment portfolio is largely invested in liquid assets which could be realised if necessary should any unforeseen circumstances arise.

At the balance sheet date, the Trustees are satisfied that the current level of available funds meets the Foundation's requirements. Unrestricted funds at 31 December 2021 are £1,524,330 (2020: £1,351,689).

b) Plans for future periods

The Trustees will continue to support the activities set out above by the awarding of grants.

c) Going concern

Having considered the charity's reserves and commitments, the Trustees believe that the Foundation will be able to maintain positive cashflows for at least 12 months from the date of signing the financial statements. As a result, the going concern basis of accounting remains appropriate.

d) Auditor

A resolution for the reappointment of Deloitte LLP as the charity's auditor will be proposed at a future Trustee meeting.

Statement of disclosure to the Auditor

As far as the Trustees are aware:

- there is no relevant audit information of which the charity's auditor is unaware; and
- the Trustees have taken all the steps that they ought to have taken as a Trustee to make themselves aware of any relevant audit information and to establish that the charity's auditor is aware of that information.



As explained more fully in the trustees' responsibilities statement, the trustees are responsible for the preparation of the financial statements and for being satisfied that they give a true and fair view, and for such internal control as the trustees determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the trustees are responsible for assessing the charity's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the trustees either intend to liquidate the charity or to cease operations, or have no realistic alternative but to do so.

We have been appointed as auditor under section 144 of the Charities Act 2011 and report in accordance with the Act and relevant regulations made or having effect thereunder.

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs (UK) will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

A further description of our responsibilities for the audit of the financial statements is located on the FRC's website at: www.frc.org.uk/auditorsresponsibilities. This description forms part of our auditor's report.

Extent to which the audit was considered capable of detecting irregularities, including fraud
Irregularities, including fraud, are instances of non-compliance with laws and regulations. We design procedures in line with our responsibilities, outlined above, to detect material misstatements in respect of irregularities, including fraud. The extent to which our procedures are capable of detecting irregularities, including fraud is detailed below.

We considered the nature of the charity's industry and its control environment, and reviewed the charity's documentation of their policies and procedures relating to fraud and compliance with laws and regulations. We also enquired of management and trustees about their own identification and assessment of the risks of irregularities.

We obtained an understanding of the legal and regulatory framework that the charity operates in, and identified the key laws and regulations that:

- had a direct effect on the determination of material amounts and disclosures in the financial statements. These included the UK Charities Act; and
- do not have a direct effect on the financial statements but compliance with which may be fundamental to the charity's ability to operate or to avoid a material penalty.

We discussed among the audit engagement team regarding the opportunities and incentives that may exist within the organisation for fraud and how and where fraud might occur in the financial statements.

As a result of performing the above, we identified the greatest potential for fraud or non-compliance with laws and regulations in the following area, and our specific procedures performed to address it is described below:

- we presume a risk of material misstatement due to fraud in revenue recognition which is related to the completeness of donation income. To address this risk, we reviewed the Trustees' meeting minutes, all bank statements in the period, and post year end records up to the date of this report to test whether income had been appropriately included in the financial statements.

In common with all audits under ISAs (UK), we are also required to perform specific procedures to respond to the risk of management override. In addressing the risk of fraud through management override of controls, we assessed the design and implementation of controls over the assessment and approval of grant awards; we tested the appropriateness of journal entries and other adjustments; assessed whether the judgements made in making accounting estimates are indicative of a potential bias; and evaluated the business rationale of any significant transactions that are unusual or outside the normal course of business.

In addition to the above, our procedures to respond to the risks identified included the following:

- reviewing financial statement disclosures by testing to supporting documentation to assess compliance with provisions of relevant laws and regulations described as having a direct effect on the financial statements;
- performing analytical procedures to identify any unusual or unexpected relationships that may indicate risks of material misstatement due to fraud;
- enquiring of management concerning actual and potential litigation and claims, and instances of non-compliance with laws and regulations; and
- reading and reviewing minutes of meetings of those charged with governance.

Report on other legal and regulatory requirements

Matters on which we are required to report by exception

Under the Charities (Accounts and Reports) Regulations 2008 we are required to report in respect of the following matters if, in our opinion:

- the information given in the financial statements is inconsistent in any material respect with the trustees' report; or
- sufficient accounting records have not been kept; or
- the financial statements are not in agreement with the accounting records and returns; or
- we have not received all the information and explanations we require for our audit.

We have nothing to report in respect of these matters.

1. ACCOUNTING POLICIES

(a) Basis of Accounting

The financial statements are prepared under the historical cost convention, with the exception of investments which have been included at market value, in accordance with the Statement of Recommended Practice "Accounting and Reporting by Charities (SORP 2019)" applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102), effective 1 January 2019.

The charity has taken advantage of the provisions in the SORP for charities applying FRS 102 Update Bulletin 1 not to prepare a Statement of Cash Flows.

The charity constitutes a public benefit entity as defined by FRS 102.

(b) Going concern

The charity's activities, together with the factors likely to affect its future development, performance and position are set out in the Trustees Report which also describes the financial position of the charity including its cash, investments, distributions and reserves policy. Taking these into consideration and the fact that all funds are unrestricted, the Trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. Therefore, they continue to adopt the going concern basis of accounting in preparing the annual report and financial statements.

The functional currency of the charity is pounds sterling as the charity operates and received income in the UK.

The principal accounting policies are set out below.

(c) Investments

Listed investments are valued at the market price from a recognised stock exchange at the balance sheet date. Realised and unrealised gains and losses on investments are included in the Statement of Financial Activities.

Realised gains and losses on investments are calculated as the difference between sale proceeds and opening market value (or value at the date of purchase if later). Unrealised gains and losses are calculated as the difference between the market value at the year end and opening market value (or value at the date of purchase if later).

The Foundation is largely invested in unit trusts or Common Investment Funds. Investment management fees for these funds are reflected in the fund valuations and are not paid directly to the managers. Custody fees charged by Schroder & Co are reported within expenditure on raising funds.

NOTES TO THE FINANCIAL STATEMENTS (CONTINUED) YEAR ENDED 31 DECEMBER 2021

(d) Income and Expenditure

Income is accounted for in the Statement of Financial Activities when the Foundation is legally entitled to the Income and the amount can be quantified with reasonable accuracy and is probable to be received. Income from investments is treated as receivable when the Investment is quoted ex-dividend. Other income and all expenditure are accounted for on an accruals basis. Grants payable are payments made to third parties in the furtherance of the charitable objects of the Trust. Costs of raising funds comprise investment management costs associated with managing the Foundation's investments.

Included in charitable expenditure are the audit fee and management fee which are allocated to charitable activities.

(e) Taxation

On the basis that the activities fall within charitable purposes and the funds are applied only for these purposes, no provision for taxation is made.

(f) Fund Accounting

All funds are unrestricted and can be used in accordance with the Foundation's charitable objects at the discretion of the Trustees.

(g) Financial Instruments

Financial assets and financial liabilities are recognised when the charity becomes a party to the contractual provisions of the instrument.

Investments are initially recognised at transaction value and subsequently measured at fair value.

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Cash at bank and cash in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account. Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

(h) Critical accounting judgements and key sources of estimation uncertainty

In the application of the charity's accounting policies, the Trustees are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

The Trustees do not consider there are any critical judgements or sources of estimation uncertainty requiring disclosure.

The Trustees are pleased to present their annual report along with the financial statements of The Broad Cairn Foundation for the year ended 31 December 2020.

STRUCTURE, GOVERNANCE AND MANAGEMENT

a) Constitution

The charity was formed under a Declaration of Trust dated 14 January 1999.

The Trustees who served during the year were:

No Trustee had any interests in the charity.

b) Method of election of Trustees

New or additional Trustees are appointed by deed. Every future Trustee must sign a declaration of willingness to act as a Trustee before he or she is eligible to vote at any meeting of the Trustees. The current Trustees ensure that an appropriate induction programme is undertaken in the event of a new appointment. To date, Trustees have been recruited with their specific skills and experience in mind, although further training is undertaken where necessary.

c) Organisational structure and decision making

The Foundation operates from its head office at 70 Grosvenor Street, London.

The Trustees meet at least once a year to consider appeals for grants, the current and future financial position of the Foundation and longer term strategy. Day to day responsibility for the running of the Foundation has been delegated to a small team of suitably qualified individuals employed by the Grosvenor Family Office.

The Foundation does not employ any staff directly.

The Foundation has regard to the seven principles of good governance and best practice which are set out in the Charity Governance Code.

d) Risk Management

The major risks to which the charity is exposed as identified by the Trustees have been reviewed, and procedures have been established to mitigate those risks. A full risk assessment is undertaken on an annual basis by the Trustees.

The key risks that have been identified and which are carefully monitored are:

- Poor performance of the investment portfolio leading to a material financial loss of our main source of funding. This has been mitigated by diversification of investments and regular performance monitoring; and
- Risk of fraud or failure of internal financial controls which is mitigated by shared authorisation procedures.

OBJECTIVES AND ACTIVITIES

a) Objectives

The assets of the charity are held on trust for such exclusively charitable objects or purposes in any part of the world as the Trustees may from time to time determine.

b) Aims

The charity is a grant making foundation that aims principally to address social welfare issues by supporting appropriate registered charities.

c) Statement of public benefit

The Trustees have paid due regard to the guidance produced by the Charity Commission when reviewing the Foundation's aims and objectives and are satisfied that the charitable activities and projects funded through grant making are of direct benefit to the public. The Trustees' responsibility is to ensure that the monies are being spent in line with the charity's aims and objectives. For grants greater than £5,000 the Trustees request an impact report from the recipient charities explaining how the donation has been utilised.

d) Grant Making Policy

The Foundation concentrates its grant making activities almost exclusively on smaller charities where its contribution can make a real difference. The Trustees' grant making priorities are:

- **Disadvantaged Children and Young People.**
To help disadvantaged young people and to enable them to participate in society by providing support and activities which develop their skills, confidence, and aspiration.
- **Third World infrastructure and development.**
To assist charities supporting the third world, especially those supporting infrastructure such as clean water and agricultural improvements.
- **Conservation and sustainable development.**
To help promote conservation and the sustainable use of the world's scarce resources for the benefit of those whose lives depend on them and for future generations.
- **Heritage.**
To support the renovation and conservation of historic buildings and monuments.

Support is given mainly by grants to appropriate registered charities. On occasion, the Foundation may support charities that are exempt or exempted from registration, or projects where the grant is for an exclusively charitable purpose. Proposals are likely to be invited by the Trustees, and in general the Foundation does not fund unsolicited appeals. Grants are not made to individuals.

ACHIEVEMENTS AND PERFORMANCE

a) Review of activities and financial review

The financial statements below give details of the financial transactions in the year and the financial position at the year end.

Total income for the year of £34,402 (2019: £58,921) was £24,519 lower due to a decrease in donations received of £26,000. Expenditure totalling £32,399 was £31,784 lower (2019: £64,183), largely due to a decrease in grant making of £31,964. Grants totalling £22,150 (2019: £54,114) were made during the year.

Fifteen grants were awarded during the year, with an average size of £1,477. The largest grants awarded were £10,000 (spread across 4 grants) to support regions affected by the Australian bushfires at the start of 2020, £5,000 to the Game & Wildlife Conservation Trust and £3,000 for the National Emergencies Trust Coronavirus appeal. 2019 grant making was more than the distribution target set last year reflecting an

underspend in 2018.

The distribution target for 2020 was £40,000 (representing 3% of the opening investment portfolio value in accordance with the Trustees' previously agreed distribution policy) plus cash unspent in previous years. Actual grant making was less than target and the Trustees will seek to rectify this as soon as possible in future financial years.

The Trustees did not feel it necessary to adjust the distribution target as a result of Covid-19. Overall, the impact of the pandemic on the Foundation was minor with a small decrease in the value of the investment portfolio and an improvement in investment income.

b) Investment policy and performance

The Trustees have wide investment powers and a policy of seeking a fair balance between capital growth and income yield.

The market value of investments (including cash held within the portfolio) decreased to £1,321,019 (2019: £1,329,459), a decrease of 0.6%. The overall return of the investment portfolio for the year was 1.8% compared to a benchmark return of 4.7% (RPI plus 4%).

No changes were made to asset allocation during the year. Financial markets experienced unprecedented volatility during the height of the Covid-19 pandemic in March but managed to recover their losses.

The Trustees regularly review the performance of the investment portfolio, and during 2021 will continue to review the asset allocation with their advisors.

OTHER

a) Reserves policy

The Trustees policy is to retain 12 months of funding in cash, which is approximately £40,000 based on year end values. The year-end cash balance of £33,211 is below this; however, the charity has no commitments or significant operating expenses.

The Foundation's funds are all unrestricted and may be used in furtherance of its charitable objects. The investment portfolio (which is the main asset of the Foundation) is largely invested in liquid assets which could be realised if necessary, should any unforeseen circumstances arise.

At the balance sheet date, the Trustees are satisfied that the current level of available funds meets the Foundation's requirements. Unrestricted funds at 31 December 2020 are £1,351,689 (2019: £1,357,267).

b) Plans for future periods

The Trustees will continue to support the activities set out above by the award of grants.

c) Going concern

Having considered the charity's reserves and commitments, the Trustees believe that the Foundation will be able to maintain positive cashflows for at least 12 months from the date of signing the financial statements. As a result, the going concern basis of accounting remains appropriate.

d) Auditor

A resolution for the reappointment of Deloitte LLP as the charity's auditor will be proposed at a future Trustee meeting.

Statement of disclosure to the Auditor

As far as the Trustees are aware:

- there is no relevant audit information of which the charity's auditor is unaware; and
- the Trustees have taken all the steps that they ought to have taken as a Trustee to make themselves aware of any relevant audit information and to establish that the charity's auditor is aware of that information.

Opinion

In our opinion the financial statements of The Broad Cairn Foundation (the 'charity'):

Basis for opinion

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

- had a direct effect on the determination of material amounts and disclosures in the financial statements. These included the UK Charities Act; and
- do not have a direct effect on the financial statements but compliance with which may be fundamental to the charity's ability to operate or to avoid a material penalty.

We discussed among the audit engagement team regarding the opportunities and incentives that may exist within the organisation for fraud and how and where fraud might occur in the financial statements.

As a result of performing the above, we identified the greatest potential for fraud or non-compliance with laws and regulations in the following area, and our specific procedures performed to address it is described below:

- we presume a risk of material misstatement due to fraud in revenue recognition which is related to the completeness of donation income. To address this risk, we reviewed the Trustees' meeting minutes, all bank statements in the period, and post year end records up to the date of this report to test whether income had been appropriately included in the financial statements.

In common with all audits under ISAs (UK), we are also required to perform specific procedures to respond to the risk of management override. In addressing the risk of fraud through management override of controls, we assessed the design and implementation of controls over the assessment and approval of grant awards; we tested the appropriateness of journal entries and other adjustments; assessed whether the judgements made in making accounting estimates are indicative of a potential bias; and evaluated the business rationale of any significant transactions that are unusual or outside the normal course of business.

In addition to the above, our procedures to respond to the risks identified included the following:

- reviewing financial statement disclosures by testing to supporting documentation to assess compliance with provisions of relevant laws and regulations described as having a direct effect on the financial statements;
- performing analytical procedures to identify any unusual or unexpected relationships that may indicate risks of material misstatement due to fraud;
- enquiring of management concerning actual and potential litigation and claims, and instances of non-compliance with laws and regulations; and
- reading and reviewing minutes of meetings of those charged with governance.

Report on other legal and regulatory requirements

Matters on which we are required to report by exception

Under the Charities (Accounts and Reports) Regulations 2008 we are required to report in respect of the following matters if, in our opinion:

- the information given in the financial statements is inconsistent in any material respect with the trustees' report; or
- sufficient accounting records have not been kept; or
- the financial statements are not in agreement with the accounting records and returns; or
- we have not received all the information and explanations we require for our audit.



NOTES TO THE FINANCIAL STATEMENTS YEAR ENDED 31 DECEMBER 2020

1. ACCOUNTING POLICIES

(a) Basis of Accounting

The financial statements are prepared under the historical cost convention, with the exception of investments which have been included at market value, in accordance with the Statement of Recommended Practice "Accounting and Reporting by Charities (SORP 2019)" applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102), effective 1 January 2019.

The charity constitutes a public benefit entity as defined by FRS 102.

The charity's activities, together with the factors likely to affect its future development, performance and position are set out in the Trustees Report which also describes the financial position of the charity including its cash, investments, distributions and reserves policy. Taking these into consideration and the fact that all funds are unrestricted, the Trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. Therefore, they continue to adopt the going concern basis of accounting in preparing the annual report and financial statements.

The functional currency of the charity is pounds sterling as the charity operates and received income in the UK.

The principal accounting policies are set out below.

(b) Investments

Listed investments are valued at the market price from a recognised stock exchange at the balance sheet date. Realised and unrealised gains and losses on investments are included in the Statement of Financial Activities.

Realised gains and losses on investments are calculated as the difference between sale proceeds and opening market value (or value at the date of purchase if later). Unrealised gains and losses are calculated as the difference between the market value at the year end and opening market value (or value at the date of purchase if later).

The Foundation is largely invested in unit trusts or Common Investment Funds. Investment management fees for these funds are reflected in the fund valuations and are not paid directly to the managers. Custody fees charged by Schroder & Co are reported within expenditure on raising funds.

(c) Income and Expenditure

Income is accounted for in the Statement of Financial Activities when the Foundation is legally entitled to the income and the amount can be quantified with reasonable accuracy and is probable to be received. Income from investments is treated as receivable when the investment is quoted ex-dividend. Other income and all expenditure are accounted for on an accruals basis. Grants payable are payments made to third parties in the furtherance of the charitable objects of the Trust. Costs of raising funds comprise investment management costs associated with managing the Foundation's investments.

Included in charitable expenditure are the audit fee and management fee which are allocated to charitable activities.

NOTES TO THE FINANCIAL STATEMENTS (CONTINUED) YEAR ENDED 31 DECEMBER 2020

(d) Taxation

On the basis that the activities fall within charitable purposes and the funds are applied only for these purposes, no provision for taxation is made.

(e) Fund Accounting

All funds are unrestricted and can be used in accordance with the Foundation's charitable objects at the discretion of the Trustees.

(f) Financial Instruments

Financial assets and financial liabilities are recognised when the charity becomes a party to the contractual provisions of the instrument.

Investments are initially recognised at transaction value and subsequently measured at fair value.

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Cash at bank and cash in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account. Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

(g) Critical accounting judgements and key sources of estimation uncertainty

In the application of the charity's accounting policies, the Trustees are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

The Trustees do not consider there are any critical judgements or sources of estimation uncertainty requiring disclosure.
