Other items purchased are outdoor play items, library books, 3 read book prizes, a portable Bluetooth speaker and funding a Spanish day and the Marp Jam music festival.

We have a bank balance of £38,464.21, of which £38,182.50 is committed to the school for the outside reading area, mindfulness/yoga practitioner, smart camera, sports day, school community hardship funding and the new resources building.

I would like to thank all the local businesses for supporting us during the year. Also thank you to the staff and committee for their tolerance and help.

There being no further business the meeting closed at 7.15pm.




