Governing Document

The charity is governed by a constitution adopted on 19th January 1999.

Recruitment and Appointment of New Trustees

The management of the charity is the responsibility of the Trustees who are elected and co-opted under the terms of the constitution.

Board Membership

There were no changes in year 2023-24.

Induction and Training of New Trustees

The charity continues updating the knowledge of all Trustees on their roles and responsibilities. This usually includes regular training/ refresher updates as part of the Trustee meetings.

Four quarterly Trustee Board Meetings were held during the period 5 November 2023 to 4 November 2024.

Organisational Structure

The day to day running of the charity has been delegated to the presiding prelates for Europe and Asia with the support of an administrator. The Trustees are consulted on all material issues and determine the strategic direction of the charity. Trustees meet formally as and when required to review the operations of the charity. The charity's volunteers provide an invaluable contribution, particularly at formal events/ meetings.

Related Party Relationships

The charity is part of an International Network which operates branches in North America, South America, Asia, Africa, the Caribbean, Australasia and Europe.

The charity provides spiritual covering to 100 member assemblies, all of which operate autonomously and have ownership of their individual assets.

OBJECTIVES AND ACTIVITIES

The principal objects of the charity are to:

- i) Advance the Christian religion
- ii) Relieve persons in conditions of poverty, sickness and distress; and
- iii) Protect and preserve public health.

Main activities during the year

1. Year 2023 -2024

All the individual churches within the organisation hold weekly in person services in their buildings. However, the churches within the organisation have continued their use of internet and media technology, developed during lockdown and beyond, to be able to maintain both contact and the spiritual wellbeing of their members and the wider communities that they serve.

Assemblies within Rejoice (Jabula) New Life Ministries Europe & Asia continue to hold Annual Thanksgiving and Anniversary Services, which fall at different times throughout the year. These are supported by the Jabula churches within their region and also by other local assemblies.

2. Annual Leadership Conference

The LOUD 2024 Conference took place this reporting year. The theme was "Abundance & Overflow". This was held from Friday 31st May to Saturday 1st June 2024. The keynote speakers were Bishop Roberts (USA), Bishop Ballakistan (RSA), Apostle Morgan – Scott (USA) and Pastor Quintanilla (UK).

This was well supported by members of the church communities and people from outside.

On the Friday evening there was leadership training with Bishop Roberts. For the Sunday morning services, those ministers available were deployed to various churches in the organisation.

Plans are in place for the LOUD 2025 Conference where the founder and chief executive of Jabula International, Bishop Tudor Bismark will be the keynote speaker. This will be held Friday 30th – 1st June 2025.

3. Leadership Training

In November 2023, Bishop Hugh Daniel Smith, Presiding Bishop of Jabula International visited Birmingham to provide Leadership Training for Jabula Pastors & Leadership. He ministered at the Sunday service at New Jerusalem Community Church.

4. Worldwide Ministry

Members and Affiliates continue to be involved in philanthropic outreach both in the United Kingdom and abroad (particularly in Asia). The ministry in India whilst growing, continues to be reliant on funding from the charity for its work, supported by the generous giving of individual church members and assemblies.

A number of local churches in the UK assist the churches in India and the local orphanage and school.

ACHIEVEMENTS AND PERFORMANCE

Key Member and Affiliate Achievements in the Year

1. New Jerusalem through both its church and Transformation centre continue to impact on the local communities of Aston and Nechells. Particularly to the local schools and young people, but also to all people who need support. A fully functioning Foodbank continues to be available 3 days a week, also working with several other local agencies.

However New Jerusalem continues to look to partner with other community organisations to maximise both the physical building and the skill sets of our members, building on the partnership in place with the Community Empowerment Agency below.

The focus on the arts for young people is also evidenced with a fully operational recording studio being available.

The church regularly supports its youth members, both during the school year and those who are studying at university, especially those who are located away from Birmingham area.

One of our Elders continues to serve on the Board of the local regional health authority.

Two of the ordained Ministers at the church continue their permanent roles in a local prison and hospital respectively. A third heads up a Community Empowerment Organisation which provides mental, spiritual and practical support particularly for youth and young men.

2. Several of the Jabula churches in the UK support Bishop Samuel, his orphanage and his affiliated churches in India.

3. Bishop Designate Memory Tapfumaneyi of the Oxford church continues as the Chairperson for the Oxford Pastors Forum.

4. Place of Refuge in Croydon continue to run a foodbank in conjunction with other local churches and also support the Mediation Service in the local Croydon community.

5. The Jabula Churches also support the Annual Samaritans Purse shoe box initiative, providing Christmas presents across the world for children who would not otherwise receive.

6. Restorer Christian Centre have purchased and renovated their own building in Oldbury, operating services and support to the local community.

The Charity's Growth and Future Developments

1. Progression

The policy of training other senior Pastors within Jabula to carry out required duties within the body in support of Bishop Brooks has continued this year almost exclusively by Zoom. Bishop Brooks has utilised the technology to actively support the Jabula membership and the Pastors to continue supporting their church members and their local communities. His use of technology has allowed his influence to be felt worldwide.

Similarly technology has allowed our international leader, Bishop Hugh Smith and other leaders worldwide to project services, leadership training and other educational content to the wider Jabula communities.

Bishop Brooks undertakes appraisals and identifies training needs for the member Pastors often providing said training on a one-to-one basis, utilising Zoom and other technologies.

- Revisit Constitution, make changes to the functions.
- A personal assistant to be assigned to Deputy International Prelate of Rejoice New Life Ministries (Jabula)
- Our target of 30 churches within the UK remains.
- To acquire an independent office which would be utilised as Jabula Headquarters UK within will also be a church.
- Employ a part time Administrator and Book Keeper
- Church Governance - recruit new trustees from Education and Health industry (mental health)
- The development of a Bible School for Rejoice New Life Ministries (Jabula) – to expand the gospel – has commenced.
- The establishing of empowerment ministries for Men, Boys and young Ladies and the bringing in of specialist teachers and trainers s ongoing.
- Hold a Regional Loud Conference which covers the above objectives
- Develop fundraising to meet executive objectives (new building)
- Establish parenting training (help children) and pre-marriage retreats
- The Southern Region to be divided into three areas (based on growth), with three key leaders

The above are constantly under review given the current local and worldwide situation.





Main activities during the year

1. Post COVID – 19

This period being reported reflects the first 12 months following the lifting of all COVID-19 restrictions. To recap this had impacted on the ability of the organisation and the churches within it, to operate in a traditional and conventional way.

In the last few months of that period individual churches reopened for in person services, operating within the government guidelines in place at that time. Many continued the on-line presence in parallel.

By 2022, all the individual churches within the organisation had reopened their buildings for in person services. However, the churches within the organisation have continued their use of internet and media technology, developed during lockdown and beyond, to be able to maintain both contact and the spiritual wellbeing of their members and the wider communities that they serve.

A monthly evening Prayer Meeting is held on line by Zoom, which brings all the churches together.

The Southern region continued to hold weekly Sunday morning services on Zoom to bring the individual churches and their members together, bringing spiritual support particularly during the times of lockdown.

Assemblies within Rejoice (Jabula) New Life Ministries Europe & Asia have recommenced holding Annual Thanksgiving and Anniversary Services, which fall at different times throughout the year. These are supported by the Jabula churches within their region and also by other local assemblies.

2. Annual Leadership Conference

As at the end of this reporting period, no decision has been taken, in respect of the next Europe & Asia Conference due to be held in 2023. This is due to the viability of such an event following the changes in attendee behaviour post COVID and the overall financial requirements of the event.

3. Worldwide Ministry

Members and Affiliates continue to be involved in philanthropic outreach both in the United Kingdom and abroad (particularly in Asia). The ministry in India whilst growing, continues to be reliant on funding from the charity for its work, supported by the generous giving of individual church members and assemblies.

The international charitable arm of the international organisation was set up under the Utopia banner, with its financial administration taking place in the UK. The aim is to support and provide resources to the Jabula churches across the world, with focus on those in less affluent areas of the world. As reported previously the financial administration was being moved to being under US management, with the process now completed during this reporting period.

A number of local churches in the UK assist the churches in India and the local orphanage and school. Additional funding was provided to help with the provision of a generator to help maintain lighting and ventilation during electricity outages.





STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing Document

The charity is governed by a constitution adopted on 19th January 1999.

Recruitment and Appointment of New Trustees

The management of the charity is the responsibility of the Trustees who are elected and co-opted under the terms of the constitution.

Board Membership

There were no changes to the Board during this financial year.

Induction and Training of New Trustees

The charity continues updating the knowledge of all Trustees on their roles and responsibilities. This usually includes regular training/ refresher updates as part of the Trustee meetings.

Four quarterly Trustee Board Meetings were held during the period 5 November 2019 to 4 November 2020.

Organisational Structure

The day to day running of the charity has been delegated to the presiding prelates for Europe and Asia with the support of an administrator. The Trustees are consulted on all material issues and determine the strategic direction of the charity. Trustees meet formally as and when required to review the operations of the charity. The charity's volunteers provide an invaluable contribution, particularly at formal events/ meetings.

Related Party Relationships

The charity is part of an International Network which operates branches in North America, South America, Asia, Africa, the Caribbean, Australasia and Europe.

The charity provides spiritual covering to 100 member assemblies, all of which operate autonomously and have ownership of their individual assets.

OBJECTIVES AND ACTIVITIES

The principal objects of the charity are to:

- I) Advance the Christian religion;
- ii) Relieve persons in conditions of poverty, sickness and distress; and
- iii) Protect and preserve public health.

Main activities during the year

1. COVID – 19

Most of the period in question was dominated by the impacts of COVID-19. This impacted on the ability of the organisation and the churches within it, to operate in a traditional and conventional way.

The churches within the organisation have switched to the use of internet and media technology to be able to maintain both contact and the spiritual wellbeing of their members and the wider communities that they serve.

The Southern region held weekly Sunday morning services on Zoom to bring the individual churches and their members together, bringing spiritual support particularly during the times of lockdown.

2. Annual Leadership Conference

As detailed in the previous year's report the decision was taken, that regional Annual Leadership Conferences would be held every 2 years, so the next Europe & Asia Conference was not due to be held until June 2021. This had to be rolled forward another year and currently ongoing discussions are currently taking place as to the viability of such a conference taking place in June 2022, given the ongoing uncertainties in respect of COVID-19 and travel restrictions.

3. Worldwide Ministry

Members and Affiliates continue to be involved in philanthropic outreach both in the United Kingdom and abroad (particularly in Asia). The ministry in India whilst growing, continues to be reliant on funding from the charity for its work, supported by the generous giving of individual church members and assemblies.

The international charitable arm of the international organisation was set up under the Utopia banner, with its financial administration taking place in the UK. The aim is to support and provide resources to the Jabula churches across the world, with focus on those in less affluent areas of the world. It is planned that in 2021, the financial administration will move to being under US management.

During this time, donations were made to Zimbabwe to support New Life Ministries as poverty and food shortages in the country led to great challenges. Donation was made to Zambia to assist with the building of a well for the local community. Financial help was provided to a member church in South Africa, whose building was damaged during a time of civil unrest during the pandemic.

A number of local churches in the UK assist the churches in India and the local orphanage and school. Additional funding was provided to help with the provision of a generator to help maintain lighting and ventilation during electricity outages.

ACHIEVEMENTS AND PERFORMANCE

Key Member and Affiliate Achievements in the Year

1. New Jerusalem through both its church and Transformation centre continue to impact on the local communities of Aston and Nechells. Particularly to the local schools and young people, but also to all people who are in need of support. A fully functioning Foodbank previously available 3 days a week, is now available Monday to Friday, also working with a number of other agencies.

Mentoring support for young people who are facing challenge in their schooling which was provided to up to 5 schools in the wider area, is currently discontinued.

However New Jerusalem are looking to partner with other community organisations to maximise both the physical building and the skill sets of our members.

The focus on the arts for young people is also evidenced with a fully operational recording studio being available.

The church regularly supports its youth members, both during the school year and those who are studying at university, especially those who are located away from Birmingham area.

One of our Elders serves on the Board of the local regional health authority and a second is part of the leadership and management team of the local faith school.

Two of the ordained Ministers at the church continue their permanent roles in a local prison and hospital respectively. A third heads up a Community Empowerment Organisation which provides mental, spiritual and practical support particularly for youth and young men.

2. A number of the Jabula churches in the UK support Bishop Samuel, his orphanage and his affiliated churches in India.

3. The 2020 Women of Purpose Conference was postponed.

4. Assemblies within Rejoice (Jabula) New Life Ministries Europe & Asia were encouraged to hold Annual Thanksgiving and Anniversary Services, which fell at different times throughout the year. These were supported by the Jabula churches within their region and also by other local assemblies. These have had to be physically curtailed during this period, but various on-line events have taken place.

5. Bishop Designate Memory Tapfumaneyi of the Oxford church continues as the Chair Person for the Oxford Pastors Forum. He has hosted the Annual Dinner and Conference at which local Bishops, MPs and other dignitaries attend, speak and share their views.

6. Place of Refuge in Croydon continue to run a foodbank in conjunction with other local churches and also support the Mediation Service in the local Croydon community.

7. The Jabula Churches also support the Annual Samaritans Purse shoe box initiative, providing Christmas presents across the world for children who would not otherwise receive.

The Charity's Growth and Future Developments

1. Progression

The policy of training other senior Pastors within Jabula to carry out required duties within the body in support of Bishop Brooks has continued this year almost exclusively by Zoom. Bishop Brooks has utilised the technology to actively support the Jabula membership and the Pastors to continue supporting their church members and their local communities. His use of technology has allowed his influence to be felt worldwide.

Similarly technology has allowed our international leader, Bishop Hugh Smith and other leaders worldwide to project services, leadership training and other educational content to the wider Jabula communities.

2. The organisations policy of supporting its member and affiliates in their personal and spiritual development has continued. Bishop Brooks undertakes appraisals and identifies training needs for the member Pastors often providing said training on a one-to-one basis, utilising Zoom and other technologies.

3 Future Planning and Direction.

The proposed plan for the next 3 years, originally to 2023, has been rolled forward to 2025 and is as follows:

- Revisit Constitution, make changes to the functions
- A personal assistant to be assigned to Deputy International Prelate of Rejoice New Life Ministries (Jabula)
- To have at least 30 churches minimum within the UK
- To acquire an independent office which would be utilised as Jabula Headquarters UK within will also be a church.
- Employ a part time Administrator and Book Keeper
- Church Governance - recruit new trustees from Education and Health industry (mental health)
- Develop a Bible School for Rejoice New Life Ministries (Jabula) – to expand the gospel
- Establish empowerment ministries for Men, Boys and young Ladies - bring in specialist teachers and trainers
- Hold a Regional Loud Conference which covers the objectives
- Develop fundraising to meet executive objectives (new building)
- Establish parenting training (help children) and pre-marriage retreats
- The Southern Region to be divided into three areas (based on growth), with three key leaders

This is constantly under review given the current worldwide situation.


Reserves policy
