**Objects:** TO ACQUIRE, MANAGE, CONSERVE AND INTERPRET, FOR THE BENEFIT OF THE PUBLIC, COLLEGE FARM OF FINCHLEY IN LONDON, AND IN PARTICULAR THE ENVIRONMENTAL, HISTORICAL AND ARCHITECTURAL HERITAGE TO PROVIDE RECREATIONAL FACILITIES IN THE INTERESTS OF SOCIAL WELFARE FOR RECREATION AND OTHER LEISURE TIME OCCUPATION, WITH THE OBJECT OF IMPROVING THE CONDITIONS OF LIFE FOR THE PUBLIC, AND PARTICULARLY THOSE WHO HAVE NEED OF SUCH FACILITIES BY REASON OF THEIR YOUTH, AGE, INFIRMITY OR DISABLEMENT, POVERTY OR SOCIAL AND ECONOMIC CIRCUMSTANCES TO ADVANCE THE EDUCATION OF THE PUBLIC, PARTICULARLY YOUNG PEOPLE, IN AGRICULTURE, HORTICULTURE, HOME CRAFTS, COUNTRY LIFE, ENVIRONMENTAL CONSERVATION AND RELATED SUBJECTS, AND IN THE PRINCIPLES OF SELF DISCIPLINE AND GOOD CITIZENSHIP TO PROMOTE TO THE PUBLIC HUMANITY AND MORALITY BY EDUCATING THEM IN THE CARE AND CONSIDERATION OF ANIMALS TO PROVIDE EDUCATION AND TRAINING FOR MEMBERS OF THE PUBLIC WHO HAVE NEED OF SUCH FACILITIES BY REASON OF THEIR YOUTH, OLD AGE, INFIRMITY OR DISABLEMENT, POVERTY OR ECONOMIC CIRCUMSTANCES, SO AS TO PREPARE THEM FOR ANY TRADE, OCCUPATION OR SERVICE, AND THEREBY ADVANCE THEM IN LIFE AND ENABLE THEM TO EARN THEIR OWN LIVELIHOOD TO RELIEVE MEMBERS OF THE PUBLIC WHO ARE DEPRIVED OR PHYSICALLY DISABLED OR HAVE LEARNING DIFFICULTIES OR DISABILITIES, OR OTHER MENTAL OR SENSORY IMPEDIMENTS, BY PROVIDING FACILITIES AS A REMEDIAL, RECREATIONAL OR THERAPEUTIC ACTIVITY TO PROMOTE ANY EXCLUSIVELY CHARITABLE PURPOSE
