Activities: local dog training facilities.Arts and crafts club .Village functions such as Halloween parties and touring theatre companies.Hire of premises for private parties.Authorpe village hall was purchased with financial aid from the national lottery for the sole purpose of the local community to use for social gatherings and functions to help and maintain the hall.
