## TRUSTEES' REPORT (INCLUDING DIRECTORS' REPORT)

FOR THE YEAR ENDED 31 JANUARY 2025

---

The trustees present their annual report and financial statements for the year ended 31 January 2025.

The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the financial statements and comply with the charity's memorandum and articles of association, the Companies Act 2006 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)" (effective 1 January 2019).

### Objectives and activities

The charitable objects are to provide facilities in the interest and social welfare, for the recreation, or other leisure time occupation and for the advancement of religion for the general community but specifically for the residents of Westbury, Wiltshire.

### Public benefit

The trustees have paid due regard to guidance issued by the Charity Commission in deciding what activities the charity should undertake.

### Achievements and performance

#### Significant activities and achievements against objectives

Overall we have had a steady year with both regular bookings and one off bookings remaining similar to 2023-2024.

The general income from casual hirers, has decreased slightly by £203 over the previous year, from £5,372 to £5,169.

The income from regular hirers has increased by £7,311 over the previous year, from £9,133 to £16,524. The total income from casual and regular hirers is decreased slightly by the repayment of refunds to hirers, and movement on debtors costs to £21,097.

The total income included bank interest and donations is £33,096.

I wish to extend a huge thank you to our regular fundraiser, the monthly bingo, which generated an impressive income of £4,477 for hall funds.

Our annual charity bingo, where the monthly bingo is run in aid of a nominated charity, on this occasion raised an amazing £528, for the Royal Osteoporosis Society.

As in previous years, in 2024-2025 we have run a number of successful village events, all of which were very well attended. The Summer Fete, Christmas Fair and Table Top Sales raised £2,403 in total.

We have had some large expenditure costs this year. Insurance at £2,332, and the installation of a new fire alarm system along with other new fire safety features at a total cost of £15,262.

Completing the installation of the fire alarm system along with other upgrades throughout the year now means the hall is fully compliant with all the latest legislation.

We continue to keep the gardening and cleaning costs to a minimum by running both with our willing band of volunteers.

The expenditure total is £33,466

We were fortunate during the year to receive some grants towards the running of the community hall, firstly in March we were awarded £2,839 from Westbury Town Council towards the cost of installing the new complete fire alarm system, also in March £961 was granted by Swindon Borough Council towards the new hedge project in the car park to replace the recently removed overgrown laurel hedge.

During the year a total of £194 was received towards the upkeep of the defibrillator from the Hollies Inn made up of monies from the collection box together with an extremely generous donation from the owners of the Hollies.

### Financial review

#### *Reserves policy*

We lease the hall from the church. The lease requires us to maintain the church building and grounds. We are therefore liable for all repairs and all maintenance. It was therefore agreed that we should hold a larger reserves fund to enable us to deal with any major repair. We look to keep £30,000 as our reserves. This stood us in good stead through the Covid years as we were able to finance our losses then, and have survived to carry on serving the community.

### Structure, governance and management

The charity is a company limited by guarantee. Westbury Leigh Community Project Limited, has directors (all trustees) and a secretary. It is run by a committee. The committee is made up with volunteers from the local community.

The trustees, who are also the directors for the purpose of company law, and who served during the year and up to the date of signature of the financial statements were.
