Achievements and performance

The past year has seen a return to more of our normal activities following the recent pandemic.

In May 2022, as mentioned by the Chair, the Becksde Interpretation Panel was finally installed at a cost of £750, only to be vandalised shortly afterwards.

At the end of May 2022, we received a donation of £150 from Lofthouse Lodge, part of the Guisborough Freeman's Organisation, this was followed in August by the same amount from the Regional Charity Fund. This money was marked to be used towards replacing the damaged stone trough at North Lodge.

Following my year as Chair of Guisborough Town Council and Mayor of Guisborough the Mayors Charity Fund was distributed to my chosen Charities, one of which was Guisborough Town Pride, which received the sum of £362.50.

The popular Challoner Street Markets returned and the Town Pride stall proved to be a useful fund-raising activity.

A couple of years ago we were notified that Guisborough Town Pride was a beneficiary in the will of the late Mr Stan Robins. In November I received paperwork from his solicitors stating that his affairs had been finalised and that we were to receive one third of the estate. This amounted to a staggering £132,895.38, which has been deposited into our Reserve Account and is currently gaining around £100 interest per month.

Our expenditure during the past year has been mainly on plants, however the usual items of Insurance, Clock Servicing and Room Hire are all shown on the Balance Sheet.

We end the year in a very healthy financial situation thanks to Mr Robins and look forward to the new year.


