Financial Performance

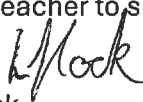
The charity's income for the year was £33,281.90 primarily generated through donations, voluntary contributions and fundraising events.

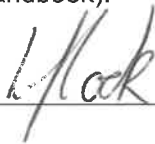
