- This year we have seen nearly £8,000 year on year increase in event income which was offset by an only £2,000 increase in event costs.
- Donations to the school have dropped from £20,000 last year to £2,000 this year.
- This has contributed to a swing from £12,000 loss last year to a £17,000 profit this year.
