Accounts:

The Accounts are prepared on a receipts and payments basis. During the year to 31 December 2022 the income of the Trust amounted to £125,334 (2021: £2,065) of which £4,169 (2021:£2,675) was utilised to progress the objectives of the Trust, leaving a surplus for the year of £121,164 (2021:Loss £610). There was a balance in hand at 31 December 2022 of £126,741 (2021: £5,576).
