


Running costs of the charity are met by an annual grant from St Ender Parish Council.

In this financial year, the Trust had a significant uplift in income, which related to a CiL [Community Infrastructure Levy] grant from Cornwall Council for the purposes of replacing one piece of play equipment and replacing all the safety surfacing for the play area.
