IN ADDITION THE TRUSTEES SHALL ENSURE THAT ALL LAND AND BUILDINGS AND EQUIPMENT OF THE CHARITY ARE KEPT IN GOOD DECORATIVE ORDER CLEAN AND TIDY AND CULTIVATED TO A STANDARD SUITABLE FOR USE BY MEMBERS OF THE PUBLIC AS A PUBLIC OPEN SPACE
