**Activities:** Gives support to people with disabilities and mobility difficulties of all kinds, including sensory impairments; provides disability advocacy and information to group members, people with disabilities, parents with young children, carers and the public in general sponsors or undertakes research offers guidance to local agencies and providers of services and public buildings on disability matters.
