(2) TO ENCOURAGE, FOSTER, ASSIST AND PROMOTE SUCH OF THE ACTIVITIES OF THE PARENT AS ARE CHARITABLE AND THOSE OF ANY SIMILAR ORGANISATIONS ESTABLISHED FOR CHARITABLE PURPOSES AS SHALL BE APPROVED BY THE TRUSTEES FROM TIME TO TIME.

**Activities:** mhs community charity takes the lead on Corporate Social Responsibility for the mhs homes group. The key objectives of the CSR are tackling worklessness, community cohesion and digital inclusion. All projects undertaken or sponsored by the charity fall within this remit.
