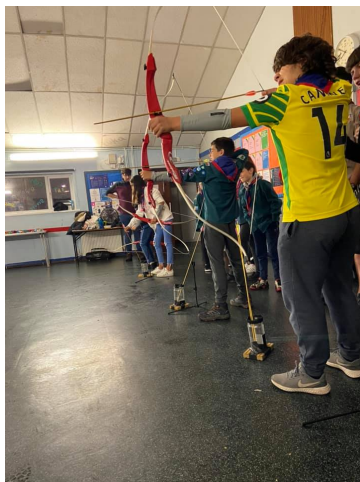

# Scouts Report

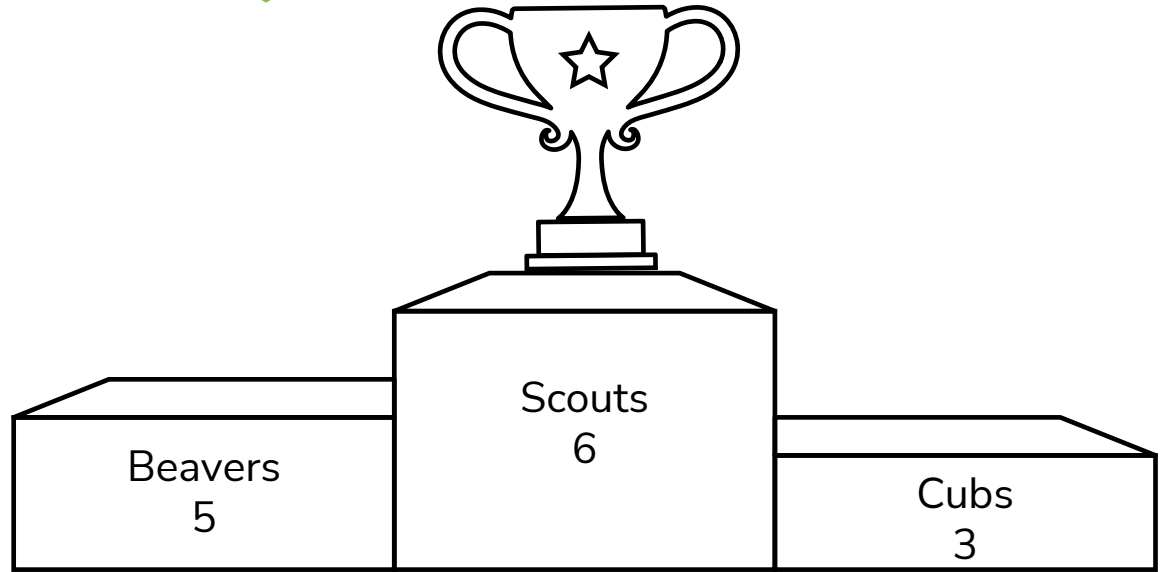

<b>Subscriptions</b> 2021 saw subs streamlined entirely through OSM to the "new" monthly price. A large chunk of subs was also finally released from GoCardless resulting in a nearly £3700 payout, some of which had been held since 2020. The increase in subs income from 2020 to 2021 was therefore substantial.	<b>£11,407.22</b>	<b>£5,325.00</b>	<b>£6,082.22</b>		
<b>Fundraising, grants, gift aid and donations:</b> We gratefully received £10000 in COVID relief grants from Cardiff Council. Admiral Insurance generously donated a grant to buy a new laptop (purchase of which is yet to be agreed by committee for several reasons including, importantly, limited stock availability at the time of grant). We received a hefty GiftAid payout of over £4404, which we for some reason did not in 2020. Other income included Melvin Skidmore, Easyfundraising and AmazonSmile.	<b>£15,482.82</b>	<b>£10,200.00</b>	<b>£5,282.82</b>		
<b>Hall hires (inc. garage):</b> We have continued in our decision not to hire out the hall to external parties, inline with our COVID risk assessment eg. Regarding cleaning etc, and also that availability is now limited since 45th group made their home with us. They are now contributing towards maintenance and utilities (£650 in 2021). Rent of the garage has fallen by the wayside since the pandemic began.	<b>£650.00</b>	<b>£2,749.00</b>	<b>-£2,099.00</b>		
<b>Other income:</b> Although "less" than 2020, this is merely because of a cashbook reshuffle to ensure accurate declaration of our funds, some now being regrouped in the sections above.	<b>£156.62</b>	<b>£1,541.33</b>	<b>-£1,384.71</b>

<b>Programming:</b> For COVID sanitation, and being in a fortunate position financially, we have begun to invest in new and additional materials for programming, both for immediate use and as long term investments. Large parts of 2020 was also conducted via Zoom, therefore requiring very little spend for sessions.	£2,831.82	£2,228.75	£603.07		
<b>Uniform &amp; badges:</b> Just over £200 more was spent on badges in 2021 which simply reflects greater achievements of our members. A large order of new neckers was also required, ready to invest new members to the group.	£1,147.51	£687.41	£460.10		
<b>Utilities, rent and insurance:</b> Our 2020 declaration consisted only of the utilities, which in 2021 were £1969.06. Although significantly higher, the hall was not subjected to the lengthy full lockdown (and mere standing charges) of 2020, and is now also now host to 45th's additional gas/electricity. Some other additional necessities are now being categorised under utilities eg. group web hosting	£3,882.95	£1,424.22	£2,458.73		
<b>Maintenance and repairs:</b> The majority of the year's spend, around £1300, went toward building the outdoor shelter and another £400 replacing the shed. Other significant spends include the cleaner we hired for the hall, to minimise COVID risk. The remainder was for minor repairwork.	£2,022.45	£2,084.20	-£61.75		
<b>Material and Equipment:</b> This is a new category, with most items previously falling under maintenance or programming but includes distinct options such as hall toiletries and office supplies. The last year led to a mass reorganisation and clearout of the hall, for the sake of COVID risk, functionality and compliance. This required new storage solutions and replacement of equipment and tools e.g. first aid kits, stacking boxes. The overall costs of Maintenance and Materials was much larger than 2020, but a necessary investment for now and the future.	£1,660.63		£1,660.63
