ALSO FOR THE BENEFIT OF THE PEOPLE OF THE SAID COUNTY OF SOMERSET AND THE SAID DIOCESE TO PRESERVE, REPAIR, MAINTAIN, IMPROVE, BEAUTIFY AND RECONSTRUCT THE CHURCH AS A BUILDING OF HISTORICAL IMPORTANCE OR ARCHITECTURAL VALUE IN THE EVENT OF THE CHURCH BEING DECLARED REDUNDANT BE A PASTORAL SCHEME MADE UNDER THE PASTORAL MEASURE 1983 (OR ANY STATUTORY MODIFICATION OR RE-ENACTMENT THEREOF) OR OTHERWISE CEASING TO BE USED REGULARLY FOR PUBLIC WORSHIP AND THE MONUMENTS, FIXTURES, STAINED-GLASS, FURNITURE, ORNAMENTS AND CHATTELS IN THE CHURCH AND THE CHURCHYARD BELONGING THERETO.

Activities: FOR THE RESTORATION, PRESERVATION, REPAIR, etc.. OF THE CHURCH OF St. PETER & St. PAUL AND THE MONUMENTS, FITTINGS, FIXTURES etc.. ALSO FOR THE BENEFIT OF THE PEOPLE OF SOMERSET TO PRESERVE, REPAIR etc..
