**Objects:** (A) TO ADVANCE EDUCATION ABOUT CHRISTIANITY IN THE HOLY LAND AND ABOUT OTHER SUBJECTS, (THE "HOLY LAND" FOR THE PURPOSES OF THIS CONSTITUTION IS COMPRISED OF ISRAEL, THE PALESTINIAN AREAS OF THE WEST BANK AND GAZA, JORDAN AND THE NEIGHBOURING COUNTRIES WHICH INCLUDE LEBANON, SYRIA, EGYPT, TURKEY AND IRAQ); AND (B) TO RELIEVE PERSONS WHO ARE IN CONDITIONS OF NEED IN THE HOLY LAND.

**Activities:** SUPPORTING AND PRESENTING SCHOLARLY COMMENTARY, ANALYSIS AND INTERPRETATION OF THE HISTORY AND CONTEMPORARY EXPERIENCE OF THE CHRISTIAN CHURCHES AND CHRISTIAN COMMUNITIES IN THE MIDDLE EAST FOR THEIR USE IN, FOR EXAMPLE, LEADERSHP TRAINING . INFORMING THE CHRISTIAN COMMUNITY IN THE UK ABOUT CONTEMPORARY MIDDLE EAST CHRISTIANITY THROUGH SOCIAL MEDIA, PILGRIMAGE, CONFERENCES AND PUBLICATIONS .
