To treat all animals brought to our centre by owners. To hold clinics at all the animal fairs in the area. To educate the community in the humane and compassionate treatment of animals.

The Receipts and Payments Account is set out on the following pages.


Investments

To state whether any particular matters have come to my attention.


Basis of an Independent Examiner's Report


