Objects: (1) THE LAND IDENTIFIED IN PART 1 OF THE SCHEDULE OF THE ABOVE SCHEME MUST BE USED IN THE PROVISION AND MAINTENANCE OF A RECREATION GROUND IN THE INTERESTS OF SOCIAL WELFARE, TO IMPROVE THE CONDITIONS OF LIFE FOR THE INHABITANTS OF THE AREA OF BENEFIT WITHOUT DISTINCTION OF POLITICAL, RELIGIOUS OR OTHER OPINIONS. (2) THE TRUSTEES MUST LET THE LAND IDENTIFIED IN PART 2 OF THE SCHEDULE OF THE SCHEME AS ALLOTMENTS FOR THE BENEFIT OF PERSONS IN NEED WHO ARE RESIDENT IN THE AREA OF BENEFIT.
