The trustees, who are also directors for the purpose of company law, have pleasure in presenting their report and the financial statements of the charitable company for the year ended 30 June 2022.

The financial statements comply with the Charities Act 2011, the Companies Act 2006, the Memorandum and Articles of Association and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable to the UK and Republic of Ireland (FRS 102).

**Overview from the Trustees**

Another challenging year for Kids Kabin, its staff, participants, funders, and supporters. I am pleased with the superb responses from all of these groups, and we seek to recover from the Covid pandemic and the impact of events locally, nationally and globally.

In particular, I would draw attention to the implications of the lockdowns over recent times and how that has affected children deprived from the benefits of social interaction at schools, clubs and at Kids Kabin events.

Kids Kabin staff provided on-line and other delivered programmes during these lockdowns and are keenly aware that children need to be supported as their lives return to a degree of normality.

I am pleased to see that participation numbers for Kids Kabin activities have now returned to pre-pandemic levels, shown some growth and we are anticipating further growth in years to come.

Looking further ahead, Kids Kabin has ambitions to extend its presence to other locations whether by opening new facilities in its own right or in partnership with like-minded organisations.

I would like to thank all our funders, staff, volunteers, and trustees for their tireless efforts on behalf of Kids Kabin over the past year.

## **Chief Executive's Report**

Thankfully, this last year has seen a return to a sense of 'normality' after the Covid lockdowns and forced adaptations of the last 2 years. As a result, we have delivered a full programme of street, centre based and school activities. We have been able to run workshops in a more relaxed and comfortable way - without face coverings or fear of handling the same tools and materials. This, alongside a pent-up demand, has resulted in high levels of attendance. 1291 different young people took part in workshops through the year, the highest number in Kids Kabin's history. This return to open, public activity has been met with a real sense of relief. An excellent example of this was a very successful Walker Outdoor Week. This year 15 organisations collaborated to engage 300 young people in a week of events in 2 local parks.

However, beneath this activity, we have witnessed the enduring impact and challenges that Covid has created. For a number of people, we have observed an ongoing anxiety and reluctance to re-join activity. We have seen the aftereffects of lockdown and home schooling - in the delayed development of social and practical skills. Demand for volunteering is increasing but is yet to return to pre Covid levels. Fortunately, we have a full complement of international volunteers again - who play such a key role in our delivery.

We are now all seeing the wider economic impact of Covid, inflation, and the Russian invasion of Ukraine. This is putting increased pressure on families and communities and will create ongoing challenges to wellbeing. These background factors are continually reminding us of the importance of the lessons we have learnt through the Covid pandemic – targeting those in highest need, working in partnership to respond to this need and to maximise the use of limited resources. We also continue to prioritise mental well-being for young people and families as well as for our staff teams.

Inevitably, this wider economic impact is creating financial challenges, with increasing costs and reduced funding available. This has triggered us to increase our fundraising capacity, diversify our income sources and to think creatively and differently about how to create additional capacity. Notably, we are looking outside the organisation for advice and support, and are working with a fundraising consultant to develop our internal skills and capacity. We also welcome the support of a team of volunteers from Pilotlight, who will provide input and advice over the year ahead.

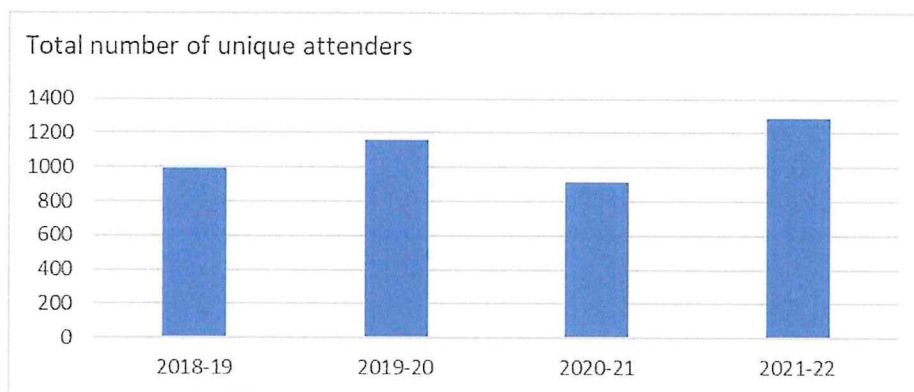
This report describes a year of recovery and development. It is structured around our 4 development themes – People, Places, Partnerships and Processes. It then highlights our future plans, based on our new 2022-2025 organisational plan.



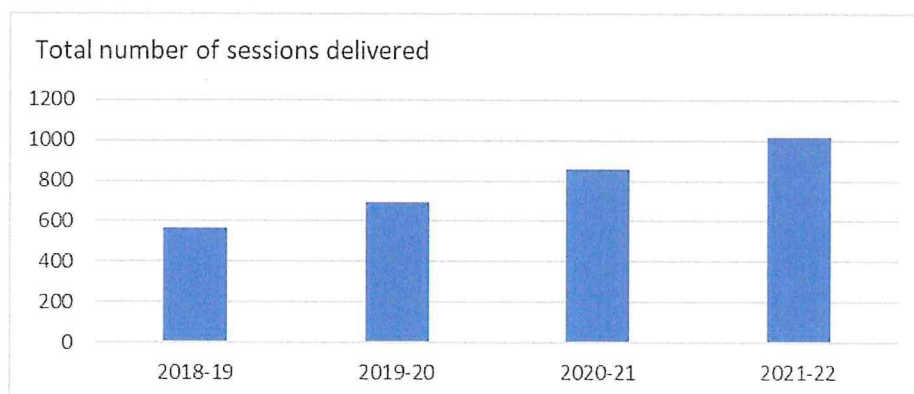
## Delivery Data

The graphs below show the 4-year trends in numbers of attenders, numbers of sessions delivered and numbers of attendances. Key trends are as follows:

- The number of unique attenders continues to increase, now at 1291 for 2021-2022. Noting the drop in 2020-2021 as a result of Covid, there is a steady increase over time. Of these 1291 individuals, 1003 attended Newcastle workshops and 288 participated in Middlesbrough.



- The number of sessions delivered shows a consistent increase between 2018 (564 sessions) and 2022 (1014 sessions). This reflects the development of delivery in Middlesbrough, as well as an increase in the number of sessions delivered in partnership in Newcastle and Middlesbrough. Covid lockdowns had less impact on this, as we adapted to online and outdoor delivery.

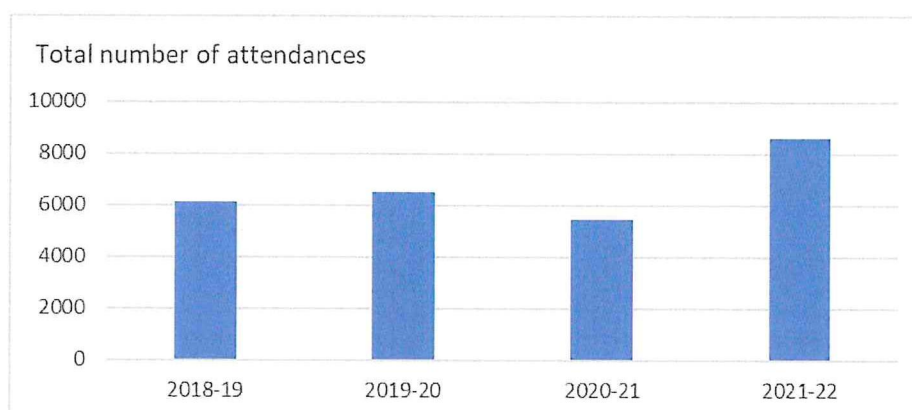


- The number of attendances shows a consistent increase over time, with a Covid dip in 2020-2021.
- Attendances have increased by over 40% between 2018-2019 and 2021-2022, from just over 6100 to more than 8500.
- This equates to an average of more than 7 sessions per child during 2021-2022

The Kids Kabin team has worked hard to return to, and exceed, pre Covid participation levels. These trends also reflect the development of Kids Kabin Middlesbrough and a number of new partnership initiatives. A return to a greater number of volunteers has also increased capacity. The team will continue to look at creative and collaborative ways to engage and benefit more young people.

## **People**

### **2019-2022 objectives**

- > Continue to involve parents and the community in supporting and delivering our street workshops.
- > Empower young people to progress and take on new roles and responsibilities.
- > Build the role of the international volunteer team, developing their leadership training and their support for Kids Kabin Middlesbrough.

### **What has happened this year?**

- Children and young people continue to take the lead – starting with their first creative engagement at street sessions or school visits then progressing on to regular attendance at centre-based workshops. Young people have shared their skills, helping their peers and using their skills out in the community – from fixing bikes to helping at community events.
- Our full-time volunteer team is now back up to full strength. From September 2022 we have 7 full time volunteers, 5 living in Newcastle and 2 in Middlesbrough. These volunteers play a central role in activity delivery, each leading at least one of our weekly sessions and playing important roles in project design and organisational development.
- The number of community volunteers has growing again. Young volunteers continue to support many of our workshops – Mariana's experience is shown in the case study below. We're also seeing young volunteers progressing from Kids Kabin onwards into new challenges. Lucky Amer, a Cowgate young volunteer, is now volunteering with the Police Cadets. He recently wrote to us to tell us what Kids Kabin has meant to him: *"Thank you and all the staff at Kids Kabin for the many great years I've had there, it's been a pleasure. I've progressed so much, from being shy, and wanting to be left to do my own thing, to working with others and volunteering with the younger ones. Thank you so much for the experience. Also, I would love to be a volunteer at future events, I have always looked forward to them."*



- Following successful fundraising with the Walker Workers, we have appointed 2 apprentice youth workers for Walker, one based at Kids Kabin and one at the Bostey. The apprenticeships run for one year from June 2022. From November 2022, the apprentices will start placements with partner organisations to develop their skills and experience and increase local youth work capacity.
- Parents and residents continue to support our street and community workshops, sharing information and publicising our sessions locally.

**Case study – Young Volunteer, Mariana Noor**

Mariana has been a young volunteer for 1 year. Here, she tells us more.

**Can you tell us about your Kids Kabin experience?**

I used to come to Kids Kabin when I was younger, from when I was about 8 to about 13. I really enjoyed it, making things and having fun with my friends. I stopped coming when I was 13. Then I started thinking that it would be good to get involved and help out. I'd wanted to ask about volunteering for a bit but hadn't managed to. Then one day I saw Will putting the bin out and asked him about it. I've been volunteering since then, for about 1 year.

**Why do you volunteer and what do you get out of it?**

I'm interested in working with children and young people when I leave college. I'm on a T-level Education and Childcare course. I'm starting a placement at West Walker Primary school soon and I want to be a primary teacher. Volunteering at Kids Kabin has helped me decide what I want to do in the future. It's been good to get experience and it's really helped me feel confident at college, talking about all the topics. I've also been able to learn how to work with different children and understand their different needs. I'm also now a lot more confident with woodwork and cooking with kids.

**What advice would you give other young people interested in volunteering?**

Don't be shy, go ahead and do it. It's good fun and really rewarding. It can sometimes be difficult. A big thing for me has been learning how to be professional as a young volunteer. It's different from being a kid. You have to think differently – because you're being responsible for other people – previously you just had to think about yourself.



## **Places**

### **2019-2022 objectives**

- > Continue to commit to our Newcastle communities.
- > Build Kids Kabin Middlesbrough.
- > Explore new opportunities in a third city.

### **What has happened this year?**

- Regular workshops have been delivered in the 5 Newcastle locations – in the main centre in Walker, in Cowgate, Pottery Bank, Daisy Hill and Byker. The Byker bike repair collaboration with Recyke Y Bike and Newcastle YMCA has enabled us to broaden our geographical impact. We now deliver weekly street bike workshops between March and the end of October, moving between 5 locations across the Byker ward. The summer streetwork programme has returned to full capacity in Newcastle, with 85 street workshops taking place, engaging more than 500 different young people.
- Regular weekly workshops now run in 5 neighbourhoods across Middlesbrough. In addition to the Laurel Avenue, Easterside and Thorntree/Brambles Farm, the Middlesbrough team have expanded their delivery into Breckon Hill and Salter's Gill. Weekly workshops have run throughout the year in community venues in these locations. Over the summer 98 street workshops took place across Middlesbrough.
- The collaboration with Hartlepool Borough Council continues. This summer saw workshops co-delivered in Rossmere park in Hartlepool, showcasing street and outreach delivery and promoting this approach to local partners. In addition, the Kids Kabin Middlesbrough team ran a training workshop for Hartlepool youth and community workers.
- Summer camping trips took place in Rupert's Wood, Birkheads Wild and in the Tyne Valley. Rupert's Wood suffered particularly severe damage from Storm Arwen in November 2021. Children and the staff team helped relocate the camp site and will continue to work with Rupert Redesdale and Newcastle University students to support the wood's recovery.
- The Newcastle kitchen project is still underway. Covid, illness and challenges in the building trade has further postponed completion. This project has faced an unexpected number of challenges, with hopes for completion by the end of November 2022.

### **Case study - Middlesbrough Satellite No. 5 – Saltersgill**

Middlesbrough Manager Sue McBride explains start up and development of this new location:

"In January of 2022 Kids Kabin was invited to a meeting with local partners in Saltersgill - the Anti Social Behaviour Officer and the Manager of the Sutton Centre - to discuss the needs of the area. They had heard about Kids Kabin and wanted to discuss ways in which we could create and support activities for the children in the area. We talked to local families to gauge interest. Parents and children told us that there was nothing to do, and they were bored after school.

The centre offers a large space, kitchen and outdoor area - perfect for delivering a wide range of activities. Our sessions were immediately popular, with our first workshop in February 2022 attracting 16 children. The children's feedback was immediate. Sophia told us *'This is the best fun and I like making pizza. I want to come every week!'*

Children have enjoyed taking part in craft, pottery, woodwork, cooking and gardening. They have also made firepits and BBQ's during the summer. Manager Carole tells us *'This partnership has proved beneficial to the centre and the local community. We are trying to provide activities for all ages and the 7-13 year age group was missing. It's lovely to see so many happy faces every Tuesday evening. We couldn't ask for better people to work in partnership with, kids are thriving and so much happier now!'*

We are lucky to have two young volunteers from Grove Hill who have offered to come along and help out at Saltersgill. Quinn and Gracie have supported the young children and are great at tidying up! Quinn tells us *'I've been coming to Kids Kabin since they first came to our street, at the Ant sculpture on Woodville Avenue. I've done loads of activities now. The best was learning to sew, and I could fix my teddy myself. It's nice to see that my younger sister and brother can now come in as they were too little before. I like to help them and all the kids'*



## **Partnerships**

### **2019-2022 objectives**

- > Share practice and innovation with other organisations, learning from them and helping them develop – for example, helping them become mobile and meet more people on the streets.
- > Work with both the voluntary and community sector and businesses and find mutual benefits in these partnerships.

### **What has happened this year?**

- Kids Kabin works with community partnerships in Byker, Walker and Cowgate in Newcastle and with Middlesbrough Youth Mutual. These partnerships continue to take forward the momentum gained during their collaborative community support work during Covid. The Walker Workers have successfully fundraised together to run a Walker youthwork apprenticeship programme. Both Walker and Byker partnerships co-delivered summer programmes. For example, the Walker Workers ran the annual WOW week. This year 15 partner organisations worked together to run 5 days of workshops in 2 parks in Walker engaging 300 different children and young people.
- Kids Kabin Middlesbrough have been working in partnership with Middlesbrough Youth Mutual which brings together agencies working with young people. As well as promoting more joined up working, they have a strong focus on involving young people in decision making about future provision.
- The collaboration between Beamish, Kids Kabin and Northumbria University has run through the year. This started with the Dovetails project, explained in more detail in the case study below. The Beamish Men's group then offered to make a garden bench for the Seahouses Hostel, for the benefit of Kids Kabin and may other groups that visit. In return, Kids Kabin have made a teapot and biscuit plate for the Beamish Men's group. Skills sharing and learning partnerships also continue with Recyke Y Bike and Hartlepool Borough Council.
- During 2022 we've developed a collaboration with N21, a business based in Byker, Newcastle. Kids Kabin has run pottery, wood carving and pizza making workshops with new staff joining N21. In return, N21 have refitted and upgraded our street kitchen and are helping redesign our website.

Partnership work with the NEAT Schools Trust has developed. NEAT schools include 4 local primaries in Walker, and Benfield secondary school. This year, there has been closer planning and consideration of links to key skills in the curriculum. Kids Kabin has also hosted a teacher training session for Central Walker Primary School staff to introduce some of the skills and tools that the children will be using throughout the year ahead. Feedback on this new approach to planning has been very positive. A teacher from Tyneview Primary School told us: "The sessions were great, the kids got loads out of it and they hit the needs of the curriculum. Thank you. The children especially loved the shuduf session and talked lots about it at school. All the staff were great and very knowledgeable, and I loved how they were giving facts about the skills and ancient Egypt."

### **Case study - From Cowgate to Beamish and back again – Creativity and communication**

Most of us know Beamish as the living museum of the North East - for the trams, the sweet shop, or the old Victorian school house. Perhaps something we know less about is their great work supporting and empowering people in their local community.

Michelle Kindleysides leads the Health and Well-being team at Beamish. Michelle runs a range of programmes with local people, including Beamish's Men's Group - set up in 2014 to help support local men's mental health, including those living with dementia, through community and creativity. Thanks to Michelle, and Henry Collingham from Design School at University of Northumbria, Kids Kabin has been able to collaborate on a new creative project in partnership with Beamish, called Dovetails. Henry explains: "*The aim of the project has been to explore what Kids Kabin and Beamish's Men's Group have in common through their creative practice, and to make some beautiful projects for one another!*" 8

Between September and November 2021, children from Kids Kabin, Cowgate, Newcastle upon Tyne, and members of the Beamish Men's Group have planned, designed and made a number of hand-crafted wooden products for the benefit of the other group. Based on principles of learning, sharing, and linking communities, each group made short videos of their ideas, prototypes and progress and shared these throughout the project. This process inspired new ideas and product improvements and built a virtual 'making' relationship between Beamish and Kids Kabin.

The project culminated in the grand unveiling of the creations at Orchard Cottage at Beamish on Saturday 4th December, 2021. The Kids Kabin kids presented the Beamish group with a hand carved garden bench and a tool store for their work shed. In return the Men's Group presented a modular 'FlexiGames' set for building indoor and outdoor games, and a bespoke toolbox measured to fit on the Cowgate mobile woodwork bench, both projects are complete with beautiful hand carved and stippled handles!

The project has been hugely rewarding for members of both groups. Michelle Kindleysides describes the impact for the men she supports: *"I think I can safely say that everyone in the Men's Group has thoroughly enjoyed working on this project. It was great to be set a 'challenge' and to work together to problem solve. The groups were really inspired by being able to make something that would be used by Kids Kabin, and then being able to actually meet the children and show them what they'd made at the end was the icing on the cake! It's been a massive boost for the men's self-confidence and a great way to get to know each other."*

Following the success of this project, Kids Kabin and Beamish group plan to keep in touch and work together in the future.



## **Processes**

### **2019-2022 objectives**

- > Innovate and develop new street workshops and exciting new activities for children and young people.
- > Develop the use of data, technology and systems within the organisation to learn more about the impact of our work and how to make the most of what we are doing.

### **What has happened this year?**

- Kids Kabin trustees and staff teams have worked together to create a 2022-2025 organisational plan. This involved a consultation with children, parents, and stakeholders to review our vision, values and mission. The aims and objectives of the plan are included in the following section – plans for future periods. The key results of the consultations are also included below. Consultations will take place annually throughout the life of this organisational plan.
- Enabled by a development grant from the Tudor Trust, Kids Kabin is working with a fundraising consultant. The aim of this work is to increase the organisations fundraising capacity by upskilling team members. A second aim is to diversify income sources and trial new income generation methods.
- Kids Kabin was a winner of the Garfield Weston awards at the beginning of 2022. We are working with the Pilotlight team to review and develop our capacity, skills and resilience.
- Kids Kabin members have taken part in surveys every 6 months, in December 2021 and June 2022. These surveys have enabled individuals to self-assess their skills and confidence. Improvements in skills and confidence have been seen in all activities and locations. We are now exploring variation in rates of change and evaluating what we can learn from this.

### **Case study – Asking people what they want to see**

In April and May 2022, we spoke to children, parents, and other stakeholders as we developed our 2022-2025 organisational plan. This process is guiding our organisational strategy we will repeat these conversations each year to make sure we are listening to community priorities.

In April 2022, we spoke to 55 children in Newcastle, asking them about their vision for a 'perfect neighbourhood'. They created a graffiti board and their feedback focused on:

- Improving the environment – growing trees and flowers, keeping their community tidy
- Being kind to people – supporting charities and challenging bullying and negative behaviour
- Positive activities – sport, exercise and play, cooking, making things and being practical

In May 2022, we spoke with 15 parents across our 5 locations. We asked them what is needed for children in their community and what happens if these needs are not met. They told us:

- Children want to be active and need safe, accessible activities close to their homes. Parents suggested more parks and areas to play, more youth groups and more organised activity.
- When children don't have safe places and positive activities, they can get into trouble and put themselves and others at risk. One parent explained, 'If kids can't fix their own bike, they'll pinch one from someone else.'

In April 2022, we spoke to 10 local stakeholder organisations. We asked for their feedback on our current and future work and where it could improve. Their suggestions included the following:

- Getting kids active and positive,
- Making their learning relevant and linking it to their communities,
- Responding to real community problems and challenges

**Plans for future periods - Kids Kabin organisational plan 2022-2025**

**Overall Goal – 2022-2025** - To increase our impact by 2025 by enabling 2500 young people a year to experience creative and personal development opportunities – increasing from 1,300 young people participating in 2021-2022.

**Our aims – 2022-2025**

- To develop new partnerships and ways of working, providing opportunities to share practice, co-deliver and increase impact
- To increase the quality of youth and adult volunteering and the further development of apprenticeships and training
- To empower communities to co-create projects and workshops
- To continue to explore different ways of increasing impact – including delivery in partnership, sharing our methodologies and working in new areas
- To increase our organisational resources, capacity and capability

**Our development priorities – 2022-2025**

**People**

- To embed and develop our apprenticeship scheme in collaboration with the Walker Workers, recruiting 2 Walker apprentices in June 2022, June 2023 and June 2024.
- To create, fundraise for, and develop a Newcastle Operations Manager role.
- To increase our volunteer capacity and improve progression pathways and support systems for both youth and adult volunteers.
- To introduce student placements in collaboration with local Universities, starting in September 2022.

**Places**

- To develop new activity programmes in the Newcastle kitchen and café space, between December 2022 and June 2025.
- To recruit a consistent group of full time, international volunteers in Middlesbrough, starting with the opening of a volunteer house in September 2022.
- To collaborate with organisations in Hartlepool to support and develop their street workshop delivery and methodology – initially in summer 2022 and summer 2023.

**Partnerships**

- To develop research projects with local Universities and promote stronger relationships between universities and partner organisations in the communities in which we work.
- To continue consistent engagement with community partnerships in Walker, Byker and Middlesbrough and revive a community partnership in Cowgate.
- To develop 3 new business partnerships each year, between July 2022 and June 2025.

**Processes**

- To review and update our educational model and theory of change each year - 2023, 2024, 2025.
- To continue to improve our impact measurement framework, based on outcomes and personal development for individual young people.
- To establish a process enabling young people and parents to discuss the present operations and future developments of Kids Kabin.
- To diversify new income sources and increase annual, non-grant income to 10% by June 2023 and 20% by June 2025.

## FINANCIAL REVIEW

The finances of the charity remain in a stable position. During the financial year the charity obtained funding of £309,347 (2021 - £205,030) with an overall surplus of £70,487 (2021 deficit - £9,295). Reserves at 30 June 2022 were £566,796 (2021 - £496,309) of which £324,136 (2021 - £290,728) related to restricted funds. Unrestricted reserves stand at £117,875 (2021 - £105,172).

We keep a close eye on the financial sustainability of Kids Kabin. As the charity and its expenditure grows, we are aware of the increasing requirement to raise funds, to diversify our sources of income and to remain lean and cost effective.

### Reserves policy

The board have decided that unrestricted reserves should be kept at a level equal to approximately 6 months of annual operating costs and that these reserves should be in a readily realisable form. The policy on reserves considers the risks associated with Kids Kabin's various income streams, as well as variations in expenditure and other unforeseen circumstances. The reserves policy is considered by the Board on a regular basis.

The reserves policy is reviewed by the board for appropriateness on an annual basis with unrestricted free reserves being £117,875 (2021 - £105,172).



**1. Accounting Policies**

**1.1 Basis of preparation**

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued in October 2019, the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102), the Charities Act 2011, the Companies Act 2006 and UK Generally Accepted Accounting Practice.

Kids Kabin meets the definition of a public benefit entity under FRS 102. The financial statements are prepared under the historical cost convention or transaction value unless otherwise stated in the relevant accounting policy note(s). The financial statements are prepared in Sterling which is the functional currency of the charity and rounded to the nearest £.

The significant accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all years presented unless otherwise stated.

**1.2 Going concern**

The financial statements have been prepared on a going concern basis as the Directors believe that no material uncertainties exist. The Directors have considered the level of funds held and the expected level of income and expenditure for 12 months from authorising these financial statements. The budgeted income and expenditure is sufficient with the level of reserves for the charity to be able to continue as a going concern.

**1.3 Funds**

Unrestricted funds are available for use at the discretion of the Trustees in furtherance of the general objectives of the charitable company and which have not been designated for other purposes.

Designated funds comprise unrestricted funds that have been set aside by the Trustees for particular purposes. The aim and use of each designated fund is set out in the notes to the financial statements.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors which have been raised by the company for particular purposes. The cost of raising and administering such funds are charged against the specific fund. The aim and use of each restricted fund is set out in the notes to the financial statements.



**1.4 Incoming resources**

All incoming resources are included in the Statement of Financial Activities (SoFA) when the charity has entitlement to the funds, any performance conditions have been met, the amount can be measured reliably and it is probable that the income will be received.

Income from charitable activities includes income received under contract or where entitlement to grant funding is subject to specific performance conditions and is recognised as earned. Grant income included in this category provides funding to support performance activities and is recognised where there is entitlement, certainty of receipt and the amount can be measured with reasonable certainty. Income received to deliver services over a specific period covering more than one financial year is accounted for over the specific period; related expenditure is accounted when incurred.

Investment income relates to interest earned through holding assets on deposit.

Other trading income includes rental income received for the use of rooms at Kids Kabin.

In accordance with the Charities SORP (FRS 102), the general volunteer time is not recognised and refer to the directors report for more information about their contribution.

**1.5 Expenditure and irrecoverable VAT**

All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category. Expenditure is recognised where there is a legal or constructive obligation to make payments to third parties, it is probable that the settlement will be required and the amount of the obligation can be measured reliably.

Irrecoverable VAT is charged as an expense against the cost for which the expenditure arose.

**1.6 Support cost allocation**

Support costs are those that assist the work of the charity but do not directly represent charitable activities and include office costs, governance costs and administrative payroll costs. They are incurred directly in support of expenditure on the objects of the charity.

**1.7 Tangible fixed assets**

Tangible fixed assets are stated at cost (or deemed cost) or valuation less accumulated depreciation and accumulated impairment losses. Cost includes costs directly attributable to making the asset capable of operating as intended.

Depreciation is provided on all tangible fixed assets, at rates calculated to write off the cost, less estimated residual value, of each asset on a systematic basis over its expected useful life as follows:

Freehold Property	-	2.5% straight line
Equipment	-	25% straight line
Fixtures and Fittings	-	20% straight line

All assets costing more than £500 are capitalised.

**1.8 Debtors**

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

**1.9 Cash at bank and in hand**

Cash at bank and cash in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

**1.10 Creditors and provisions**

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement after allowing for any trade discounts due.

**1.11 Financial instruments**

The charity only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value.

**1.12 Pensions**

The charitable company contributes to a defined contribution pension scheme for the benefit of its employees. The assets of the scheme are held separately from those of the charitable company. The annual contributions payable are charged to the Statement of Financial Activities.

**1.13 Tax**

The charity is an exempt charity within the meaning of schedule 3 of the Charities Act 2011 and is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes.

The future costs designated fund are funds set aside by the trustees for future capital expenditure on the kitchen project. It is expected the future costs designated fund will be spent in 2022-23 and capitalised expenditure will transfer into the capital fund.

Newcastle – Kitchen Project – relates to the development of the kitchen within the premises at Church Walk. The kitchen project had an overall brought forward reserves balance of £103,639. During the year no further income was recognised and £24,653 transfer between restricted funds and designated funds occurred as a result of the capitalisation of assets. In the financial year 22/23 further expenditure of £49,960 will be incurred bringing total expenditure on the project to £103,639.

**Capital fund – property**

The capital fund is equal to the net book value of the property held within the charity. Restricted funds had originally been obtained in order to purchase these assets.
